A. CHANGES TO BEST MANAGEMENT PRACTICES

No changes occurred during 2019 – 2020 reporting cycle.

B. STATUS OF COMPLIANCE WITH PERMIT CONDITIONS

1. Public Education and Outreach

BMP A.1: Distributed Paper Material (Newsletter)

The Village newsletter, *Elk Grove Villager*, contains periodic stormwater related articles throughout the given year to assist in Public Education. The Village used the newsletter this cycle to communicate various stormwater-related information to residents and business owners. See attached sample newsletters from, May, June, September 2019. *Newsletters allow for “fair” access and are available to all in the community.*

BMP A.3: Public Service Announcement (Cable TV)

Two (2) separate Public Service Announcements were transmitted on the cable TV municipal access channel this reporting period and involved Public Works Staff (see attached screen shots). *Cable TV is a “fair access” means for communicating with the public important stormwater-related matters.*

BMP A.6: Other Public Education (Village Website)

An updated Storm Water specific section was added to the Village website during the Year 12 cycle and continues to be monitored and updated. This section of the website contains: information about motor oil’s environmental impact and proper disposal methods, information regarding the storage and disposal of common household items that are harmful to our waterways and past NPDES Permits (see attached samples). *The website is a “fair access” means for communicating with residents and businesses. If there is suitable information regarding the ever-changing climate and its effect on pollution prevention for waterways, it will get posted in the future.*

2. Public Participation/Involvement

BMP B.4: Public Hearing (Meeting)

Last public meeting hosted during the March 26, 2019 Village board Meeting. Village Trustees, Staff and attendees were educated and updated on the IEPA's National Pollutant Discharge Elimination Program (please see attached meeting agenda and presentation outline). March 2020 Meeting did not occur due to COVID 19 Pandemic.

BMP B.7: Other Public Involvement (Cleanup Event; Tree Planting)

A local volunteer group, Friends of Critters, Salt Creek Watershed Network, hosted "Salt Creek Clean Up" day on June 8, 2019 (see attached Facebook post and engagement statistics). A fall cleanup corresponding to leaf pickup was also emphasized in the fall of 2019 (see the attached October and November 2019 newsletter sample). The Village planted 624 trees during the past cycle.

3. Illicit Discharge Detection & Elimination

BMP C.1: Storm Sewer Map Preparation

The Storm Sewer System is mapped and edits and revisions are made as needed when incorrect information is found (see attached copy dated 5/29/2020).

BMP C.2: Regulatory Control Program (Ordinance)

The Ordinance was reviewed and no revisions were deemed necessary.

BMP C.3: Detection/Elimination Prioritization Plan

BMP C.4: Illicit Discharge Tracing Procedures

BMP C.5: Illicit Source Removal Procedures

The joint approach by the Metropolitan Water Reclamation District of Greater Chicago (MWRD) and all departments of the Village has resulted in a comprehensive approach to detecting and eliminating illicit discharges. The Village responds with appropriate resources including a Hazardous Materials Team, trained Public Works personnel, Health Inspectors, and Community Development Inspectors depending on the situation. Some requests for assistance are generated from MWRD, and MWRD is notified and assistance requested as appropriate. The outfalls are checked minimally on a quarterly basis for debris and illicit discharges. Prior to forecasted major rain or snow melt events, the outfalls are checked for debris and illicit discharges as well in supplement to the quarterly checks.

BMP C.7: Visual Dry Weather Screening (Outfall Inspections)

The Village's GIS map containing Village outfall locations is continuing to be updated and evaluated. Outfall locations will be monitored during periods of dry weather and results/pictures of the area will be catalogued in the Village GIS system.

BMP C.10: Other Illicit Discharge Controls (“Drains to Waterways”)

All frames and grates purchased by the Village are cast with “Drains to Waterways” text. Replacement of existing frames and grates continues as required, typically during the Street Maintenance program and as part of storm sewer repairs based on complaints.

BMP C.10: Other Illicit Discharge Controls (Visual Monitoring Inspections)

During the 2016 - 2017 reporting cycle, the Village established a new water monitoring program. During the Fall of 2017 the Village will begin collected water samples, during a period of dry weather from Salt Creek, where the creek enters the Village limits at Arlington Heights Rd and exits the Village limits at Devon Ave. Water samples are tested for Total Nitrogen calculated Gas Diffusion, Total Oil & Grease SPE, Total Suspended Solids, Phosphate Total as P by Lachat, Fecal Coliform by Membrane Filter for Wastewater, and Chloride by IC. Records are stored in the Village’s NPDES files (Fall 2019 Testing Report Attached).

4. Construction Site Runoff Control

BMP D.1: Regulatory Control Program (Ordinance)

The MWRD Watershed Management Ordinance effective May 1, 2014, last amended May 7, 2020, along with Village Ordinance 8-12-9: Soil Erosion and Sedimentation Control, is used to enforce soil erosion and sediment control requirements for developments and construction sites.

BMP D.2: Erosion and Sediment Control BMPs

Construction Permits require that an appropriate soil erosion and sediment control plan, including a SWPPP be developed. These requirements are enforced during the site plan review process.

BMP D.4: Site Plan Review Procedures

Site plans are reviewed for SWPPP and soil erosion and sediment control during the plan review process.

BMP D.6: Site Inspection/Enforcement Procedures

All sites inspected as required for compliance.

5. Post-Construction Runoff Control

BMP E.2: Regulatory Control Program

Post construction BMPs are installed, regulated and inspected per the MWRD Watershed Management Ordinance.

BMP E.3: Long Term O&M Procedures

All known BMPs were inspected as needed. Inspection of erosion control measures were completed, no maintenance was required during the reporting period. MWRD Ordinance requires all property owners performing a development to have a Long Term O&M Procedural Plan.

BMP E.4: Pre-Construction Review of BMP Designs

Plans were reviewed and suggestions were made for inclusion of BMP designs where appropriate and when required by the MWRD Watershed Management Ordinance.

BMP E.5: Site Inspections During Construction

Inspected BMPs during construction to ensure compliance with approved plans along with required weekly inspecting and inspections after ½ inch of rain fall.

6. Pollution Prevention/Good Housekeeping**BMP F.1: Employee Training Program**

Two employees completed the Certified Stormwater Inspector Training from the National Storm water Center (certificates attached). Two employees completed the Managing Snow and Ice Control Operations Training from the University of Wisconsin-Madison (certificates attached). Appropriate Police, Fire, and Public Works personnel have received at a minimum Hazardous Materials Awareness training performed by certified trainers from the Fire Department in past cycles.

BMP F.2: Inspection and Maintenance Program

Over 164 catch basins, inlets, and storm sewer mains were cleaned, repaired or rebuilt. Over 3,500 linear feet of various sized storm sewer pipe were cleaned of debris. The debris was removed primarily by vacuum truck and disposed of as non-toxic debris.

Street sweeping of all Village streets was accomplished three times for the business park and four times for the residential area during the reporting period. Over 2,500 miles of street gutters/curbs were swept during the reporting period. Debris generated from those activities was disposed of as non-toxic debris.

BMP F.3: Municipal Operation Storm Water Control

Debris was removed from storm grates as conditions dictated. Deicing materials are stored in a permanent structure. All fertilizers, pesticides, or other chemicals are stored indoors.

BMP F.4: Municipal Operations Waste Disposal

During the reporting period; all non-toxic debris generated by municipal operations such as storm sewer cleaning, and similar activities was removed and disposed of by a contractual service. The Village Fleet Services stored lubricants in a waste oil tank and they were picked up by a licensed waste hauler. Coolant waste is stored in barrels and picked up by a licensed recycler. Street sweeping debris was disposed of by the Village's Solid Waste Hauler.

BMP F.5: Flood Management/Assessment Guidelines

The Village is part of the National Flood Insurance Program (NFIP) and focuses Village resources on the reduction of flooding throughout the Village. The Village continues to make a concentrated effort to keep all drains and waterways open throughout the duration of heavy rainfalls. During the 2019 reporting period the Village continued to remove and reconstruct culverts underneath roadways as needed.

BMP F.6: Other Municipal Operations Controls

During the reporting period, municipal vehicles were routinely washed at wash stations, the triple basins were cleaned as required.

The MWRDGC is a special district recognized under the laws of the State of Illinois with authority to enforce Ordinances. The District enforces Appendix A – Discharges To Waterways of their sewage and waste control ordinance and the Watershed Management Ordinance.

F. CONSTRUCTION PROJECTS PAID BY THE VILLAGE OF ELK GROVE VILLAGE

Over the last year the Public Works Department oversaw the design engineering and construction of the Louis Avenue Culvert Improvement project, ditch maintenance program, Nerge and Rohwing Lift Rehabilitations, Residential Lift Rehabilitation, Tanglewood Drive Water Main Replacement, Clearmont Drive Water Main Replacement, Pump House 2 and 6 Rehabilitation, 3.40 miles of Village road resurfacing, and the Oakton & Lively Traffic Signal Relocation.

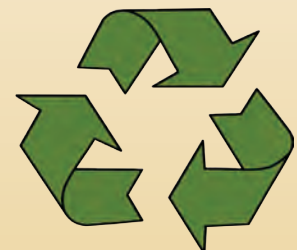

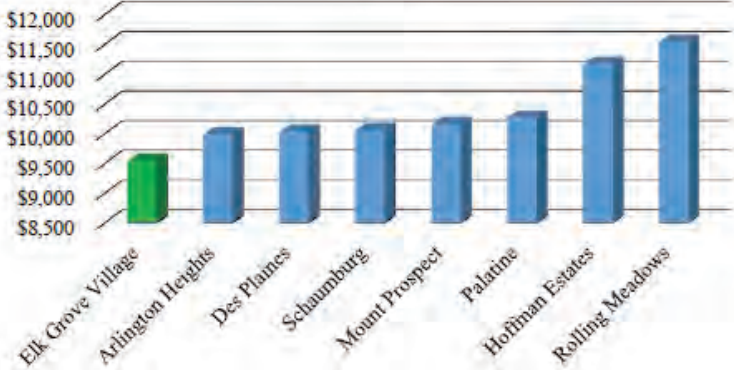




ELK GROVE REMAINS THE MOST AFFORDABLE COMMUNITY FOR RESIDENTS

A 2019 survey of seven comparable communities shows that Elk Grove Village continues to provide the lowest cost of living for residents. Elk Grove Village routinely compares itself to neighboring municipalities and we are proud of our reputation of offering high quality services at affordable prices. Not only has Elk Grove Village maintained our place as the most affordable community since we began this survey over ten years ago, this also marks the 21st year that our residents have had the lowest combined property tax rate in the area.

2019 Cost of Living Analysis - Annual Municipal Impact



The annual cost-of-living survey is intended to account for the entire range of municipal taxes and fees that impact residents-this includes property tax, sales tax, natural gas tax, cable franchise fees, waste/recycling services, water/sewer rates, and various other costs. The graph shows that Elk Grove Village has the lowest annual municipal impact for these taxes and fees, coming in at under \$9,600 per year.

The Village is able to maintain this low cost of living in large part to our robust business community. We work hard to cultivate relationships and provide value to our business community to help keep costs low for residents.

As it flows, it picks up dirt, leaves and grass clippings, pesticides and fertilizers, oil, litter and other harmful contaminants. All of these pollutants are carried by storm water into storm drains and ultimately into our creeks and rivers which ends up in Lake Michigan. However, there are simpler ways that residents and businesses can all help in reducing the amount of these pollutants that enter our creeks and rivers:



- Do not dump used motor oil, antifreeze, or other hazardous materials on the ground or into sewers. Recycling programs are available for these hazardous materials.
- When cleaning your driveway, dock, or parking lot use a broom instead of water and dispose of debris in the trash; not the street or storm sewer.
- Do not dump branches, leaves or grass clippings along creek beds, in open ditches or in the street.
- Minimize the use of herbicides, pesticides and fertilizers on your lawn, and plant native plants whenever feasible.
- Please pickup litter and place in trash cans. This will prevent it from getting washed into the storm sewers and eventually into our waterways.
- Cover piles of dirt and wood mulch while doing landscaping projects, and sweep up debris; do not wash it into the street.

WATER SUPPLY SYSTEM CONSUMER CONFIDENCE REPORT



Each year public service water suppliers issue a report known as the Consumer Confidence Report (CCR). The CCR contains information regarding the public service water supplier's water sources (i.e. rivers, lakes, reservoirs, or aquifers) any detected contaminants, compliance and educational information. RESIDENTIAL PROPERTY MAINTENANCE INSPECTIONS ARE UNDERWAY



Elk Grove Village prides itself on providing an aesthetically appealing environment for residents, businesses and visitors. Every year Village Property Maintenance Inspectors conduct neighborhood inspections to ensure compliance of minimum standards set forth in the Village code for all properties.

Please be advised, we conduct all property inspections from the sidewalk, adjacent streets, or where permission granted, from the property itself. Our inspectors are happy to assist you with any of the following Property Maintenance Code items.

Do you want to make sure your home is up to code? Here is a handy list to get started:

Address Numbers should be seen from the street, Arabic numerals or alphabet letters should be 4 inches high x 0.5 inches wide.

Exterior Surfaces must be free of holes and rotting materials, properly painted, and water proofed.

Doors must be in good condition and weather-tight.

Windows & Frames should be free of cracks or holes, must be in good condition and weather-tight.

Roofs should not have missing shingles, signs of sagging, or any defect that would allow water to leak through.

Gutters must be in good condition, anchored to the roof with leaders and downspouts properly connected, and free of obstruction.

Accessory Structures such as decks, sheds, detached garages, fences, porches, pools and retaining walls must be structurally sound and in good condition.

Trees and Bushes cannot overhang the public sidewalk.

Driveways and walkways must be kept in good condition, no severe cracks, deterioration or settlement that might create a tripping hazard.

Brick Veneer must be structurally sound and have no missing bricks, mortar or excessive cracks.

Right-Of-Way Obstructions are not permitted on your property with the exception of mailboxes.

NWMC MULTIMODAL TRANSPORTATION PLAN

REPORTING COYOTE SIGHTINGS

Over the past few months, the Elk Grove Village Police Department has received reports from residents with concerns about increased coyote activity in populated areas. While not all coyote sightings are cause for concern, the Police Department's top priority is keeping residents and their pets safe. Therefore, the department is taking a proactive step to strategically address coyote issues or concerns by partnering with Scientific Wildlife Management. Scientific Wildlife Management has worked with many municipalities throughout the Chicagoland Area and is led by Rob Erikson, one of the nation's leading experts on the topic of urban coyote management.

Mr. Erikson is enlisting the help of the community to get a better understanding of the Village's coyote population and patterns. Residents are requested to report any coyote concerns, issues, or contacts to Scientific Wildlife Management. The webpage is user friendly and provides valuable data, such as location of the coyote sighting, the physical condition of the coyote, and the behavior of the coyote.

Through hiring Scientific Wildlife Management, the Village will be provided with understanding monitoring and management of the coyote population in order to mitigate any threatening coyote encounters. Scientific Wildlife Management will review the information that residents provide through the online portal.



Residents are requested to report all unusual coyote behavior, so Scientific Wildlife Management can accurately investigate coyote concerns. Additionally, Elk Grove Village staff would like to remind residents to not feed coyotes or wild animals, leave pet food/water outside, put food products into compost piles, or leave pets outside without supervision.

EMS BILLING FAQ FOR RESIDENTS

Will residents get an EMS/ambulance bill?

No. All charges are issued to the patient's insurance company (including Medicare and Medicaid). Residents are not billed. However, you may receive a request from Andres Medical Billing, our medical billing administrator for insurance information if it was not provided at the time of transport. This form should clearly state "This is Not a Bill".



What is EMS billing?

EMS billing is a fee for service charged for ambulance transportation to a hospital facility. No fees are charged if a patient is not transported.

What is the cost for ambulance services?

The cost for ambulance services was recently streamlined to charge a flat fee, regardless of residency or level of service provided.

What if my insurance does not cover the bill?

The rates charged for ambulance services by the Village are within the generally accepted limits for reasonable and customary rates allowed by insurance carriers. Any remaining balance owed after insurance payments have been received will be waived. It is Village policy to never balance bill ambulance patients.

2. Keep your dog on a leash: Walking your pet on a leash protects your pet from traffic, unrestrained animals and provides a way for your pet to be properly introduced to people or children you may encounter.
3. Walk your dog in the parkway: As a friendly neighbor, walking your dog in the parkway can help prevent your dog from trespassing on neighbors property during your walk.

GROUND BREAKING FOR ELK GROVE VILLAGE VFW HALL ELEVATOR

On Monday, April 8, Keeley Construction hosted a ground breaking ceremony for the elevator installation at the Elk Grove VFW Hall located at 400 E. Devon Avenue in conjunction with VFW Post 9248, Community Character Coalition (CCC), and the Village of Elk Grove.

The groundbreaking marked the commencement of the installation of a much-needed elevator at the Elk Grove VFW Hall, our Veterans' home away from home. Currently, the VFW Hall has no ground floor entry, and no wheelchair accessible entrance—VFW members have to enter the VFW Hall by using a staircase.

CCC member Kitty Weiner first proposed the idea of raising funds to help the VFW with this project. Mayor Johnson saw an opportunity to achieve this ambitious goal by connecting the CCC with the owners of Castle Chevrolet—Joe Castelbuono, Tony Castelbuono and Bob Politza—who generously donated a 2017 Corvette to raise funds in the “Vette for Vets Car Raffle”. The Elk Grove community raised \$178,953 through raffle ticket sales and many generous donations from the Elk Grove business community. These funds were donated to VFW Post 9248 to support this project.

The installation of an elevator into an existing building is a complex project, and has presented many challenges throughout the development period, including additional costs that exceeded the original fundraising estimates. Earlier this year, Sean Keeley of Keeley Construction stepped in and generously offered to take over the project construction and help out in closing the gap on the fundraising side.

This entire process would not be possible without the initiative and dedication of the Community Character Coalition, the generosity of Castle Chevrolet North, donations from numerous local businesses, and commitment of Keeley Construction to bring this to the finish line.



FIREWORKS SAFETY & THE LAW

Although, the purchase of some types of fireworks may be legal in neighboring states, the fact remains that they are illegal to use, sell, or possess in Illinois.

In addition to the illegality, people tend to overlook the obvious dangers involved as adults as well as children can be burned or injured from the heat, fire, projectiles, and explosions.

Due to the public safety risk and the risk to property loss, Elk Grove Village ordinance prohibits any person from possessing, manufacturing, storing, selling, or exploding fireworks in the Village all year round. The law in Illinois does not change over the July 4 Holiday or any other holiday.

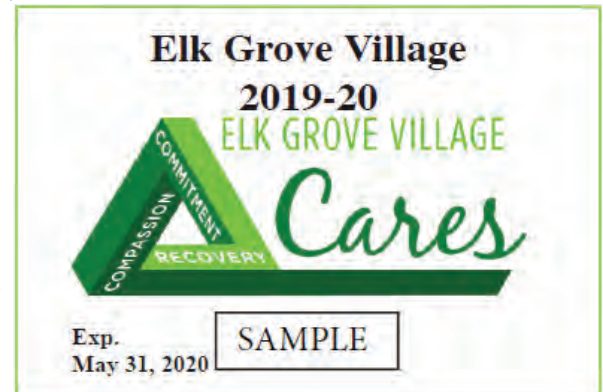

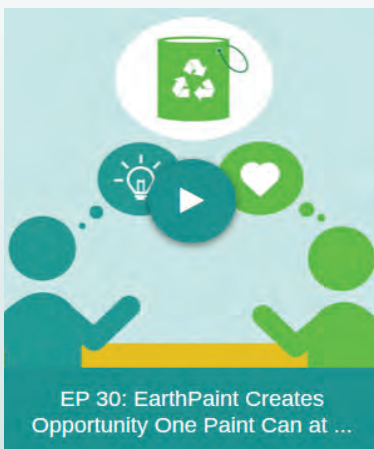

Vehicles that do not have a sticker displayed by June 1, or within thirty days of purchase for new vehicles, and are registered to or housed at a business within Elk Grove Village are subject to citations and fines per Village Code 6-2-2.

Vehicle stickers may also be purchased in person at the Finance Department counter, Monday through Friday 8:00 a.m. until 5:00 p.m., and the first Saturday of every month from 9:00 am until noon excluding holiday weekends.

WHAT YOUR TREE MAY BE EXPERIENCING THIS SEASON

This spring has been particularly rough on area trees and landscaping. The Chicago area has experienced an unusual number of rain showers, including over 8 inches of rain in May alone. Trees like damp soil, but do not like drenched conditions that were common in much of the area this spring. Tree roots gather oxygen from the ground, and if the ground is constantly saturated, trees can be deprived of oxygen and become more prone to disease.

Spring has been wetter than average this year causing various problems for our trees and landscaping—but the problems are not permanent. Issues that have been observed in the community include Tar Spots, Leaf Drop, Cedar-Apple Rust, Phomopsis Blight (browning of Evergreens), and Apple Scab.

Additionally, the cooler temperatures and moist ground conditions are favorable for a number of insects that cause cosmetic issues for trees such as Scales, Japanese Beetles and Gal. HOME RENOVATIONS

Considering a home remodel or addition project? The Community Development Department is here to assist you in making the permit and inspection process a positive experience. Below are guidelines to help guide you through the process from start to finish.

Step 1 - Make a list! Write down your renovation ideas and goals. Decide which rooms to remodel first and the design for each. It's helpful to sketch plans in order to get a visual concept of how the alterations will look, enabling you to move forward or redesign the project.

If you need help with the renovations, your next step is to find professional contractors to do the work.

Step 2 - Hire your contractor! In order to safeguard your peace of mind and your renovation, hiring a proficient contractor is essential. Use online resources and reviews or ask your neighbors if they can refer a trustworthy contractor. It is wise to obtain a minimum of three proposals in order to compare price and scope of work as well as asking for references in order to ensure their quality of work. Be cautious when deals sound too good to be true and always ask questions.

Step 3 - Get Permits! Once you have selected a contractor, it is the responsibility of either the homeowner or contractor to submit a construction permit application to the Village detailing the full scope of work. Once all applicable building and/or engineering permits are approved and issued by the Village, construction can begin. Inspections are performed by Village staff, to ensure all renovations are compliant with current codes, standards and restoration practices. Continue to ask questions and maintain open communication with your contractor and Village inspectors. At the end of your project, be sure to obtain a Waiver of Lien from the contractor as proof of payment in full.

RUSE BURGLARY PREVENTION

The northwest suburbs, including Elk Grove Village, typically experience ruse burglaries during the warmer seasons. Ruse burglaries often begin with the offenders creating an excuse to enter the victim's home. After selecting homes usually of older victims, the offenders often claim to be a utility worker, Village employee, or a contractor. They will enter the home using the ruse of needing to check something (property lines for fences, water pressure, fuses, or pipes). While one offender keeps the homeowner occupied, one or more additional offenders enter the home undetected and commit a burglary.

Prevention Tips:

- Do not let any unsolicited workers into your home without contacting the Village, Utility or Police Department.
- Always request identification from utility workers--you may prevent yourself from becoming a victim by showing the offender that you are alert to the possibility that they are not who they claim to be.
- If you are ever in doubt or see something suspicious, close and lock your doors and call 911 immediately.
- Call 911 if you feel that you may already have been a victim.



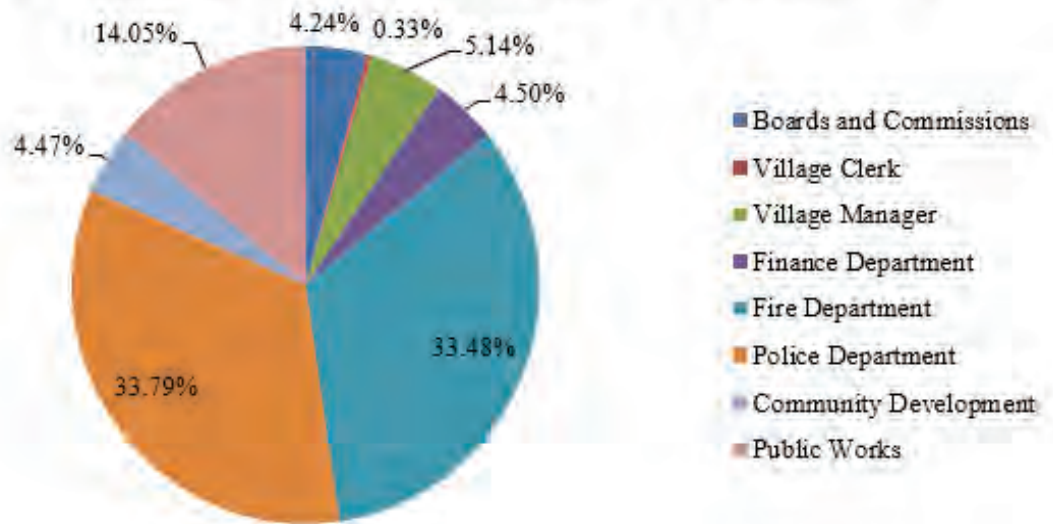


VILLAGE BOARD APPROVES FISCAL YEAR 2020 BUDGET

On April 23, 2019, the Mayor and Village Board approved the Fiscal Year 2020 Budget in the total amount of \$139,003,750. The General Fund budget, which contains most of the Village’s traditional services such as Fire, Police and Public Works, was approved at \$60,688,774.

Elk Grove Village is experiencing continued financial progress and stability through an increase of business development activity. The first quarter of 2019 maintains a low industrial vacancy rate at 3.21%. As a result, the General Fund has experienced overall positive balances for the past several years. This is predominately resulting from rising sales taxes as well as building permit fees. While we appreciate less-trying economic times, the Mayor, Village Board, and Department Heads continually explore innovative methods of delivering services in a cost effective manner.

Fiscal Year 2020 Operational Expenditures



In December 2017, the Village annexed a greenfield subdivision to be developed as the “Elk Grove Technology Park.” The project serves as an 85 acre light industrial Tech Park redevelopment that includes Busse Farm and neighboring properties with a planned 1.25 million new square footage of industrial property. Phase I of construction is underway with four buildings on the west side and construction for the five remaining buildings is anticipated to begin this summer.

After having celebrated its 60th birthday in 2016, the Village Board is planning for the future with a new capital program entitled: “Elk Grove 2025.” This program is an 8-year, \$135 million capital investment program designed to prepare the community for the next 60 years. As part of the program, the Village has completed four major facility construction/renovation projects in the past two years. The Biesterfield Fleet Garage rehabilitation was completed in January 2018. The James Paul Petri Public Works facility was occupied in January 2019 and includes 85,000 square feet of office and garage space. The 8 acre development also includes a salt storage barn and fueling station. Most recently, two brand-new fire stations, Fire Station 10 on Meacham Road and Fire Station 8 on Fargo Avenue, opened for operations at the end of April 2019.

In keeping with the Village’s commitment to high and consistent standards, the Fiscal Year 2020 Budget was guided by the goal of enhancing customer service for both residents and the Village’s business park. To that end, the recommended budget represents a value driven approach designed to increase the Village’s flexibility to continue enhancing customer service while capturing efficiencies. Over the past several fiscal years, the Village has laid the foundation for these initiatives.

The Fiscal Year 2020 Budget also includes a continuation of community events including the Mid-Summer Classics Concert series that will feature five performances including one on the Fourth of July with a fireworks display, the annual Oktoberfest, and the annual Holiday Tree Lighting Ceremony.

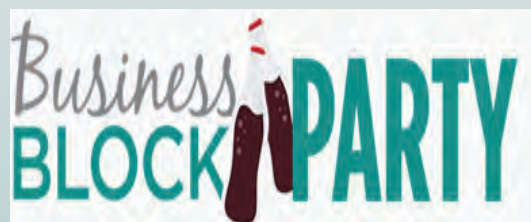

BOWL GAME SPONSORSHIP DELIVERS BIG WIN FOR ELK GROVE VILLAGE

Elk Grove Village officials announced at the Board Meeting on August 13, that its sponsorship of a college football bowl game attracted a national travel stop network to Elk Grove Village.

Love's Travel Stops & Country Stores, the nation's industry-leading travel stop network, is seeking to build a 7,600 square-foot store and fueling station at the intersection of Pratt and Busse in Elk Grove Village. **Officials project that the store would generate millions of dollars in sales tax revenue for the Village in just a few years.**



Officials from the Village and Love's held an introductory meeting in May 2019 to discuss potential locations. At the end of the meeting, Chad Bruner, real estate project manager for Love's, mentioned to Mayor Johnson that he first heard of Elk Grove Village while watching the Makers Wanted Bahamas Bowl last year from his home in Oklahoma City. Bruner liked the creativity and boldness of the sponsorship and began to explore the potential of opening a Love's store in Elk Grove Village.

"Love's has been looking for the right place to serve customers in the O'Hare International Airport area, which is both a heavily traveled area and densely populated," Bruner said. "The sponsorship drew my attention and made me think of Elk Grove Village as a business-friendly place. The service and support I've gotten from the Village have confirmed that they are the right partners for this unique endeavor. We're excited for the opportunity to bring jobs and our brand of Highway Hospitality to customers in Elk Grove Village."

“From the beginning, sponsoring the Makers Wanted Bahamas Bowl was about creating national and international brand awareness for the Elk Grove Village Business Park. We knew this bold move would serve as a great platform to tout our ‘Beyond Business Friendly’ approach to attracting companies to the Village,” said Mayor Johnson. “The story of Love’s coming here is a great example of how we’re creating strong economic momentum.”



Love’s officials have signed a lease for the property located at Pratt and Busse in Elk Grove Village and submitted a petition for a special use permit for their fuel station operations. The next step for approval will be a public hearing before the Village’s Plan Commission, which will then issue a recommendation to the Village Board. The special use petition is currently under staff review and a public hearing is not yet scheduled. Company officials say they are working to cut the ribbon on the new Love’s store in 2020.

Elk Grove Village is home to the nation’s largest industrial park, a 6-square mile expanse that is home to more than 5,600 businesses that employ over 100,000 people.

The Village is the title sponsor of the 2019 Makers Wanted Bahamas Bowl. It began its sponsorship with the bowl game last year and became the first non-tourism driven municipality to ever be the title sponsor of any college football bowl game. Sponsoring the Makers Wanted Bahamas Bowl is one facet of the Village’s overall economic development strategy that has delivered results for businesses and residents alike.

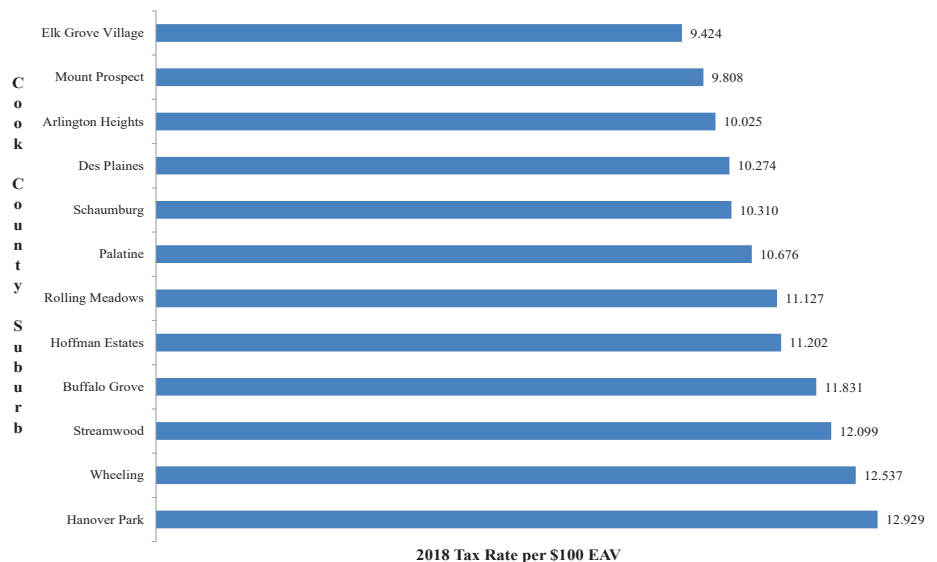
VILLAGE MAINTAINS EXCEPTIONALLY LOW PROPERTY TAX RATE

As residents receive and pay their 2018 property tax bills, the Village of Elk Grove is proud to share that we have been able to keep our tax levy flat (with no increase from the previous year) due to our value-driven customer service approach to delivering the highest quality services for our residents and businesses.

The overall 2018 property tax rate for residents—the combined rate for all taxing districts, such as the park district, library and schools—is \$9.424 per \$100 equalized assessed value (EAV). The Village accounts for approximately 10% of the overall property bill.

Elk Grove Village has the lowest combined property tax rate in the area—it is lower than comparable communities by an average of nearly \$1,234 for the most recent property tax bills. The Village is able to maintain these low property tax rates due to our robust business community, which helps keep costs low for residents.

ELK GROVE VILLAGE CARES, ONE YEAR LATER

In July of last year, Elk Grove Village officials launched a comprehensive, community-based approach to reducing the number of heroin and opioid-related deaths, connecting addicts and their families to treatment programs and counseling, and educating residents about the devastating effects that opioid addiction can have on people, families and communities.



Since the program began last summer, community support of Elk Grove Village Cares has continued to grow, and so many people have come forward to share how their lives have been touched by the disease of addiction, whether through a loved one or through their own personal experience.

One of the key pieces of the program has been the Police Department placing individuals seeking treatment immediately into treatment centers, and covering the costs of treatment for the uninsured, when necessary, through grants and designated Village funds. As of today, there have been thirty intakes for treatment through the Elk Grove Village Cares program and we are proud to say that one participant has now celebrated one full year of sobriety since she entered our program. Elk Grove welcomes anyone who needs assistance.

The Elk Grove Village Cares program also includes personal follow-up with individuals who enter treatment through the program, the placement of overdose-reversing medication naloxone in public places, the creation of a family support group for those who have loved ones suffering from the disease of addiction, and increased education and awareness to the community on this national epidemic.

POLICE DEPARTMENT WINS 1ST PLACE AT THE ILLINOIS TRAFFIC SAFETY CHALLENGE

On August 14, the Elk Grove Village Police Department won 1st Place at the Illinois Traffic Safety Challenge in the Municipal Police Agency (66-100) Officers Category. The Department also received the Rookie of the Year Award, as this was the first year that the Department participated in the program.

The comprehensive traffic safety initiative consists of a panel of judges reviewing areas such as department training, review of policy and guidelines, public information and education, enforcement activity, and effectiveness of efforts.

The overall results of this initiative specifically focused on occupant protection, distracted driving, speed, and impaired driving--these are the most common causes of traffic accidents. The department also received a Laser Technology Lidar and \$5000 in tuition for officer training at Northwestern University's Center for Public Safety.

STORMWATER SURVEY

As part of on-going efforts to address stormwater impacts throughout the Village, we need your input! Our region has been experiencing more frequent and larger rain events over the past few years. Subsequently, the Village has seen an increase in reports of stormwater ponding (standing water after a storm) from residents.

We are currently working to gauge the level of stormwater ponding on properties in the Village. We have developed a survey for residents to gather information on stormwater issues within the Village. Your input will assist the Village in understanding the location and nature of these issues. Even if you do not experience stormwater ponding on your property, your response will help develop a better understanding of stormwater issues in the community.

VILLAGE PARKING REGULATIONS

Elk Grove Village parking regulations are in place to help ensure the safe flow of vehicular traffic on our streets and to deter crime in residential neighborhoods and the Business Park. Parking restrictions are common among suburban municipalities because they:

- Prevent the storage/abandonment of vehicles on public streets;
- Assist overnight street patrols in identifying suspicious vehicles parked in neighborhoods; and
- Allow for safe and effective snow plowing

In residential areas, vehicles are not permitted to park on streets during the hours of 2 a.m. to 5 a.m. Residents can request temporary parking permission from the police department by calling the non-emergency number 847-357-4100 or by using the Village's service request system at www.elkgrove.org/contactus.

In the Business Park, vehicles are prohibited parking on roadways from 7 p.m. to 7 a.m. and are also limited to a maximum of two-hour parking on streets during the day, as identified by signage. While commercial vehicle traffic flow generally decreases overnight, parked vehicles on the roadway create hazards and operational issues for commercial truck drivers making deliveries during the day and night.

The Village of Elk Grove prides itself on being Beyond Business Friendly. Should a resident or business owner have specific parking issue they should contact a police department shift supervisor at 847-357-4100. Please note that on evenings when snowfall exceeds two inches, every kind of overnight parking permit is canceled, and all on-street vehicles have to make way for incoming plows.

FALL CLEAN-UP PROGRAM

Elk Grove High School is once again offering its Fall Clean-Up program. Students are volunteering to do lawn clean up, flowerbed clean up, leaf raking, and window washing for those who are not able to do it themselves (seniors or disabled adults).

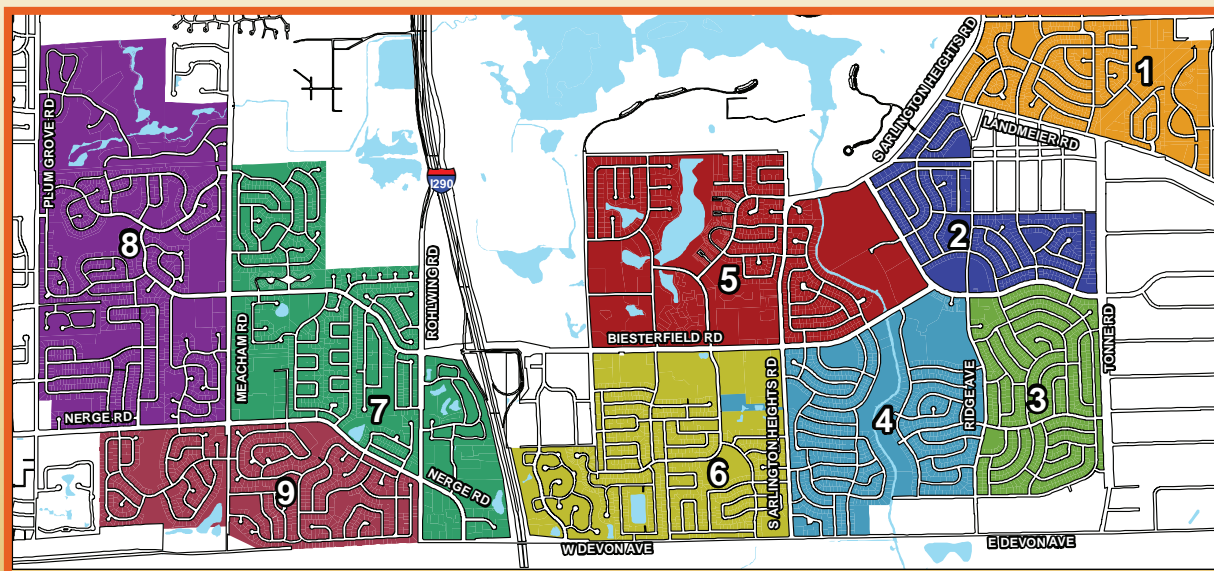
2019 FALL LEAF COLLECTION PROGRAM

During the months of October and November, the Village offers residents convenient disposal of their Fall leaves through the Public Works Department. The Village is divided into sections, and each section receives four (4) leaf collection dates. The scheduled collection dates and a map depicting the Village sections are shown below. If you choose to bag your leaves, the normal rules for yard waste disposal will apply. Only paper yard waste bags or refuse cans may be used; no plastic bags will be accepted. One yard waste sticker is required for each bag or can.

Should you have any questions or experience any problems with the program, please call the Public Works Department at (847) 734-8800, Monday through Friday, between 8:00 a.m. and 4:30 p.m., or check the Village website at www.elkgrove.org/leaves for more information. Please make sure to comply with these important program regulations:

- Only rake leaves into the street. Grass, branches and yard waste can damage equipment.
- Leaves should be raked into the street after 3 p.m. the day before collection and before 7 a.m. the day of collection.
- Leaves should be placed in a continuous row on the pavement 2 feet from the curb.
- Parking in the street will be prohibited on the day of collection from 7 a.m. until the leaves are removed.
- No leaves are to be placed on State or County roadways, nor on the following Village streets: Tonne Road, Elk Grove Boulevard, Oakton Street, Rev. Morrison Boulevard, J.F. Kennedy Boulevard, Biesterfield Road, and Wise Road. Residents along these streets should place their leaves in the parkway on collection day.
- In the event of rain, you should still place your leaves in the street on your scheduled date. Leaves will be collected as soon as possible after the scheduled date.
- In the event of snow, leaf pickup will be rescheduled for another day.

INTERNATIONAL AEROSPACE LEADER CHOOSES ELK GROVE VILLAGE AS NEW HUB FOR US OPERATIONS

Elk Grove Village is pleased to announce that Broetje-Automation, world leader in automated manufacturing for the aerospace industry, has chosen to base its U.S. operations at the new Elk Grove Technology Park.



The company has signed a lease with Elk Grove Technology Park developers Brennan Investment Group to occupy more than 43,000 square feet in one of the four buildings currently under construction. The site will serve as Broetje-Automation's U.S. headquarters and production facility for manufacturing and assembling robotic systems and automated composite manufacturing equipment.

Broetje-Automation is the Elk Grove Technology Park's first tenant and is the type of company that Elk Grove Village leadership envisioned when it began the process of transforming land that was once Busse Farm into a high-tech manufacturing hub.

"An international aerospace technology giant planting its flag here in Elk Grove Village is further fulfillment of our vision to meet the growing demand for modern facilities that can accommodate the high-tech needs of manufacturers, data centers and others," said Mayor Johnson. "Broetje-Automation's arrival in Elk Grove Village is just the beginning. We will continue work to promote the Village as a premier destination for high-tech manufacturing firms and companies that understand the value of location and a community that will support them at every turn."

Broetje-Automation expects to begin operations in the Elk Grove Technology Park, which is located between East Higgins Road and Oakton Street, in October. The company said it plans an aggressive hiring program adding 80-100 new positions in Elk Grove Village in the coming years. Broetje will be hiring specialized machine builders with mechanical and electrical skills, engineers of several disciplines (electrical, mechanical, controls, software), as well as the full range of back office personnel.

“The Elk Grove Technology Park was the only property we looked at where local government officials were fully engaged and involved from day one, which made us feel much more comfortable that the process would run smoothly,” said Broetje’s Brian O’Rourke, Vice President. “Additionally, Elk Grove Village officials have made the commitment to connect Broetje to other industrial park companies, government officials, educational institutions and programs that offer training. We are excited to be the first tenant at the Elk Grove Technology Park and bring the industrial park into the future with this tech park concept.”

The Elk Grove Technology Park lies on the north end of the nation’s largest industrial park, a six-square mile area that is home to nearly 5,600 businesses that employ nearly 100,000 Chicago-area residents.

Over the last several years, the Village has worked to support the transformation of Busse Farm from vacant land into a thriving high-tech hub spanning 85 acres. The Village annexed this land in 2017 and approved a redevelopment agreement to support the necessary infrastructure development, including new roads, water service and sewer systems.

The Village worked with ComEd to secure a site for a new electrical substation just east of the Elk Grove Technology Park near I-90 that will supply robust and reliable power to the community, companies in the adjacent industrial park, and new tenants that will occupy the Elk Grove Technology Park.

“For decades, Elk Grove Village has been a destination for companies large and small looking for a place where they can grow, thrive and innovate,” said Mayor Johnson. “Companies want to operate in municipalities that will foster and support their growth, rather than be an impediment to it. ELK GROVE HOTEL REDEVELOPMENT

On August 13, 2019, the Elk Grove Village Board approved a redevelopment agreement with Sunrise Retail Development LLC for the former site of the Elk Grove Hotel at 1600 Oakton. The agreement lays out a plan to transform the existing site with a modern layout, including two nationally recognized hotels and a restaurant or commercial building.

The 7.4 acre property will be developed in three phases, the first of which is the construction of a Country Inn & Suites hotel beginning in 2020. The hotel will be built with a portion of the former 3-story Elk Grove Hotel and is planned to include 98 guest rooms. A restaurant or commercial building is planned for phase two of the development. The third phase, which will also begin in 2021, is the construction of an entirely new Tru by Hilton hotel to include 98 guest rooms.

The Village purchased the former Elk Grove Hotel site in 2018 for the purpose of attracting redevelopment along a major entry corridor of the Business Park. Sunrise Retail will invest an estimated \$25 million into the site throughout the three phase development period.

The purchase of the former Elk Grove Hotel site was made using funds from the Busse/Elmhurst Tax Increment Financing (TIF) District. The Busse/Elmhurst TIF was created in 2014 to spur private investment and development in blighted and underutilized areas. Tax Increment Financing freezes the assessed value of property within a designated area (or “district”) so that new money generated can be used for uses such as promoting redevelopment. Private investment and redevelopment revitalizes and grows the Village’s tax base to ensure the future financial security of the community.

The study formulated a safety index score by reviewing the most recent FBI crime statistics to create state rankings based on cities in Illinois with a population of 10,000 people or more. The study reviewed violent crime rates, property crime rates, and the number of law enforcement workers on a per capita basis. The study named Warrenville first, Deerfield second, Elk Grove Village third, Burr Ridge fourth, and Wood Dale fifth as the top 5 safest cities to live in Illinois. This accomplishment reflects not only the efforts of the Elk Grove Village Police Department, but also the commitment of the Village in providing essential training, resources and support.

RECENT ROBOCALLS, NOT FROM THE VILLAGE

In the recent weeks, there have been numerous anonymous robocalls and mailers that have been distributed throughout the community. The Village of Elk Grove is in no way affiliated with these robocalls or mailers and has no control over them.

Several of the robocalls have addressed the issue of the Haymarket drug addiction treatment center planned for Itasca. The Village of Elk Grove has not been approached by Haymarket about opening a facility in our community, despite the robocall pronouncements.

The Village of Elk Grove does not involve itself in political activities, such as the kind included in the robocalls. If anyone has any questions or concerns about the robocalls or mailings, please call Mayor Craig Johnson directly at (847) 437-8226.

ELK GROVE VILLAGE CARES PROGRAM: RUMOR VS. FACT

RUMOR: The Village of Elk Grove will spend \$500,000 of Village taxpayer money on treatment for addiction for out of town residents through the Elk Grove Village Cares (EGV Cares) program in 2019.

FACT: Elk Grove Village has made a commitment to address the disease of addiction in our community, and we stand by that commitment. Addressing this type of public health issue is not something that can be done just in one community—opioid addiction is a national public health crisis and there are grant funding opportunities available to support programs like EGV Cares.

In order to be eligible for such grants, which support the treatment of residents, the Village cannot discriminate against individuals based on where they live. The Village has so far received two grants from the State of Illinois Criminal Justice Information Authority totaling \$78,584 to support treatment for individuals through the EGV Cares program. Treatment costs to date have totaled less than \$50,000.

RUMOR: The Elk Grove Village Cares Program was recently expanded to include treatment for individuals who are not residents, and as a result, individuals from across the U.S. will be flooding the Village to take advantage of the program.

FACT: The Elk Grove Village Cares Program is now over a year old, and has been open to any individual seeking treatment, without discrimination, since its inception. In that time, there have been 32 referrals to treatment through the program. Over 63% of these referrals have been for Village residents, and the remaining individuals have been from nearby communities—all living less than 20 miles from Elk Grove Village. Many of the participants from other communities are former Village residents or have immediate family members living in the Village. Some program participants have insurance coverage and simply need assistance connecting to treatment and support to continue with recovery. Grant funding has been used to pay for treatment for those without insurance, which has included both residents and non-residents.

ELK GROVE VILLAGE CARES EARNS MAJOR FEDERAL GRANT TO PROVIDE RESOURCES AND TRAINING TO COMBAT OPIOID-RELATED OVERDOSES

The Elk Grove Village Police Department is proud to announce that Elk Grove Village Cares, a comprehensive, community-based initiative to take on the opioid epidemic, will serve as a regional resource to area community groups and municipalities in northwest suburban Cook County seeking to utilize opioid-reversing medication thanks to a \$385,000 federal grant.



The grant, funded by the First Responders Comprehensive Addiction Recovery Act and awarded by the United States Department of Health and Human Services - Substance Abuse and Mental Health Services Administration, is renewable in the same amount for three additional years for a total grant amount of \$1,540,000.

Elk Grove Village Cares will partner with the Kenneth Young Center and Live4Lali to provide Narcan-related training and resources to law enforcement organizations and community groups.

Narcan, also known commercially as Naloxone, is a drug administered via a nasal spray or auto-injector, which can temporarily stop or reverse the effects of an opioid or heroin overdose. Narcan allows EMTs and police officers to take potentially life-saving action when they encounter an individual suffering an overdose. The grant will provide training for first responders and the public about how to administer Narcan and will also help equip first responders with the overdose reversing drug.

Training on safety around fentanyl, carfentanil, and other dangerous licit and illicit drugs is also funded by the grant. Further, the groups will work to develop strategies to connect overdose survivors with the right treatment program and recovery support services.

The partnership will provide training and resources in the following communities: Arlington Heights, Des Plaines, Elk Grove Village, Hoffman Estates, Mount Prospect, Palatine, Prospect Heights, Rolling Meadows, and Schaumburg.

“This grant establishes Elk Grove Village as a regional resource to other communities and organizations seeking to take on the opioid epidemic in a smart, strategic and comprehensive way,” said Elk Grove Village Mayor Craig Johnson. “It’s a role we’re well-equipped to serve based on our ongoing commitment to face this challenge head on. Further, the grant really validates the approach we are taking to save lives, get more people into treatment and remove the stigma around opioid addiction.”

Earlier this year, Elk Grove Village Cares received a state grant aimed specifically at providing addiction treatment to more people, including the uninsured.

“These two grants complement one another very well because it means we can use state funds to support actual treatment for people suffering from the disease of addiction and federal funds on ensuring the availability of Narcan where it is needed and training for first responders and communities,” said Deputy Police Chief Mike Gaspari.

MIKERPHONE BREWING PRESENTS DONATION TO COMMUNITY CHARACTER COALITION OF ELK GROVE



Mike Pallen, owner of Mikerphone Brewing, presented a check for \$18,500 to the Community Character Coalition (CCC) of Elk Grove at the Village Board Meeting on September 10. The check represented the proceeds from Mikerphone's annual festival, "Smells Like a Beer Fest", which was held outside the brewery on Garlisch Drive in April 2019.

Over the past three years, this event has raised over \$50,000 for community organizations. Mikerphone initially approached the Village about hosting a fundraising event on Garlisch Drive outside their brewery to raise money for local community organizations back in 2017, shortly after they opened for business. The Village

agreed to partner with Mikerphone Brewing to co-sponsor the annual fundraising event, and each year it has expanded to allow for a bigger crowd and raise more money for charity.

In 2017, Mikerphone Brewing's craft beer festival was limited to 500 attendees and raised \$10,000 to support the installation of the elevator at the Elk Grove Village VFW Hall. In 2018, Mikerphone expanded the festival to 750 attendees and raised over \$17,000 for the Elk Grove Youth Committee to use towards college scholarships. This year's event included 1,000 attendees and raised a total of \$26,000, which was split between the CCC, which received \$18,500, and ChildServ, which received \$7,500.

Due to the continued popularity of the event, Elk Grove Village and Mikerphone have agreed to move the 2020 festival to Rotary Green on Lions Drive to allow for additional capacity. Next year's event is set to take place on May 2, 2020, and will accommodate 2,500 people, with the goal of raising \$50,000 for the Kenneth Young Center and A Caring Place Respite program.

The Village is proud to partner with Mikerphone Brewing on this annual event, and is grateful for their continued support of the community.

ELK GROVE VILLAGE WATER METER UPGRADE

Elk Grove Village is embarking on a program that will replace about 10,600 water meters with new meters. The new meters will replace older, mechanical units with new technology that will help identify high water usage and potential leaks. The new meters will result in smarter water use for customers.



The new meters and remote will automatically transmit data wirelessly and eliminate the need to manually read each meter. This allows the Village to be more efficient and save money by preventing recording errors and eliminating time-consuming manual meter reading.

Every water customer with the older style meters will receive a new water meter at no charge. It will take about one year to replace all the meters in the Village.

The Village has awarded a contract to Siemens Industry, Inc. to perform this meter upgrade. The installer will need to access your home to replace the meter. Siemens will reach out and work with residents and businesses to arrange a convenient appointment time to complete this task.

When will the Village begin installing new meters?

Installation will begin in December of 2019, beginning with residential meters, followed by commercial and industrial meters. The installations will be staggered throughout the community over several months. The Village will provide further communications in the coming months regarding scheduling appointments for your new meter.

Why is Elk Grove Village installing and upgrading water meters?

Water meters across the Village are approaching or exceeding the American Water Works Association's recommended lifecycle. As the current mechanical water meters age, they may slow down and their accuracy in registering water consumption decreases. The planned water meter upgrade will replace all water meters in the Village to achieve both technological and customer service benefits.

Do you have to enter my home/business to change my water meter?

Yes. Due to freezing temperatures in the winter, all meters are installed within the home or business. Most homes have a device for remote reading access on the outside of the home that will also be changed as part of this project.

Will my water bill increase?

The water rate you pay will not change as part of this project. The new water meters will allow customers to be billed for actual water used. Depending on the accuracy of their existing meter, a customer may see a variance when they receive an accurate meter. The new meters will provide instant leak alerts and so customers will not have a leak that has been ongoing and unnoticed, thus increasing their water bill.

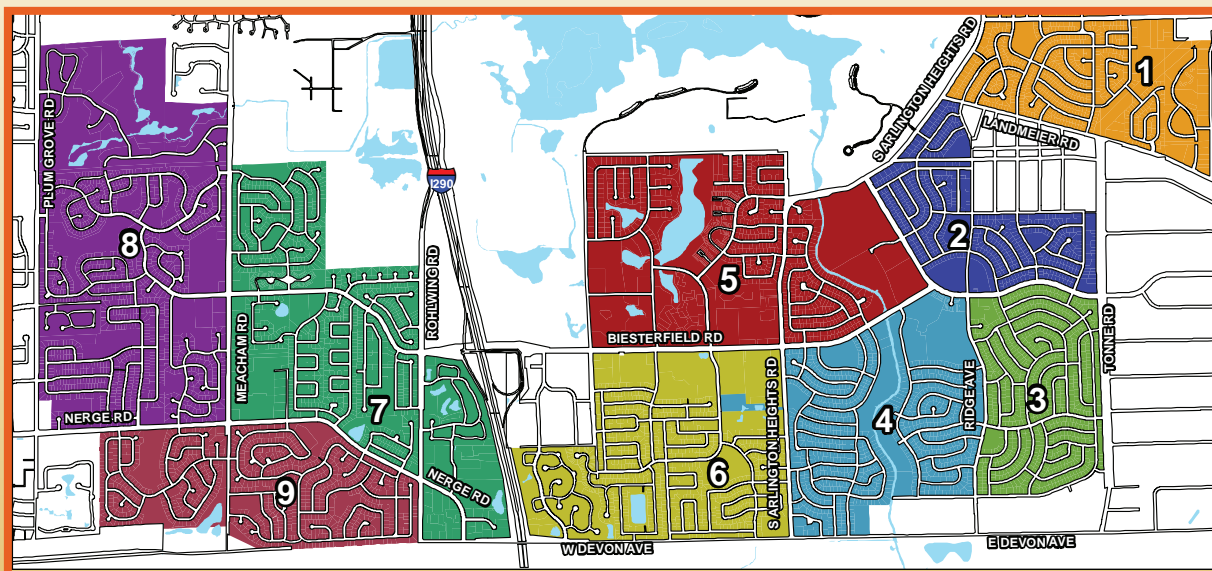
2019 FALL LEAF COLLECTION PROGRAM

During the months of October and November, the Village offers residents convenient disposal of their Fall leaves through the Public Works Department. The Village is divided into sections, and each section receives four (4) leaf collection dates. The scheduled collection dates and a map depicting the Village sections are shown below. If you choose to bag your leaves, the normal rules for yard waste disposal will apply. Only paper yard waste bags or refuse cans may be used; no plastic bags will be accepted. One yard waste sticker is required for each bag or can.

- Only rake leaves into the street. Grass, branches and yard waste can damage equipment.
- Leaves should be raked into the street after 3 p.m. the day before collection and before 7 a.m. the day of collection.
- Leaves should be placed in a continuous row on the pavement 2 feet from the curb.
- Parking in the street will be prohibited on the day of collection from 7 a.m. until the leaves are removed.
- No leaves are to be placed on State or County roadways, nor on the following Village streets: Tonne Road, Elk Grove Boulevard, Oakton Street, Rev. Morrison Boulevard, J.F. Kennedy Boulevard, Biesterfield Road, and Wise Road. Residents along these streets should place their leaves in the parkway on collection day.
- In the event of rain, you should still place your leaves in the street on your scheduled date. Leaves will be collected as soon as possible after the scheduled date.
- In the event of snow, leaf pickup will be rescheduled for another day.

HALLOWEEN SAFETY TIPS

VILLAGE GRANT TO BOLSTER ELK GROVE HIGH SCHOOL WORKFORCE DEVELOPMENT INITIATIVES

Elk Grove Village is excited to announce that we are providing a \$100,000 grant to the District 214 Education Foundation to assist in the modernization and expansion of Elk Grove High School's Fabrication Lab, which allows students the ability to learn advance manufacturing skills on the precision machinery used in today's manufacturing sector. Village officials say the grant is one facet of the Village's overall efforts to strengthen the local workforce through education.

The Elk Grove High School Fabrication Lab currently houses industry standard equipment to allow students to learn how to work with metal, wood and other materials. GAS STATION COMING TO ELK GROVE AS A RESULT OF THE BAHAMAS BOWL

Elk Grove Village has formally approved plans for a Love's gas station -- the first bricks-and-mortar example of a business attracted to town through the village's unconventional sponsorship of a college football game.

The 7,600-square-foot store and fueling station with nearly two dozen pumps will be built on four acres it's leasing at the northwest corner of Busse Road and Pratt Boulevard, in the village's sprawling industrial park. Construction is scheduled to start next spring.

Marketing the six-square-mile business park -- the nation's largest -- was the aim behind Elk Grove's \$300,000 sponsorship of the Makers Wanted Bahamas Bowl last December in Nassau, Bahamas.

And it was because a Love's executive was watching the game on ESPN that he says he first learned of the town and started to take a serious look at opening a location there.

Chad Bruner, the real estate project manager for the Oklahoma City-based gas station chain, was back in Elk Grove Tuesday night to get sign variations and special use approval from the village board to operate the 24-hour gas station and convenience store.

He said most Love's locations are located along highways -- like the one in Hampshire along the Jane Addams Tollway -- but now the company plans to expand into urban areas.

The Elk Grove location along Busse Road is heavily traveled by cars and trucks, which has local officials pleased for what the business could mean for sales tax revenues. They've estimated the gas pumps and in-store sales could generate millions in taxes in the first few years.

"That's a lot of trucks. That's a lot of potential business," said Mayor Craig Johnson. "Love's is picking up on that."

Bruner said the gas pumps will be open 24/7, and the convenience store will also offer those hours initially, though it may cut back on overnight hours depending on business. The store will have its standard coffee bar and hot dog rollers, but also offer branded fast food offerings: Chester's Chicken and Godfather's Pizza.

The location will employ as many as 40 full- and part-time workers.

WINTER WILDLIFE

The Environmental Health Division offers some basic tips for deterring wildlife that may seek refuge in our neighborhoods as weather gets colder. Below are suggestions to make your property less inviting.

- Do not feed wildlife as feeding sites can bring many different animals into the same area.
- Feed family pets indoors when possible. Do not leave food or water dishes outside overnight and clean up any spilled food.
- Secure garbage cans and close dumpster lids at night.
- Harvest or dispose of ripe food from vegetable plants in the garden or fruit trees in the yard.
- Stack firewood at least two feet above ground and away from buildings or fences.
- Reduce possible places for animals to hide in your yard by removing grass clippings, vegetation overgrowth, brush piles, or debris.
- Routinely inspect the exterior of your home to ensure there are no gaps in the structure or damage to the roof which would provide animals easy access to the home's interior.
- Install a motion-sensitive light to deter animals and provide an extra level of safety by making them more visible.

If you have determined wildlife is living on your property, the Environmental Health Division recommends working with a licensed wildlife removal company. For more information regarding specific laws pertaining to animal trapping reference the IDNR website at www.dnr.illinois.gov or call the Environmental Health Division at (847)357-4240 for a list of local wildlife control companies.

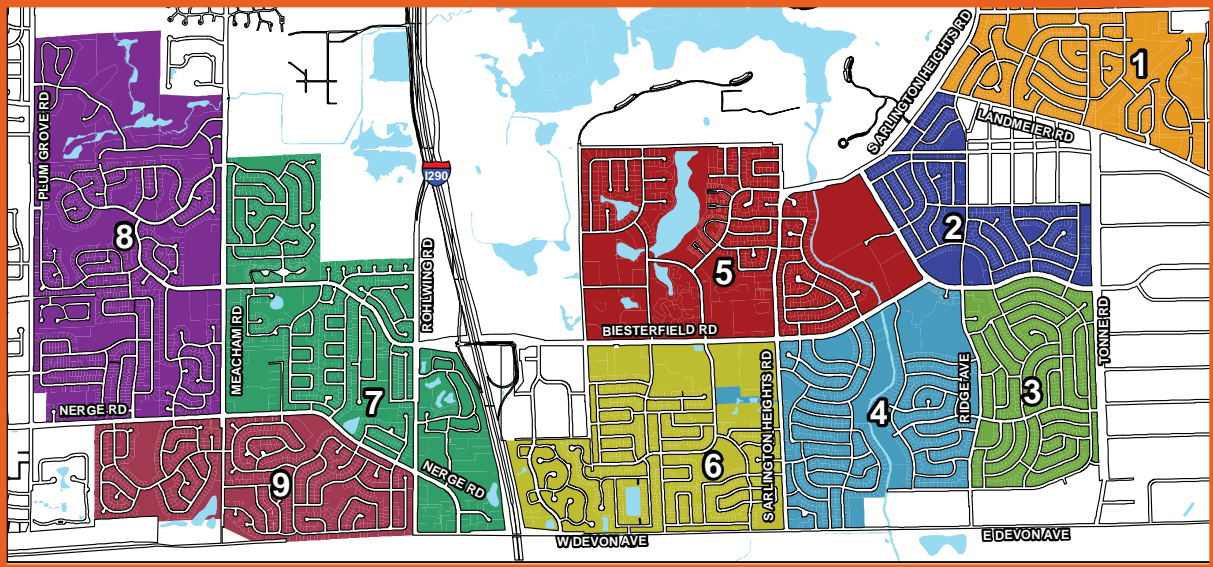
2019 FALL LEAF COLLECTION PROGRAM

During the months of October and November, the Village offers residents convenient disposal of their fall leaves through the Public Works Department. The Village is divided into sections, and each section receives four (4) leaf collection dates only two of which remain for the month of November. The scheduled collection dates and a map depicting the Village sections are shown below. If you bag your leaves, the normal rules for yard waste disposal will apply. Only paper yard waste bags or refuse cans may be used; no plastic bags will be accepted. One yard waste sticker is required for each bag or can.

THANKSGIVING COOKING SAFETY TIPS



It's hard to beat the speed of deep-frying a turkey—or the irresistible flavor and juiciness that result—but turkey fryers also have the potential to cause fire and serious injury. That is why organizations like Underwriters Laboratories and the National Fire Protection Association advise against using them. If you plan to deep-fry your holiday turkey, be sure you know how to safely use the fryer and take the following precautions to protect yourself, your guests and your home.

1. Keep outdoor fryers off decks, out of garages and a safe distance away from trees and other structures.
2. Make sure the turkey is thawed and dry before cooking. Ice or water that mixes into the hot oil can cause flare-ups.
3. Watch the weather. Never operate a fryer outdoors in the rain or snow.
4. Place the fryer on a level surface and avoid moving it once it's in use.
5. Leave two feet between the tank and the burner when using a propane-powered fryer.
6. Follow the manufacturer's instructions to avoid overfilling. Oil can ignite when it makes contact with the burner.
7. Choose a smaller turkey for frying. A bird that's 8 to 10 pounds is best; pass on turkeys over 12 pounds.
8. Never leave fryers unattended.
9. Purchase a fryer with temperature controls, and watch the oil temperature carefully. Cooking oil that is heated beyond its smoke point can catch fire. If you notice the oil is smoking, turn the fryer off.
10. Turn off the burner before lowering the turkey into the oil. Once the turkey is submerged, turn burner back on.

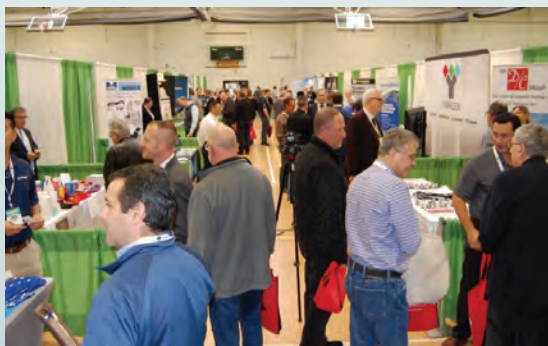

What is Stormwater?

The United States Environmental Protection Agency defines stormwater as a runoff generated when precipitation from rain and snow melt events flows over land or impervious surfaces and does not percolate into the ground. As the runoff flows over the land or impervious surfaces (paved streets, parking lots, and building rooftops), it accumulates debris, chemicals, sediment or other pollutants that could adversely affect water quality if the runoff is discharged untreated. The primary method to control stormwater discharges is the use of best management practices (BMPs).

Where does Stormwater go?

Would you go to the beach and dump a gallon of oil or paint in to the water? How about a shovel full of dog poop? Well if you dump waste oil, paint, pet waste into the storm drain by your home you are doing the same thing. What goes into the storm drain by your house goes directly into the local ponds and streams; it does not go to a treatment plant.

Call the Public Works Department for information on where to dispose of waste oil and paint, and clean up after your pet.

(The Prairie Lake School plans to operate a resale of food to families of the school as soon as the permit is approved.

(It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.

(A report from the Director of Finance, recommending approval, is attached.)

- b. Consideration of a request from Elk Grove Park District to waive permit fees in the amount of \$750.00 for partial storm sewer remediation at Hampshire Park, 1632-1635 Gibson Drive.

(It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.

(The Director of Community Development recommends approval.)

- c. Consideration to award a professional service contract to Ayers Associates Inc. of Madison, WI for aerial orthophotography and planimetric mapping updates as part of the GIS Consortium purchasing agreement in the amount of \$26,740 from the Water/Sewer Fund.

(Elk Grove Village has been a member of the GIS Consortium since 2008.

(The GIS Consortium (GISC) is a group of local communities that have worked together to develop a cost-effective solution for implementing geographic information systems (GIS)

and related technologies.

(One of those cost-effective solutions is to purchase aerial photography/mapping in bulk through the Consortium's 34 municipalities.

(The GIS Consortium Board of Directors appointed a Base Mapping Committee to initiate a selection process for a photogrammetric mapping consultant, and Ayers Associates was the selected vendor.

(As part of the pricing agreement, Ayers Associates uses economies of scale to provide their services at a reduced price.

(As part of this year's mapping program, Ayers Associates will produce updated aerial imagery of the Village and perform planimetric imagery updates within the Elk Grove Village community.

(The Assistant Village Manager recommends approval.)

- d. Consideration to award a purchase contract to Sentinel Technologies, Inc. of Downers Grove, IL to provide forty (40) replacement Cisco access points for an amount not to exceed \$27,653.

(Wireless access points are used for a variety of reasons at the Village Hall, Public Safety complex, and Fire Station 7.

(The access points serving these locations will be 10 years old next month. Since being purchased they've been surpassed by two generations of newer, faster access points.

(Replacing these access points with current, state-of-the-art technology will both increase employee productivity and eliminate the risk of older equipment failing.

(The IT staff requested quotes for new access points from three Cisco-certified vendors. Sentinel's price reflects the lowest of the three quotes received.

(The Director of Information Technology recommends approval.)

- e. Consideration to award a contract with Emeric Facilities Services of Waukegan, IL for the Cleaning and Custodial Services contract in the amount of \$38,741.76 from the General Fund.

(On Thursday, March 14, 2019, the Village opened sealed bids for Cleaning and Custodial Services at various Village facilities. Seven (7) contractors obtained bids and six (6) bids were submitted.

(This contract provides for routine cleaning services including the supply of products.

(The initial term of the contract is from May 1, 2019 through April 30, 2020, with the option of four (4) annual renewals in one-year increments through April 30, 2024.

(The lowest responsive and responsible bid was received from Emeric Facilities Services of Waukegan, IL in the amount \$38,741.76.

(Funds for the project have been allocated in the Public Works General Fund.

(The Director of Public Works recommends approval.)

- f. Consideration to award a purchase contract to Sentinel Technologies, Inc. of Downers Grove, IL to provide five (5) 48-port Cisco 9300 switches and associated licenses for an amount not to exceed \$41,619.

(Just over ten years ago the IT staff installed Cisco switches at key location points

throughout the Village to enable employees to work more efficiently and productively. Later this year these switches will reach the age where they're no longer be supported by Cisco.

(Two years ago the IT staff began staggering the replacement of our older Cisco switches in an effort to level out the expense associated with continuing to use vendor-supported equipment.

(IT staff requested quotes from three Cisco partners for the five (5) switches we currently require. Sentinel's price reflects the lowest of the three quotes received.

(The Director of Information Technology recommends approval.)

- g. Consideration to award a service contract through the U.S. Communities Government Purchasing Alliance with Cintas Corporation of Schaumburg, IL for the Uniform, Linen, and Floor Mat Services Contract in an amount not to exceed \$85,000.

(The Department of Public Works recommends awarding a service contract to Cintas Corporation of Schaumburg, IL for the Uniform, Linen and Floor Mate Services contract.

(The Uniform, Linen and Floor Mate Services contract pricing has been established by the U.S. Communities joint purchasing cooperative and offered from Cintas Corporation of Schaumburg, IL.

(The contract provides uniforms for Public Works Department staff and linen and floor mat services at the Charles J. Zettek Municipal Complex and two (2) Public Works Department facilities.

(Adequate funds are budgeted in the Public Works Department Budget.

(The Director of Public Works recommends approval.)

- h. Consideration to approve the third quarter financial report ending January 31, 2019.

(As part of the new financial software system, staff has created quarterly financial reports comparing year to date numbers to the prior year.

(The Director of Finance recommends approval.)

- i. Consideration to commit to the purchase of Bulk Rock Salt through the State of Illinois Joint Purchasing Contract in the amount of 4,000 tons for the FY 2019-2020 winter season.

(On October 23, 2018, the Village Board authorized the purchase of 2,400 tons of bulk rock salt through the Illinois Central Management Services (CMS) Joint Purchasing Program with the option to increase or decrease the order by twenty percent (20%), or 480 tons.

(This winter season the Village will purchase 2,880 tons of road salt, or one hundred twenty percent (120%) of the awarded amount.

(Illinois (CMS) is currently preparing bids for the FY 2019-20 Bulk Rock Salt Joint Purchasing Program.

(The Village intends to purchase 4,000 tons of Bulk Road Salt in FY 2020.

(The contract allows for the purchase of a minimum of eighty percent (80%) and a maximum of one hundred and twenty percent (120%) of the awarded amount.

(This purchase option provides flexibility in the event that snowfall totals were below average and provides sufficient quantity to ensure safe roadways during a severe winter.

(Adequate funds have been budgeted for this project in the FY 2020 budget.

(The Director of Public Works recommends approval.)

- j. Consideration to adopt Ordinance No. 3598 amending Title 8, Chapter 3, of the Village Code by adding thereto a new Section 8-3K-1: Penalties of the Building Activity Code of the Municipal Code of the Village of Elk Grove Village.

(This Ordinance amends recently adopted Ordinance 3597 to add Chapter 3K which was inadvertently omitted.

(The Director of Community Development recommends approval.)

- k. Consideration to adopt Resolution No. 16-19 determining the appropriateness for Class 6B status pursuant to the Cook County Real Property Classification Ordinance as amended July 27, 2018 for certain real estate located at 901 Chase Ave, Elk Grove Village, Illinois.

(The Law Offices of Liston & Tsantilis, on behalf of their client Duke Realty Limited Partnership, (Applicant) is seeking a Cook County Class 6B property tax exemption for property located at 901 Chase Ave.

(The Applicant intends to purchase the existing building and demolish it to construct a new Class A industrial building. The property currently consist of an 115,729 square foot building built in 1969.

(The Applicant will invest approximately \$21,449,405 to acquire the property and construct a 154,000 square foot Class A industrial building. Plans propose a building with thirty two foot ceilings, up to fifteen dock doors, two grade level drive in doors, and one hundred plus car parking with twenty five trailer parking spots.

(The eligibility requirements for 6B status are new construction, substantial renovation or buildings that have been vacant for a period of time.

(This site qualifies as it involves new construction.

(Property approved for Class 6B status allows the owner of the property to have the assessment level lowered for a period of twelve years. The assessment schedule is 10% of fair market value for ten years then 15% in the eleventh year and 20% in the twelfth year. Industrial property is currently assessed at 25% of fair market value in Cook County.

(Upon approval, the Director of Business Development and Marketing will issue a Letter of Receipt to the Applicant. The Letter of Receipt will allow the Applicant to file an application with Cook County. Final approval is at the discretion of the Village Board and contingent with the Applicant completing the improvements stated in their application.

(The Director of Business Development and Marketing recommends issuing a Letter of Receipt.)

- l. Consideration to adopt Resolution No. 17-19 determining the appropriateness for Class 6B status pursuant to the Cook County Real Property Classification Ordinance as amended July 27, 2018 for certain real estate located at 345 Scott Street, Elk Grove Village, Illinois.

(The Law Offices of Sarnoff & Baccash, on behalf of 345 Scott Street LLC (Applicant) is seeking a Cook County Class 6B property tax exemption for 345 Scott Street.

(The Applicant intends to purchase the property and rehabilitate the same for use by a related entity called Wookee Inc. Wookee will use the property for distribution, warehousing, and freight forwarding.

(The subject property consists of an approximately 65,336 square foot site with a roughly 15,000 square foot building. The building will be vacant prior to the purchase. (The

Applicant will invest approximately \$175,000 to rehabilitate the subject property. Improvements will include façade, landscaping, and signage. Additionally, the applicant will replace the parking lot drive and dock apron. Other improvements include fixing the parking lot, and office and warehouse remodeling.

(The Applicant will relocate their operation to the site from a currently leased space in Elk Grove. Wookee will relocate five jobs and create ten to fifteen jobs in the coming years.

(This site qualifies as it involves a purchase for value with occupancy of less than twenty four months with special circumstances and significant rehabilitation.

(The eligibility requirements for 6B status are new construction, substantial renovation or buildings that have been vacant for a period of time.

(This site qualifies as it involves vacancy for less twenty-four (24) months with a purchase for value, special circumstances, and significant rehabilitation.

(Property approved for Class 6B status allows the owner of the property to have the assessment level lowered for a period of twelve years. The assessment schedule is 10% of fair market value for ten years then 15% in the eleventh year and 20% in the twelfth year.

Industrial property is currently assessed at 25% of fair market value in Cook County.

(Upon approval, the Director of Business Development and Marketing will issue a Letter of Receipt to the Applicant. The Letter of Receipt will allow the Applicant to file an application with Cook County. Final approval is at the discretion of the Village Board and contingent with the Applicant completing the improvements stated in their application.

In compliance with the Americans with Disabilities Act and other applicable Federal and State laws, the meeting will be accessible to individuals with disabilities. NPDES

As an operator of a regulated small municipal separate storm sewer systems (MS4), we are required to obtain annual National Pollutant Discharge Elimination System (NPDES) permit coverage.

The goal of the program is to eliminate pollutants from entering storm sewer systems and depositing into our streams and creeks. Waterways in the Village include Salt Creek, Higgins Creek and tributary to Willow Creek.

As part of the NPDES permit process we complete and submit a report to the Illinois Environmental Protection Agency. The report outlines our efforts across six areas to help reduce and eliminate storm water pollutants. The six areas are:

- Public Education and Outreach
- Public Participation/Involvement
- Illicit Discharge Detection and Elimination
- Construction Site Runoff Control
- Post-Construction Runoff Control
- Pollution Prevention/Good Housekeeping for Municipal Operations

Some examples of last year's efforts include:

- Posting information in the Village newsletter & on the Village website
- Public service announcements airing on Channel 6
- Community involvement in the Salt Creek cleanup
- Routine illicit discharge checks of the Village storm sewer system
- EGV 2025 building design incorporated detention facilities to settle out pollutants
- Construction best management practices and site checks
- Street sweeping and storm sewer structure cleaning

The Village intends to file its next annual report in May.

Elk Grove Village: Storm Sewer Atlas

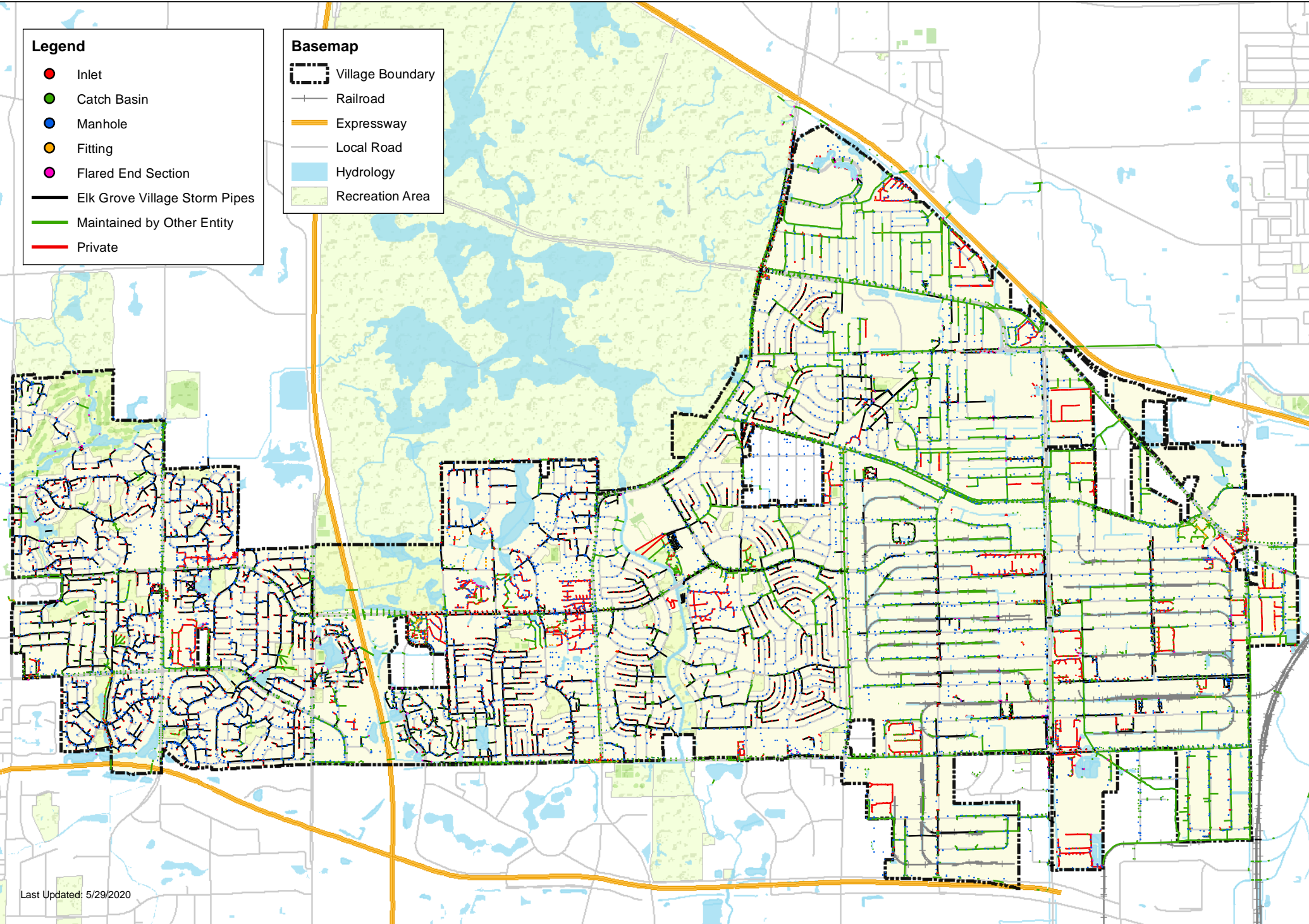


