4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – Merry Christmas, Happy Holidays and a very Happy and Healthy New Year. Even during this tough pandemic, building construction is up dramatically this year. Last year at this point the Village did approximately \$100 million in construction value and this year we are up to \$140 million. The business park is doing well.

Letters went out to inform the residents that the Village Board approved a second Coronavirus Relief package and the \$200 credit will appear on the water bills for January/February.

The holiday lights were turned on the day after Thanksgiving in the Village Green along with the grounds of the Park District Pavilion and the Library. It is nice to see so many families walking around during the warmer weather to enjoy the lights and take pictures by the new swing.

The Tax Levy is on tonight's Consent Agenda and this is the $14^{\rm th}$ year that we have not touched the General Fund. The General Fund Tax Levy increase comes from the pension side, which is mandated from the State of Illinois. Another agenda item is to authorize the Elk Grove Township to purchase salt from the Village.

The Village Board will also be accepting and approving the referendum questions that were voted on during the November General Election. The vote tally was about 76% to keep the yard waste stickers the way the program is currently set up, the vote tally to allow cannabis sales was about 64% and the vote tally to limit the number of video gaming locations was 68%. These were advisory or non-binding referendums to receive input from the public and the Village Board takes this information very seriously.

No action will be taken on the yard waste stickers program since that program will remain intact. Mayor Johnson recommended that the cannabis sales information be directed to the JPZ Committee, which is where ordinances and laws go for consideration. The JPZ Committee will look into the structure of an ordinance, if allowed, and will look at the pros and cons of cannabis sales in a community prior to bringing a recommendation back to the board as a whole. The JPZ Committee would be three votes, and then the Village Board will make a final decision as a whole. This will not be a quick decision and could take

anywhere from five to seven months to evaluate. As the Liquor and Gaming Commissioner, Mayor Johnson will bring some recommendations to the Village Board in the next month or two for the Board to consider several options for video gaming.

Mayor Johnson thanked the community for the outpouring of sympathy and condolences on the passing of his father, George Johnson. Mayor reflected on the memories of his father and the service he gave to the community as well as the recent passing of many renowned members that served the community.

Trustee Franke - No Report.

<u>Trustee Feichter</u> – The Community Character Coalition (CCC) partnered with the U.S. Marine Corps for the annual Toys for Tots Campaign. Drop off bins were located at the Village Hall, Library, Park District Pavilion and the Hattendorf Center. Thank you to all that contributed to help during these difficult times.

<u>Trustee Czarnik</u> – Attended the Northwest Suburban Municipal Joint Action Water Agency meeting on November 18. After 9 years, Kevin Lockhart will be retiring January 5, 2021 as the Executive Director of the Water Agency and Deputy Director Paul May will be promoted to Executive Director effective on Kevin's retirement. Village Manager Raymond Rummel will now serve as Chairman of the Executive Committee. Best wishes and good fortune to all.
