### ELK GROVE VILLAGE CELEBRATES COVID-19 VACCINE EFFORTS

On May 5, Elk Grove Village completed its second set of community vaccination clinics, which were hosted in partnership with Jewel-Osco and the Elk Grove Park District. Over the past two months, 4,000 community members received their vaccinations through these clinics.

The first clinics were targeted at the Village's senior population, and the second set were available to all residents ages 16 and up. Residents were notified a week in advance of each clinic and were able to make appointments up up

of each clinic, and were able to make appointments up until the day prior to each clinic through a temporary call center set up by the Village.

Elk Grove Village has also partnered with other communities in the Northwest Suburban Illinois Joint Emergency Management System (JEMS) to offer two sets of clinics providing approximately 7,000 vaccinations.

### MESSAGE FROM THE BOARD

After a year of many unprecedented events, we are truly delighted to see the community come alive again during this spring season with people dining, walking around town, and planning to attend special events once again.

As we eagerly anticipate a safe return to normalcy, our efforts have been focused on ensuring all residents who were interested in receiving a COVID-19 vaccine, were able to get one. Over 4,000 vaccine doses were provided to residents through two sets of community vaccination clinics hosted by Elk Grove Village. And our efforts did not stop there! The Fire Department, in partnership with Jewel-Osco Pharmacy, visited homebound residents to administer the vaccine.



### **DOCUMENT DESTRUCTION & ELECTRONICS RECYCLING EVENT**

Elk Grove Village, in conjunction with the Solid Waste Agency of Northern Cook County (SWANCC), is sponsoring a Document Destruction and Electronics Recycling Event on Saturday, June 5.

Saturday, June 5, 9:00 a.m. to 12:00 p.m.

There is no cost to attend, but residents must live in one of SWANCC's member communities to participate. IDs will be checked for proof of residency. Materials from businesses, institutions or schools will not be accepted.

#### To help keep the line moving, all participants are asked to follow these guidelines:

- IDs will be checked to verify residency.
- Residents will unlock/open the trunk from inside the vehicle and allow staff to unload the items.
- Paper documents should be contained in one area in the back of vehicle in paper bags or small boxes not in plastic bags! Boxes and bags will be returned to the resident.



**Paper:** Residents can bring up to three (3) file-sized boxes or paper bags of sensitive documents containing personal information, such as medical history forms, bank statements, personal files and retired tax forms. Paper documents will be shredded on site.

Plastic spines/covers and metal clips/binders MUST BE removed from all documents. **DO NOT** bring paper in plastic bags. **DO NOT** include photos, slides, negatives, books, store receipts, magazines, greeting cards or newspapers or any non-paper item.



Electronics: Please remove electronics from plastic packaging and boxes prior to the event.

<u>Acceptable Materials:</u> Cable Receivers, Cell Phones, Computer Cables, Computer Monitors, Computers (Desktop, Notebook, Tablet), Converter Boxes, Desktop Fax Machines and Printers, Keyboards, Mice, MP3 Players, Portable Digital Assistants (PDAs), Satellite Receivers, Scanners, Televisions, Video Game Consoles, Video Recorders/Players, Internal/External Hard Drives and Zip Drives.

### REAL ID DEADLINE EXTENDED TO MAY 3, 2023

Due to the pandemic, the federal REAL ID enforcement deadline has been extended to May 3, 2023. You only need to obtain a REAL ID if:

- You do not have a valid U.S. passport or passport card; AND
- You use airplanes as a mode of domestic transportation; or
- You visit military bases; or
- You visit secure federal facilities.

You do not need a REAL ID to drive, vote, open a bank account, apply for or receive federal benefits, enter a federal facility that does require identification, or visit a hospital. To learn more about the REAL ID, visit Realid.ilsos.gov.

The following items will be collected at this event:

- Motor Oil
- Anti-Freeze
- Paint or Stains (Latex, Acrylic, Water-based and Oil-based). Below are the restrictions for paint collection:
  - Must be in labeled, non-leaking cans or containers that are 5 gallons or less.
  - Dried up paint will not be accepted, but can be disposed of in your curbside waste bins.

If you do not see an item listed above, it will not be accepted at this event. Items such as adhesives, aerosol cans, cleaning products, pesticides, roofing compounds, sealers/sealants, solvents, and spray paint are household hazardous waste (HHW) items, and must be disposed of at an HHW facility. ### HELP PROTECT BASIC SERVICES IN OUR COMMUNITY

Elk Grove Village has joined 275 municipalities throughout the area in urging Springfield to restore local revenue payments. The Local Government Distributive Fund (LGDF) is generated from income taxes paid by local residents and businesses and collected by the State before it gets redistributed back to municipalities.

LGDF accounts for a sizeable portion of a town's operating budget – in some cases between 10 to 20 percent – which can amount to millions of dollars annually. LGDF funds essential services, such as police and fire, road repairs and maintenance, garbage collection and flood prevention.

The State promised 10 percent of total income tax collections to municipalities on a per capita basis through the fund in lieu of a local income tax. But in recent years, the State has reduced the LGDF share from 10 to 6.06 percent.

Now, Springfield is considering taking additional money from LGDF, which would make local governments even more reliant on property taxes when they are challenged to balance their own budgets and maintain essential services.

We encourage you to contact your State Senator and Representative and let them know that you: 1) oppose further LGDF cuts; and 2) support restoring LGDF payments to the full 10 percent level that had been promised.

Restoring LGDF dollars to our community will help relieve the property tax burden and help ensure that basic services remain in place moving forward.

### VILLAGE SUPPORTS WILDLIFE SAFETY WITH NEW CROSSING ACCOMMODATIONS FOR TURTLES NEAR BUSSE WOODS

On May 5, the Village completed a new turtle crossing area on Beisner Road between Gloucester and Winston Drive. Last fall, curbs in this area were depressed to reduce barriers for crossing turtles and the signs warning motorists of wildlife crossing were installed on May 5. This turtle crossing area was constructed to create a safe accommodation for migrating turtles based on a request from the Forest Preserve District of Cook County (FPDCC).

The Village's close proximity to one of the largest forest preserves in the region, means we live alongside various forms of wildlife. The Village is home to a large population of painted and snapping turtles that live in the marsh wetland area of Busse Woods west of Beisner Road.

For decades, the Cook County Forest Preserve has observed and received notices of turtles stuck on the side of Beisner Road struggling to get up and over the curb near Alexian Brothers Medical Center hospital and Village Point Church. Cook County Forest Preserve biologists recognized that these painted and snapping turtles follow a pattern every year in which they cross from the marsh on the west side of Beisner Road to the east side, where areas of low vegetation offer safe nesting locations.

Turtles migrate on an annual basis from April through October in search of water, food, mates, or nesting locations. Turtle crossings occur most frequently in June and July as the female turtle population search for safe nesting sites to lay eggs.

With their knowledge of migrating patterns, a representative of FPDCC approached the Village with a request to create an accommodation for the turtles. In response, the Village depressed curbs on Beisner Road between Gloucester Drive and Winston Drive in order to allow turtles to safely enter and exit the roadway. The new crossing signs were installed at the area with depressed curbs to notify motorists of potential turtle crossings.

#### COVID-19 Funeral Assistance

The Federal Emergency Management Agency (FEMA) is providing assistance for COVID-19 related funeral expenses incurred after January 20, 2020.

To be eligible for funeral assistance, you must meet these conditions:

- The death must have occurred in the United States, including the U.S. territories, and the District of Columbia.
- The death certificate must indicate the death was attributed to or caused by COVID-19.
- The applicant must be a U.S. citizen, non-citizen national or qualified alien who incurred funeral expenses after January 20, 2020.
- There is no requirement for the deceased person to have been a US citizen, non-citizen national or qualified alien.

To apply for this assistance, individuals can call FEMA's COVID-19 Funeral Assistance Helpline at 1-844-684-6333 from 9 a.m. to 9 p.m. ET, Monday - Friday and begin the application process.

### ANNOUNCEMENT OF PROPOSED WELLINGTON AVENUE AND LEICESTER ROAD CULVERT REPLACEMENTS

The Village is proposing the replacement of culverts that connect sections of Lake Cosman under Wellington Ave. and Leicester Rd. This project, anticipated to begin in the Spring of 2023, will consist of the complete replacement of the existing culverts. An illustration of the proposed design concept and mapped locations are shown below.





During construction, each street will be temporarily closed to vehicle and pedestrian traffic. Wellington Avenue will be completed and opened to traffic prior to the closure of Leicester Road. The tentative work and road closures are scheduled for Wellington Avenue from May 2023 through July 2023 and for Leicester Road from July 2023 through October 2023.

### HELP KEEP OUR STORMWATER CLEAN!

Stormwater is rainwater that runs off rooftops, lawns, driveways, and streets into our stormwater system. As the stormwater flows over surfaces, it picks up dirt, leaves, grass clippings, pesticides and fertilizers, oil, and other harmful contaminants. All of these pollutants are carried by stormwater into storm drains and ultimately into our creeks, rivers and in large bodies of water like Lake Michigan. However, there are a few simple ways that residents and businesses can all help reduce the amount of pollutants that enter our waterways:

- Do not dump motor oil, antifreeze, or other hazardous materials on the ground or into sewers. Recycling programs are available for these hazardous materials, and many service stations accept used motor oil for recycling.
- When cleaning your driveway, dock or parking lots, use a broom instead of water and dispose of debris in the trash (not in the street or storm sewer).
- Do not dump branches, leaves, or grass clippings along creek beds, in open ditches or in the street.
- Minimize the use of herbicides, pesticides, and fertilizers on your lawn. Plant native plants whenever feasible to lessen the need for herbicides.
- Pick up litter and place it into trash cans. This will prevent it from getting washed into the storm sewers and eventually into our waterways.
- Cover piles of dirt and wood mulch while doing landscaping projects, and sweep up debris (do not wash it into the street).

### RECEIVE A WATER BILL CREDIT THROUGH THE TREE WATERING PROGRAM

The Tree Watering Program is a voluntary program available to residents who had a parkway tree replaced during the previous year. For example, trees planted in the spring or fall of 2020 are eligible for the program. The program provides residents with a \$25 water bill credit in exchange for assisting the Public Works Department in watering a parkway tree that was planted in the fall or spring of the previous year. Public Works crews will place a tree bag on the parkway tree and then the participating resident will need to add water to the bag twice per week. This is roughly equivalent to 40 gallons of water over the course of the program. A \$25 credit will appear on a resident's water bill in September/October after the program has been completed.



By participating in the program, you can contribute to the health and growth of the urban forest and build a more sustainable community. ### 2021 Property Maintenance Inspection Program is Underway

Village Inspectors have begun conducting inspections to ensure properties are being maintained to Village code standards. Inspections will be conducted from the sidewalk, adjacent streets, or from the property itself where permission is granted. Do you want to make sure your property is up to code? Here is a list of some common issues!

- Address Numbers should be seen from the street; Arabic numerals or letters shall be 4 in. high x ½ in. wide
- Exterior Surfaces must be free of holes and rotting materials, properly painted, and water proofed
- Windows & Frames should be free of cracks or holes, in good condition, and weather-tight
- Roofs should not have missing shingles, signs of sagging, or any defect that would allow water to leak through
- Accessory Structures such as decks, sheds, detached garages, fences, porches, pools, and retaining walls must be structurally sound and in good condition
- Trees and Bushes cannot overhang the public sidewalk
- Driveways and Walkways must be kept in good condition with no severe cracks, deterioration, or settlement that might create a tripping hazard
- Brick Veneer must be structurally sound and have no missing bricks, mortar, or excessive cracks
- Right-Of-Way Obstructions are not permitted on your property with the exception of mailboxes




### VILLAGE BOARD APPROVES FISCAL YEAR 2022 BUDGET

Last month, Mayor and Village Board approved the Fiscal Year 2022 Budget in the total amount of \$170,445,820. The General Fund budget, which includes most of the Village's operational services (Fire, Police and Public Works), was approved at \$63,434,485. This represents a decrease of 1.59% from the previous fiscal year (with pension pass-throughs and transfers removed).

In 2020, Elk Grove Village experienced continued financial progress and stability through strong business development activity amidst a global pandemic.

The industrial vacancy rate closed out 2020 at 4.12%, which marks five consecutive years the Village has sustained a vacancy rate below 5%. As a result of this strong business climate, General Fund revenues have exceeded expenditures for the past several years. These surpluses were used in part to fund Coronavirus economic relief distributed to residents and businesses over the past year.



A trend of rising sales tax revenues heading into 2020 experienced a brief dip due to the effects of the pandemic, however, higher than anticipated receipts of building permit fees helped offset impacted revenues.

A record-setting \$339 million in private sector construction was permitted through the Village in Fiscal Year 2021. The continued development of the Elk Grove Technology Park—an 85 acre high tech industrial development contributed significantly to this feat. T5 has continued the buildout of their data center at 200 Innovation Drive, and Microsoft began 2021 by pulling the building permits for their first of three planned facilities on the west side of the Technology Park. Combined, Microsoft and T5 have invested nearly \$150 million in their buildings this past year, which does not account for the significant investment they will make in equipment on the interior of their facilities.

The *Elk Grove 2025* capital investment plan, a \$125 million program designed to ensure the community thrives for decades to come, is now in its fifth year. In the first four years of the program, the Village invested \$65 million in major capital projects, including major rehabilitation or construction of four Village facilities. The FY2022 adopted budget includes nearly \$16 million in EGV 2025 projects, most notably the rehabilitation of Arlington Heights Road from Newport Avenue to Brantwood Avenue that provides for a new bi-directional turn lane, as well as the construction of a new water tower in the Business Park.

This past year the Village responded swiftly to mitigate the effects of the Coronavirus by stepping into the frontlines of providing service and relief to our residents and businesses. A total of \$6.2 million in direct relief was provided to the community through two rounds of \$200 water credits and business license fee waivers. The Village was able to provide this relief because of strong fiscal management, and have planned for hard times. As the COVID-19 pandemic situation continues to evolve, the Village remains cautiously optimistic and is committed to maintaining exceptional standards, focused innovation, and a high level of fiscal responsibility.

While 2020 saw the cancelation of all special events due to the pandemic, social distancing requirements, and the prohibition of large scale events, we are planning, and have budgeted, for the return of our community events and public education outreach programs in 2021 and 2022.

The development of the Fiscal Year 2022 Budget was guided by the goals of delivering high quality customer-focused services to residents while offering a beyond business friendly approach to doing business in the Village. The budget serves as our road map to be the Exceptional Community.



### IDOT PROJECTS IMPACTING TRAFFIC ALONG BUSSE RD., HIGGINS RD., AND OAKTON ST.

During the next few months, two separate Illinois Department of Transportation (IDOT) projects will impact traffic along Busse Rd., Higgins Rd., and Oakton St. These two projects include intersection improvements to Busse Rd., Higgins Rd., and Oakton St. and the resurfacing of Busse Rd. from Higgins Rd. to Golf Rd.

### Higgins Rd., Busse Rd., and Oakton St. Intersection Improvements

The Illinois Department of Transportation will be making intersection improvements at Higgins Rd. and Oakton St., Higgins Rd. and Busse Rd., and further east at Higgins Rd. and Oakton St. The scope of this project includes restriping and minor widening to provide dual left turn lanes on all four legs of the Higgins Rd. and Busse Rd. intersection. The project will also include new signage and pavement markings to enhance continuity along Higgins Rd.,



traffic signal replacement, pedestrian and bicyclists accommodations, and drainage improvements. This project is anticipated to be completed by mid-November. The Illinois Department of Transportation has already completed the removal of medians and islands from the roadway and the placing of temporary pavement. Crews will continue work on the Higgins Rd., Busse Rd., and Oakton St. intersection improvements, and motorists should be aware that a new traffic pattern has been put in place to assist crews.

#### Busse Rd. Resurfacing

Additionally, the Illinois Department of Transportation has begun resurfacing a 1.7 mile stretch of Busse Road (Illinois 83) from Higgins Road (Illinois 72) in Elk Grove Village to Golf Road (Illinois 58) in Mount Prospect. This project will require daily intermittent lane closures, and access to residences and businesses within the work zone will be maintained throughout construction, which is expected to be completed in August.

During these projects, motorists can expect delays and should allow for extra travel time throughout the area. Drivers are urged to pay close attention to flaggers and signs in the work zones, obey the posted speed limits, and be on the alert for workers and equipment. #### MAY IS NATIONAL BICYCLE SAFETY MONTH

May is Bicycle Safety Month! With the increasing temperatures, more members of our community are getting outside to enjoy the weather and ride their bicycles. As the number of bicyclists increases, it's important to be mindful of them whether you are a driver, pedestrian, or even a fellow cyclist as they are among the most vulnerable people in and around the roadway. For safe cycling, bicyclists should always:



- Wear a properly-fitted helmet for safety that meets the Consumer Product Safety Commission (CPSC) standards. Visit the CPSC website at <u>cpsc.gov</u>.
- Obey the same traffic laws, signs and signals that apply to motorists. Illinois bicycle rules of the road can be found on the Illinois Secretary of State website at <u>cyberdriveillinois.com</u>.
- Ride in the same direction as other traffic, not against traffic.
- Be visible by wearing bright colors, reflective materials and lights on your bicycle, especially at night.
- Never ride distracted or impaired.

In addition, bicyclist must obey the following rules when riding on sidewalks, where permitted:

- When walking or riding your bicycle on a sidewalk or crosswalk, you must obey all pedestrian signs and signals.
- Bicyclists must yield the right of way to pedestrians on sidewalks or crosswalks.
- When approaching a pedestrian from behind, slow down and give an audible signal to alert of your presence before passing them. For more information on bicycle safety and rules, visit <u>cyberdriveillinois.com</u>.


Village Board meetings are generally held on the second and fourth Tuesday of the month at 7:00 p.m.

### 2021-2022 Vehicle Stickers for Businesses due June 1

Preprinted Vehicle Sticker renewal forms were mailed to all Village businesses in April ahead of the new vehicle sticker licensing period effective June 1, 2021. In our ongoing effort to deliver exceptional customer service, the Village provides a fillable Vehicle Sticker application form found at <a href="https://www.elkgrove.org/vehiclesticker">www.elkgrove.org/vehiclesticker</a>.

Businesses are encouraged to renew by mail or utilize the 24-hour drop box located at Village Hall.

Please see below for the vehicle sticker fee schedule:

Passenger Cars \$25.00

Trucks \$50.00 - \$155.00

Motorcycles \$20.00 - \$25.00



Stickers must be displayed in the lower right-hand corner of the windshield by June 1, 2021, for new vehicles there is a thirty day grace period. Vehicle stickers may be purchased in person at the Finance Department counter, Monday through Friday 8:00 a.m. until 5:00 p.m., and the first Saturday of every month (May – August) from 9:00 a.m. until noon, excluding holiday weekends.

### NEW BUSINESS LICENSING YEAR EFFECTIVE JUNE 1

A new licensing year is effective June 1, 2021, for businesses to renew licensing or register as a new applicant. Businesses conducting retail sales of any product or merchandise require a license. Other businesses requiring a business license include, but are not limited to; building contractors, day care centers and food caterers. In addition, all coin-operated devices must also display a valid 2021-2022 license.

New businesses may complete a fillable application on our website, <u>www.elkgrove.org/businesslicense</u>. Please note that a business may require more than one type of business license. A zoning application will also need to be completed for new businesses, contact the Community Development for more information. The annual fee for a business license covers the cost of making inspections necessary to safeguard public safety, health and welfare. Failure to obtain a license can result in fines of \$50 to \$500 per day.
