- **28.** PUBLIC COMMENT 7:30 PM Resident Helen Leski expressed concerns regarding a home in the Branigar Subdivision described as a disaster and a health hazard.

Mayor Johnson said that the Village is well aware of the house that she is referencing and the Village is also frustrated. The Village is working on a program that will come out in the next couple of months to address this type of issue for homes in Elk Grove. Since that house is in the Branigar Subdivision, we have contacted the county but do not have jurisdiction over those homes.

Helen Leski had another concern about the Post Office delivering her mail over a month late. Mayor Johnson said that the Village has no jurisdiction over the Post Office since it is under the Federal Government. Mayor recommended for the residents to reach out to Congressman Raja for assistance on any Post Office matters.

Helen Leski stated that she has one final problem with residents allowing their pets to urinate on her plants and flowers in her front yard. She asked if she can put up a sign that says "Keep Pets Off Property"?

Mayor said that the Village puts articles in the newsletters to remind pet owners to be respectful

to their neighbor's property.
