4. MAYOR & BOARD OF TRUSTEES' REPORT –

<u>Mayor Johnson</u> – *Click It or Ticket Program* - Mayor Johnson complimented the Police Department on the recent "Click It or Ticket" Memorial Day special traffic enforcement campaign. This campaign is funded with federal traffic safety funds administered by the Illinois Department of Transportation.

Business Park – The Village set a record during the pandemic of over \$4 million in permit fees but now just in the month of May of the new fiscal year, we had almost \$61 million in new buildings being built, almost \$700,000 in permit fees, and there were 345 permits issued.

Concerts Update - Loverboy had to cancel their June/July concerts in the U.S. due to the pandemic. The final line up for the Midsummer Classics Concert Series is July 4 – Daughtry at Rotary Green; July 13 - George Thorogood and The Destroyers on the Village Green, July 20 - War performing on the Village Green; and July 27 – The Beach Boys on the Village Green. Mayor Johnson announced that Paul Revere's Raiders will perform at the annual Tree Lighting Ceremony this year. (A video clip was presented of the bands.)

We look forward to getting the community back together.

Clearmont Bridge Grant – The state just awarded a \$1.7 million grant to the Village to be used

to rebuild the Clearmont Bridge by Salt Creek. The bridge cost is \$2.1 million and the Village pays 20% of the cost and the state pays 80%. We cannot thank our State Senator Laura Murphy and State Representative Marty Moylan enough for their help in obtaining this grant.

RotaryFest – RotaryFest is kicking off the summer events that begins tomorrow June 16 and runs through Sunday, June 20 over at Rotary Green.

Green Ribbon Campaign – Remember to bring the green ribbon from your parkway tree to the 4th of July concert before 7:00 p.m. There will be a table to return your ribbon for a chance to win a \$100 gift certificate to an Elk Grove Village restaurant. Mayor Johnson personally purchased ten (10) \$100 gift certificates that will be handed out at 7:15 p.m. before the concert. If you do not have the green ribbon, please bring another item that is green such as a piece of gift wrap ribbon or a piece of paper or string that can be turned in. You must be present to get your gift certificate.

Elk Grove Village Job Fair – As we are coming out of the pandemic, the businesses are having a difficult time getting employees back to work due to the elevated unemployment benefits. On September 6, the extended unemployment benefits will run out. Elk Grove Village is partnering with Elk Grove High School to host a Job Fair on Friday, July 30 from noon to 4:00 p.m. at Elk Grove High School. There will only be Elk Grove businesses at this Job Fair but anyone in the area can apply for work at an Elk Grove business. The Fair will include breakout sessions to help update resumes, provide interview tips, and if you sign up in advance you can receive a free lunch.

Check Presentation – 4Front is the owner of our cannabis cultivation center located on Greenleaf in Elk Grove Village. As part of the agreement, 4Front provides grant money to help with charitable groups and special events in Elk Grove Village. 4Front presented a \$75,000 check to Elk Grove Village and the Mayor announced that the money will be distributed as follows: Kenneth Young Center - \$15,000; Elk Grove Cares Program - \$15,000; DARE Program - \$15,000; and Special Events - \$30,000.
