## 4. MAYOR & BOARD OF TRUSTEES' REPORT -

Mayor Johnson – Met with the seniors at the Sheila Ray Adult Center on September 1 to discuss the new Groot waste pickup contract. Starting November 1, Groot will be the new waste hauler. All residents will get a new waste container and a new recycling container as part of the contract. You can select the size container that you would like (35 gallon, 65 gallon or 95 gallon). Residents will have a one-time chance at no cost to exchange their containers until December 31, 2021 if they decide they need a different size. We thank Waste Management for their service to the community but Groot was \$9,000,000 cheaper than Waste Management over an 8-year contract.

Mayor Johnson reinforced the importance of vaccinations. The Governor issued a mask mandate for all public places. The Village is not set up to host a booster clinic at this time.

Jackie Joyner-Kersee along with several other Olympians will be at the Run, Jump and Throw event scheduled for Sunday, October 10 at Elk Grove High School. Members of the USA Track and Field Team will be on the football field teaching foundational skills for children ages 7-12 who live or attend school in Elk Grove Village.

On Friday, November 5, there will be a second Job Fair at the Pavilion in Elk Grove Village. Networking will be from 9:30 a.m. - 11:00 a.m. and anyone preregistered will receive a free lunch between the hours of 11:30 a.m. and 1:30 p.m. The Job Fair will take place in the gymnasium from 11:00 a.m. to 3:00 p.m. There were 133 Elk Grove companies represented at the Job Fair on July 31 with over 500 people that attended looking for jobs.

Property tax bills are due October 1 and we are proud to say that Elk Grove Village again has the lowest combined property tax rate in all of northwest Cook County.

As a trend of the current times, Ridge Square will be converting their condominiums to apartments.

There were 356 participants in the Police Department survey. Of the 356 participants, 75% rated the Police Department as excellent, 76% rated the police officers as courteous and professional, and 84% rated the Police Department as approachable. Our Police Officers are CALEA certified and we back our blue 1,000% in Elk Grove Village.

Mayor thanked Chief Mikel and his department for coordinating the 20<sup>th</sup> Anniversary Remembrance Ceremony on 9/11.

Mayor Johnson discussed the Redevelopment Agreement with Prime Data Centers that is on the agenda. Prime is a huge data center developer and they chose Elk Grove Village as one of the first

locations in the Midwest area. They plan to build three buildings, three stories tall, and the square footage will range from 750,000 to 1,000,000. Elk Grove Village is the data center capital in the Midwest of the United States.

Renovations are underway by the Clock Tower in the Town Center. The trees planted twenty years ago grew very well but the roots are breaking up the concrete and brick pavers. Renovations will include updated landscaping and new ADA accessible walkways to be completed by the end of the year. The second phase of renovations will take place next spring at Memorial Park across from the Village Hall. The installation of a small parking lot for those visiting the Memorial Park and a new wall of plaques representing all the service branches - Coast Guard, Marines, Navy, Army, Air Force and Space Force along with water features is planned. The renovations will be paid from the Residential Enhancement Fund. We apologize to the Farmers Market for any inconvenience during the renovations.

The Fire & Police Commission conducted a test recently for Police Officer positions and there were 141 candidates that applied for the Elk Grove Police Department. Mayor Johnson and Police Chief Walsh called the following to the podium to be sworn in as Police Officers: Dominic Deangelis, Cody Phillips, Kyle Rudauskas, Nicholas Marzec, Rachel Martin, and Christine Lovecky. Officer Thomas Molloy and Officer Joshua Swoboda were recently promoted and sworn in this evening as Sergeants for the Elk Grove Police Department.

<u>Trustee Prochno</u> – The Farmers Market is open every Saturday morning in the Elk Grove Town Center parking lot from 8:00 a.m. to 1:00 p.m. through October. There is a variety of vendors and each week Cowboy Jack is always entertaining the children with some form of activity.

<u>Trustee Lissner</u> – The 9/11 Remembrance Ceremony was nicely done but it would have been nice to have Channel 6 air the ceremony. The remarks made by Mayor Johnson, the Police Chief, the Fire Chief and the Pastor from Prince of Peace United Methodist Church were very moving and made the event very special.

<u>Trustee Czarnik</u> – In agreement with Trustee Lissner, the 9/11 Ceremony was very touching and the dates of such tragic events will always be etched in our memories.

<u>Trustee Feichter</u> – The 20 year Remembrance Ceremony of 9/11 on Saturday was a very important and touching event. I agree that it would have been nice to have Channel 6 film the event. Everyone was touched by the comments and anyone that was alive at that time remembers it vividly.

The Community Character Coalition (CCC) are the Grand Marshals for the parade. The CCC, accompanied by students from Elk Grove High School, will be passing out flyers at the Jewel on October 23 for *Make a Difference Day*. The flyers will have a list of toiletry items desperately needed at the local food pantries for customers wanting to purchase an item while shopping.

<u>Trustee Franke</u> – Thank you Chiefs for coordinating the 9/11 Ceremony. Oktoberfest will be at Rotary Green on Friday, September 17, from 6:00 p.m. to 11:00 p.m. and Saturday, September 18, from 3:00 p.m. to 11:00 p.m. following the Hometown Parade. There will be good food, music and kids activities set up from 3:00 p.m. to 6:00 p.m.
