4. MAYOR & BOARD OF TRUSTEES' REPORT –

<u>Mayor Johnson</u> – On October 5, the Village purchased 3 pieces of art from the Juried Art Show to be added to our Local Artists Collection on the wall across from council chambers at Village Hall.

On October 21, Mayor Johnson taped a segment with EGTV on the Tree Lighting Ceremony. The Tree Lighting Ceremony will take place on November 26, starting with Paul Revere's Raiders at 4:30 p.m., followed by the tree lighting, fireworks and Santa at 5:30 p.m.

Mayor discussed the safety measures that Elk Grove Village has taken during the meetings throughout the pandemic and stressed the importance for everyone to get vaccinated. Since the majority of the community has been vaccinated and the numbers are low, effective immediately, Elk Grove Village is no longer enforcing the mask mandate. If you are uncomfortable, please wear a mask. If a business owner requests you to do so, it is their right and you must follow their request.

Job Fair - The second Job Fair will take place on Friday, November 5 at the Pavilion from 11:00 a.m. to 3:00 p.m.

A Wrestling Clinic will be held this Saturday, October 30, at Elk Grove High School for all Elk Grove and Conant High School wrestlers and their Feeder programs. There will be two (2) medalists from the Olympics at that event.

Building Activity – Elk Grove Village has an all-time low vacancy rate and the business park is humming. There is an increase in construction value from FY 2020 at \$80 million dollars vs. \$131 million through the end of September this year. Permit fees are also up from \$1.1 million in FY 2020 to \$1.7 million this year.

The Elk Grove Village Cares Program is available to those that are battling the disease of addiction. We are proud to announce that the EGV Cares Program received a \$102,000 grant from the State of Illinois. In the last 3 years, the program has received \$1.8 million from federal and state funds to help keep the program running.

National Prescription Drug Take Back Day – On October 23, 2021, the Village collected fiftynine (59) pounds of drugs during the National Prescription Drug Take Back Day.

Mayor Johnson announced that effective March 31, 2022, Ray Rummel will be retiring as Village Manager. Ray has over 32 years of service with the Village with 15 of those years serving as Village Manager. Mayor Johnson asked for Village Board concurrence to nominate Matthew Roan to replace Ray Rummel as Village Manager effective April 1, 2022. Matthew Roan has been Deputy Village Manager for the past 15 years and has worked at the Village for over 21 years.
