4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – The Village's 23rd Annual Tree Lighting Ceremony was on November 26. Mayor wished everyone a very Merry Christmas, a Happy Holiday, and a great New Year coming up in 2022 on behalf of the Village Board.

On Tuesday, December 7, Mayor Johnson attended the Community Character Coalition meeting where the Marine Corps was presented with all the toys that were collected throughout the Village for their annual Toys for Tots Program. The Police Department had a separate event entitled Stuff the Squad last Saturday at Walmart to collect additional toys for the Toys for Tots.

Dollar Tree is now open in the Town Center. They recently announced that they will be changing their pricing to \$1.25 for items due to inflation.

Cameras in the Village – There will be more cameras installed throughout the Village. They will not be speed cameras but will be LPR cameras (License Plate Readers) to provide assistance to the Police Department in the event of an emergency. If a Police Department is looking for a car with a certain license plate number, they will enter it into the system and the cameras will notify the local police departments that are in the system of the location of the vehicle. We will also install a few more 360°cameras for assistance with accidents and other emergencies at intersections.

Dr. Riggs' Building – Dr. Riggs was a long-time orthodontist here in the Village. He had an office building on Arlington Heights Road behind the Tapalpa shopping center. The building is in disrepair and the property was signed over to the Village at no cost. The building will be torn down soon to prepare it for future development.

Liquor Checks – In Elk Grove Village, everyone that purchases liquor is required to show a photo ID no matter what age. This law has been in place since 2000. There was an article in the paper that a nearby community did an ID check in 2019 and had 14 failures, and the last check they had 18 failures. The last time we had a failure for an ID check was once at the Fox Run Golf Course in 2019, and in 2013 there were 2 places that failed, Lou Malnati's and Sweet Baby Rays. This proves the ID checks work!

Elk Grove Village Cares – As of yesterday, the news reported that another record was set on addiction overdose deaths at over 100,000. Addiction has been rising. Please remember that Elk Grove Cares is here to help you and find treatment to get you on the path of recovery.

Arlington Heights and Higgins Road – The bowling alley and the shopping center have been on the market for a couple of years. Someone came in wanting to put a parking lot on the bowling alley property and another individual wanted to put up a storage facility there. This is not what the Village envisioned for the property at the entrance to Elk Gove Village. The Village decided to purchase both the bowling alley and the Elk Woods Shopping Center which also includes the Rose Garden Café and the BMO Harris Bank building but not the Shell gas station. The closing

will be at the end of the year. The price is \$10,700,000 for the shopping center and \$2 million for the bowling alley. The Village Board understands that there are some iconic businesses in that shopping center and we are looking to preserve those businesses. Early next year, the Village will put out a Request For Proposal (RFP) to developers to explain what we have, what we would like to see as a Board and the community - a type of mixed-use development. We want developers to bring their ideas to the Village. Strip shopping centers are becoming a thing of the past. We are not forcing anyone out of town.

Life Saving Award – Mayor Johnson and Chief Walsh presented Officer John Williams with his 4th Life Saving Award along with a uniform pin for administering CPR to save the life of an individual. Officer Williams has received Life Saving Awards as follows:

- 1. In 2013 Revived an unconscious individual in cardiac arrest by using AED equipment.
- 2. In 2019 Administered NARCAN to an individual having an opioid drug overdose to stabilize until paramedics arrived.
- 3. In 2020 Initiated chest compressions to resuscitate an unconscious person.
- 4. In 2021 Discovered an unconscious driver and resuscitated him prior to the arrival of paramedics.

Elk Grove Cares Program - Deputy Chief Dan Burke described the Elk Grove Cares Program and the expenses involved. The Village is always looking for grants to assist with funding and the state recently gave the Village a \$100,000 grant to assist with some of the expenses. JAS Freight, located on Devon Avenue, contacted the Police Department to inquire about donating to the Elk Grove Cares Program. As one of their philanthropy projects, JAS coordinated a bake sale and collected \$620 to contribute to the Elk Grove Cares Program.

Halloween House Decorating Contest Awards - Representatives from the Lions and Leos Club joined Mayor Johnson at the podium to present the Halloween House Decorating Contest Awards as follows:

The remaining winners were unable to attend the meeting and will be contacted to pick up their award at Village Hall.

Fire Department Unit Performance Award – Mayor Johnson, Chief Mikel and Deputy Chief Gac presented the Fire Department Unit Performance Awards to Lieutenant McEnery, Firefighter Petersen, Firefighter Porten, Firefighter Belpedio, Firefighter Jensen, Lieutenant Hollerbach, Firefighter Skowronski, and Firefighter Simpson. On Sunday, October 3, Elk Grove Village firefighters were dispatched to a house fire with a resident that was unable to exit the house on his own. The firefighters searched the home through heavy smoke and heat conditions along with low visibility and located the resident to remove him safely and extinguish the fire.

<u>Trustee Miller</u> – Thank you to all the Village departments for providing me with an orientation. The Academies are a great way to learn more about the departments. I attended the graduation of the Public Works academy on November 19 and they gave a survey to the graduates. The graduates could not say enough positive things about their experience. The Police and Fire will be doing an Academy in the spring, so if someone would like to know how great our departments are, that is one way to find out. The Public Works will also be having an open house the 3rd week in May.

On December 9th, I had the opportunity to attend the Beautiful Bulgaria exhibit at the Elk Grove Village Public Library with Chief Walsh. Trustee Feichter and Chief Walsh have traveled to Bulgaria in support of the Friendship Agreement that the Village has with the City of Pernik.

The winter Farmers Market is open the 1st and 3rd Saturday of the month at Christus Victor Church on Arlington Heights Road across from the movie theater. They will be closed January 1 for the New Year's Day holiday. On December 4th, the Market presented the Elk Grove Township Food Pantry with a check for \$5,000. With the Meijer's give back program, the store normally matches the donation but because of the amount, there is a chance that Meijer may double the amount to \$15,000. The Market also donated \$1,000 to the Christus Victor Food Pantry.

With snow arriving soon, please be good neighbors and remember to shovel your sidewalks. If you have neighbors that are elderly or handicapped, please help them to keep the sidewalks clear for those that are out walking their pets or walking for exercise.
