#### 4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – The next Coffee with the Board will be on Saturday, February 5, 2022 from 9:00 a.m. to 11:00 a.m. in Room E.

On January 20, Mayor met with Becky Baron to discuss her findings evaluating the Elk Grove Cares Program. Dr. Baron did her dissertation on the Elk Grove Cares Program and will report her findings to the public at a Committee of the Whole meeting on March 8, 2022.

Met with Dan Dougherty, the President of Alexian Brothers Medical Center, on January 13.

Mayor read an article featured in *Time Magazine* back in 2018 regarding the flu epidemic and explained how the same article could relate to the current situation of the coronavirus pandemic that we are experiencing today.

The Elk Grove Village vacancy rate is the lowest percentage rate in the history of the Village at 2.36%.

Mayor announced that if anyone has questions about anything that is going on in the Village to please feel free to call him at 847-437-8226 instead of reading false information on Facebook.

Mayor explained why the Village had to raise property taxes this year. The property tax was passed last December that would cost the average home in Elk Grove \$66 a year. We passed a \$5 a month water service fee, which we were the last town around to do so. Then we did a Nicor gas increase of \$2.50 per month so the total cost was \$156 a year. Mayor provided details on how the funds are determined to keep this Village operating successfully for the future.

Mayor stated that there is a new bike plan on the consent agenda this evening. Trustee Feichter, Dave Simmons and Mike Cavallini of Friends of Cycling in Elk Grove Village explained the future of biking in Elk Grove and thanked Representative Mussman, Senator Murphy & Commissioner Morrison for assisting with funds for the new bike plan.

CAPITAL IMPROVEMENTS COMMITTEE Trustee Schmidt The Capital Improvements Committee met on January 24 to discuss the 2022 roadway rehabilitation plan and the upcoming capital improvements project. Some of the funds from the tax increases will be going towards these projects. The projects for 2022 will consist of resurfacing 5.6 miles of residential streets in our community and 2.9 miles in the business park. Public Works had a Committee of the Whole meeting in 2021 to get approval to bring a company in that evaluated below the surface of all the streets in the Village. As a result, the streets were rated and 8.7 percent were in poor condition and 20.7 were in fair condition. These are the streets that are targeted for repair in 2022. Our streets are very well kept in Elk Grove Village compared to other communities. There are two other projects that are not part of that program. One project is resurfacing Biesterfield from the Village limits to Meacham Road, and the biggest project will be the reconstruction of Arlington Heights Road from Newport North to Brantwood. This will be a total reconstruction of Arlington Heights Road that will include left turn lanes down the middle of the roadway to alleviate the problems with cars travelling on the middle lanes northbound and southbound. This project will start in late spring and we hope to have it done by the end of November. Funding for this project is paid for primarily from Cook County. The cost is \$6 million and the Village is only paying \$800,000 for this project. With the relationship that the Village has with Cook County, Elk Grove Village will be overseeing the project. We ask the residents to please have patience while we work on these projects.
