4. MAYOR & BOARD OF TRUSTEES' REPORT

Mayor Johnson – There are currently only 7 COVID patients at Alexian Brothers Medical Center. Mayor discussed having mandates vs. laws and the future of COVID. Mayor stated that he is asking the Board tonight to direct the Village Attorney and Village Staff to put together a recommendation for a Village Health Department. Under our Home Rule Authority, which would give us the power to enact our own regulations when dealing with health issues through a legislative process. That will enable us to deal with health issues here in the Village. Mayor asked if there were any objections from the Board to move forward. No objections. This Village will always rule by the rule of law through a legislative process not by mandates.

- **9. ZONING BOARD OF APPEALS** Village Manager Rummel There are three items under the Zoning Board of Appeals for discussion tonight.
- a. ZBA Docket 22-1 Authorization of a petition submitted by Kaleb Jordan from Corgan, for a variation from the Elk Grove Village Zoning Ordinance as it pertains to permitted locations and heights of fences in industrial zoning districts for property located at 1925 Busse Road. (PH 2-10-2022)

Stream Data Center had a public hearing with the Zoning Board of Appeals regarding the installation of a security fence and screening for the property at 1925 Busse Road. There was a unanimous approval with a vote of 8-0 to GRANT the variation at 1925 Busse Road.

Motion to direct the Village Attorney to prepare the necessary documents for the variation at 1925 Busse Road.

b. ZBA Docket 22-2 - Authorization of a petition submitted by Taras Napora for a variation from the Elk Grove Village Zoning Ordinance as it pertains to permitted shed heights in residential areas for property located at 164 Willow Lane. (PH 2-10-2022)

The petitioner submitted a petition for a shed variation at 164 Willow Lane. The shed was permitted by the Building Department for a height of 12 feet but the shed was constructed with a height of 13 feet, 4 inches which necessitated a zoning variation. The Zoning Board heard the request for the variation at a hearing and the Zoning Board voted 5-3 to NOT GRANT the variation. The petitioner is in the audience as well as a neighbor who is objecting to the variation.

Mayor asked the petitioner to step up to the podium. Mayor asked the petitioner to confirm that he did apply for a permit but the Village had a maximum height as 12 feet. Petitioner responded yes. Mayor asked petitioner to confirm that after constructing the shed, that the height is 13 feet, 4 inches? The petitioner stated that the shed is actually 12 feet, 10 inches. Mayor stated that the Zoning Board reviewed and have declined this variation. Would you like to offer anything to the Board before we make our decision and vote?

Petitioner stated that he did not call for a final inspection because there was a complaint. If there was a final inspection the height would have been 12 feet, 8 inches. Mayor asked if the shed can be lowered. Petitioner stated that it can be lowered to 12 feet by removing the roof but he hasn't checked into the expenses to do that. Trustee Franke asked the Director of Community Development to confirm the height of the shed. Ms. Pye agreed that it is 12 feet, 10 inches.

Martha Urban, 170 Willow Lane, stepped up to the podium. Martha stated that she is the only one that is impacted the most with the height of the shed. She believes that ordinances are put in place for a reason and that the ordinances should be adhered to.

Motion to GRANT the variation with the shed height at 164 Willow Lane. MOTON FAILED due to a lack of a first and second – no vote was taken.

Motion to NOT GRANT the variation with the shed height at 164 Willow Lane.

Mayor stated that staff will come out to check on the height and the grading to see what can be done.

c. ZBA Docket 22-3 - Authorization of a petition submitted by Rafal Zalewski for a variation from the Elk Grove Village Zoning Ordinance as it pertains to permitted shed size in residential zoning districts for property located at 945 Wilshire. (PH 2-10-2022)

This item pertains to a shed constructed at 945 Wilshire Lane without a permit. The Zoning Code prohibits sheds in excess of one hundred fifty (150) square feet in area. The petitioner installed a three hundred (300) square foot shed containing one hundred (100) square feet of enclosed area and two hundred (200) square feet of partially enclosed area that will remain open on two (2) sides. The Zoning Board of Appeals reviewed the petition at a hearing and unanimously voted 8-0 to NOT GRANT the variation.

Petitioner Rafal Zalewski stepped up to the podium. Through an interpreter, Mr. Zalewski asked if the Village can please approve the shed because he put a lot of time and money to build it. Mayor asked why the petitioner didn't apply for a permit. The petitioner stated that since he had a shed in his yard that was old, he thought that he could just build a new one and remove the old one. Mayor said that the shed is double the size then allowed in the code. Mayor asked if the petitioner can take down part of the shed to bring it in compliance. Mayor confirmed that he can have 150 square feet for a shed.

Motion to DENY the request for the shed variation at 945 Wilshire Avenue. The petitioner has the opportunity to meet with a representative in the Engineering Department to find a way to make it within compliance. If not, the structure will need to be removed.
