4. MAYOR & BOARD OF TRUSTEES' REPORT -

<u>Mayor Johnson</u> – There was an open house at the Public Works locations on Saturday, May 14. Mayor complimented Director Colby Basham and his staff on how impressive the displays were and the cleanliness of the garages. Great job to the Public Works Department.

Trustee Sam Lissner will be the next Deputy Mayor for the Village of Elk Grove. Trustee Lissner has been a Trustee for 27 years.

The Volcan Agreement is on tonight's agenda. The property will be annexed into the Village and it is critical for the completion of the Prime Data Center that is going in at Busse and Oakton.

The Village received approval to tear down the Dr. Riggs office building on Arlington Heights Road near the Tapalpa Restaurant. Thank you to the neighbors for your patience during this transition.

The Elk Grove Cares Program is going into its 5th year treating people that are suffering with the disease of addiction. The program has helped 104 people to date. The Elk Grove Cares Program just received \$152,000 from the State, which is the the largest grant so far, to help fund this program.

There will be a Town Hall Meeting tomorrow evening, May 25, at 6:30 p.m. in Council Chambers. Everyone is invited to attend and ask questions about the Village. If you have a question and are unable to attend, you can submit questions through a link on our website. Questions need to be submitted by 12:00 p.m. on Wednesday. We have multiple conference rooms.

The Village is looking to expand our Green Initiative as part of the Recycling Program. Mayor mentioned several programs that the Village has in place to improve the Green Initiative and more improvements will continue in the future.

Trustees Feichter and Miller, along with David Miller from the Community Character Coalition joined the Mayor to announce the winners of the Fallen Soldier Memorial Scholarships.

The winners are: Alivia Sobon-Conant HS, Megan Steffens-EGHS, and Alexander Mayfield-Conant HS.

<u>Trustee Miller</u> – On May 21, the Elk Grove Presbyterian Church Clothing Closet had a clothing drive and they have done an amazing job creating the Clothing Closet that expands on the 2nd

floor of the church. Another clothing drive is planned for the Fall.
