## 6. CONSENT AGENDA

q. Consideration to award a professional service contract to Tasty Catering of Elk Grove Village, IL for food and drink sales at Oktoberfest in the amount of \$52,723.

(The Village held the 2022 Oktoberfest Celebration on Friday, September 16 and Saturday, September 17 at Rotary Green.

(The Village Board previously awarded a professional services contract to Tasty Catering on March 8, 2022, to provide equipment, event tents, lighting, stage, tables, and chairs for the event for an amount not to exceed \$35,300.80.

(Tasty Catering also provides professional services for this event to supply and manage sales of food and drink for the event.

(This contract covers food and drink sales, including the food service charge and actual costs for food and drink sold at the event.

(Event attendees purchase tickets to be used for food and drink at the event. The overall costs of the event will be partially offset by ticket revenue in the amount of \$50,766.60.)

r. Consideration to adopt Resolution No. 49-22 authorizing the Mayor to execute an agreement between the Village of Elk Grove Village and the Metropolitan Alliance of Police Elk Grove Village Police Chapter #141.

(The agreement will be available at the Village Board Meeting.)
