4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – We had our Parade a couple of weeks ago for Septemberfest and everything went very well.

Anyone that lives on the east side of 53 is in School District 59. School District 59 is considering major changes in the schools. Please be aware of what is going on and be involved with your schools.

Gift Cards – Thank you to the residents that are thanking us for the gift cards but this is your money that we are giving back. The Mayor spoke about how well the Village is doing and explained the reason for the gift cards.

The Village will have the 2^{nd} Town Hall Meeting on Thursday, October 13, at 7:00 p.m. in Council Chambers.

Many people have been talking about the new laws coming January 1. We all know that catalytic converter thefts are common in our area. Mayor stated that Arlington Heights recently had a theft where guns were on them and some of the suspects have had 20-30 prior arrests.

Chief Walsh has been in the papers recently due to the 40th Anniversary of the Tylenol Murders.

Mayor read a proclamation honoring the victims. The very first victim was an Elk Grove resident. There are now seals on all of the over the counter drugs and prescriptions due to this incident.

The Rose Garden Café is moving down to the Sweet Baby Ray's location. The Village bought the Sweet Baby Ray's location and worked out an exchange program that Rose Garden will work out of that location no later than April 1, 2023. Please save November 9th open to review all the submittals for the Arlington Higgins Shopping Center. Chris & Alex of Rose Garden and George did a great job redesigning Sweet Baby Ray's into the Rose Garden Café theme.

Migrant update – There are no more migrants that have come to Elk Grove. We spoke to the Governor's Office and we now have a point of contact with the state that can answer questions for us in a timely manner. The people on site will contact Marty at the Village to inform us what they need. Anybody that is interested in volunteering or would like to assist you can reach Marty Vela at 847-357-4120. We cannot take used clothes.

<u>Trustee Franke</u> – Oktoberfest was a huge success with the nice weather and everyone coming out after the parade. This event would not have gone off without the help of every one of the Village employees that participated.

<u>Trustee Miller</u> – It was my first Oktoberfest with my grandchildren and it was fun with the characters and bounce houses. I met some residents there that were extremely proud to live in Elk Grove Village.

<u>Trustee Feichter</u> – The next Villager newsletter was mailed and it is filled with a lot of information about activities in the Village.

On October 22, the Community Character Coalition will be asking for contributions at the Jewel to help restock the food pantry.

<u>Trustee Schmidt</u> – Attended the Open House on September 15 at the Northwest Central Dispatch to celebrate their 50 years in operation. Elk Grove was one of three communities that started the Central Dispatch System and now there are 12 agencies. They are the lifeline for our first responders.

<u>Trustee Lissner</u> – A few days ago I ran into a longtime Parade Committee member who said that this was the best parade since being on the committee. Thank you to Trustee Franke and staff on the Oktoberfest event.

<u>Trustee Prochno</u> – In reference to the Parade and Oktoberfest, I want to thank the CERT volunteers (Citizens Emergency Response Team) that have gone through quite a lot of training to be able to assist the Village in times of emergencies, help with traffic control or just providing an extra hand. They are a wonderful organization and if anyone is interested in joining, you can contact the Elk Grove Police Department.

The outdoor Farmers Market is open on Saturdays, from 8:00 a.m. to 1:00 p.m. on the Village Green through October 15 and they will finish off with their traditional Halloween Parade.

Revelation Golf is a non-for profit organization, that offers golf clinics for first responders and veterans. Last night was the last clinic and there were Police, Fire and Veterans participating.

It was the consensus of the Plan Commission by a 7-0 vote to recommend approval of the rezoning from B-2 to I-1.

PC Docket 22-8 - Consideration of a petition submitted by the Village of Elk Grove for a Resubdivision from one (1) lot to two (2) lots with associated variations from the Elk Grove Zoning Ordinance and a Special Use Permit to construct a cellular communications monopole in the I-1 Restricted Industrial District for property located at 2025 Tonne Road. (PH 09-19-22)

The Plan Commission met on September 19 to hear PC Docket 22-8 where the petitioner being the Village is seeking a Resubdivision and Special Use Permit to allow for the construction of cellular communications tower in the I-1 Restricted Industrial Zoning District for property located at 2025 Tonne Road. It was the consensus of the Plan Commission by a 7-0 vote to recommend approval of the petition of resubdivision of property at 2025 Tonne Road from one lot to two lots along with a special use permit the construction and operation of a cellular communications monopole at 2035 Tonne Road with variations as outlined in the finding of fact.

The Zoning Board of Appeals met on September 15 to hear ZBA Docket 22-11 with the petitioner seeking a variation to the Zoning Ordinance to allow for a variance to permit a six foot high fence between the front edge of the house and the rear edge of the house which will be located approximately seven feet from the property line where it will attach to an existing approved fence located approximately seven feet from the property line at 201 Parkchester Road. It was the consensus of the Zoning Board of Appeals by a 6-0 vote to Do Grant the requested variation.
