This form of municipal government combines the strong political leadership of elected officials, Mayor and Board of Trustees, with strong administrative experience of the Village Manager.

**Chief Executive Officer:**

The Mayor is elected at large for a four-year term.

**Legislative Body:**

There are six trustees that make up the Village Board elected at large for four-year overlapping terms.

**Village Clerk:**

The Village Clerk is an appointed official, custodian of the Village Seal, and the primary source for Village records. This office also handles voter registrations and Village elections.

**Chief Administrative Officer:**

The Village Manager is a professional administrator appointed by the Mayor and Board of Trustees to direct daily operations of the Village. The Village Manager is responsible for preparation and presentation of the budget and has full authority over all Village departments.

**MUNICIPAL SERVICES**

**Police**

The Elk Grove Village Police Department, in partnership with our community, is committed to ensuring public safety through innovative law enforcement practices, education and exceptional service, while performing with the highest level of integrity and ensuring all individuals dignity and respect. The Department is an internationally accredited law enforcement agency accredited by the Commission for Law Enforcement Agencies since 1993. The Department provides twenty-four hour a day response to emergencies and requests for service.

The Crime Prevention Unit is committed to establishing positive community relations through the development, implementation, and perpetuation of comprehensive proactive crime prevention programs. Crime Prevention Officers have received certified training in crime prevention techniques and methodology. Officers facilitate programs for senior citizens, elementary and middle school students and parents. Community programs allow the department to educate our residents on current, local, and national crime trends and present preventative measures to avoid victimization. Crime prevention officers have designed programs by fielding questions and listening to concerns of the numerous community groups we come in contact with throughout the year.

The Department manages a Community Emergency Response Team (CERT), which consists of over 100 volunteers that provide assistance to the first responders during emergencies and special events.

The Social Service Section provides assistance to residents and businesses of the Village who need support with the court system, community health systems, or human services concerns.

The Elk Grove Village Police Department is dedicated to operating a professional law enforcement agency, sensitive to the needs of the people it serves. The Department continues to be a leader in developing specialized programs to meet the needs of the community.

**Elk Grove Village Social Services/Community Services**

In partnership with local organizations, the social service department seeks to address the human and social service needs of our community.

The Social Service Department continues to promote a Drug Addiction Treatment Program called Elk Grove Village Cares, a recovery program for people dealing with substance abuse issues. To enter this free program, individuals only need to contact the Police Department information center and request admittance into the program. Social Services and Community Services receive the majority of referrals from officers when they come in contact with persons in crisis.

- ***Case Management and Advocacy:*** Social Services advocates for residents' needs and provides assistance to residents by coordinating services with other local and government agencies.
- ***Information and Referral:*** Residents are provided with information and referral to additional resources, which may be available to assist them.
- ***Food Pantry Assistance:*** Residents who are in need of food assistance can be enrolled in this program.
- ***Holiday Program Assistance:*** This program is for residents who have financial issues and need assistance. They can be part of this holiday program.
- ***Spring and Fall Yard Clean Up for Seniors:*** This senior program is initiated by Elk Grove High School in conjunction with the Elk Grove Village Community Services.
- ***Back to School Assistance Program:*** For residents who have financial issues and need assistance with school supplies.
- ***Crisis Intervention:*** Social Services responds to community crisis situations such as accidents, natural disasters and fires to provide crisis intervention. Follow up services are provided to residents when needed.
- ***Crisis Counseling:*** Social Services offers individuals, couples and family counseling to residents who are referred by the Police Department for limited time counseling services.
- ***Domestic Violence Intervention:*** Social Service is available to provide assistance to any resident who is a victim of domestic violence.
- ***Spanish Translation Services:*** A staff member is available for Spanish translation if needed.

### **Fire**

The Elk Grove Village Fire Department responded to just over 5,800 incidents in 2021, providing complete fire, rescue and emergency medical services to those who live, work, and travel within Elk Grove Village. In 2021, Emergency Medical calls accounted for slightly more than 72% of the annual incidents responded to by the Elk Grove Village Fire Department.

A total of eighty-three (83) personnel are currently assigned to fire, rescue and EMS operations, staffing three shifts. Shift personnel operate two Engine Companies (pumpers), two Quint trucks which serve as both an aerial ladder and pumping unit, one quick response

EMS Squad vehicle, three 24-hour Paramedic Ambulances, one part-time ambulance, and one Battalion Chief (shift commander) vehicle.

Fire Administration consists of a Fire Chief, Deputy Fire Chief, Training Battalion Chief and EMS Battalion Chief. An office staff of three (3) full-time civilian employees working together to meet the administrative needs of the Department in support of the diversified services offered.

The Inspectional Services Division conducts fire prevention inspections, oversees plan reviews, issues fire permits, and manages false fire alarms. The Fire Marshal oversees two (2) full-time inspectors, and a number of firefighters working off-shift as part-time inspectors.

The Public Education Team provides information on safety and fire prevention to schools, residents, and businesses. Classes include cardiopulmonary resuscitation (CPR), automatic external defibrillation (AED), and fire extinguisher training. Additional activities include station tours for school groups, participation in community events, and fire safety information for senior residents. The team organizes the annual Fire Prevention Week Open House, Citizens' Fire Academy, and Business Fire Academy.

Other Fire Department programs include coordination of quarterly blood drives and the medical sharps disposal program.

The Elk Grove Village Fire Department is accredited by the Commission on Fire Accreditation International (CFAI) and has obtained an Insurance Service Office (ISO) rating of Class 2, which ranks the Department in the upper 2% of Fire Departments nationwide.

### **Community Development**

The Department of Community Development is comprised of eighteen (18) authorized full-time employees, two (2) part-time employees and three (3) seasonal interns. Under the direction of the Director of Community Development, the Department is comprised of three (3) divisions: Engineering, Building, and Health

The Department of Community Development is responsible for the following ongoing activities:

- The review and inspection of any new, remodeled, or expanded buildings and structures for compliance with all ordinances, codes and regulations adopted by the Village.
- The review and inspection of public and private site improvements for compliance with all ordinances, codes and regulations adopted by the Village.

- The enforcement of all ordinances, codes and regulations of the Village relating to food sanitation programs, nuisance abatement, grass and weed abatement, garbage and refuse control, property maintenance and inspections of daycare and in-home day care establishments, restaurants, hotels and motels.
- All inspections to ensure compliance with building, zoning, land use, subdivision, Municipal Code, and property maintenance regulations.
- Assist with the maintenance of utility atlases, as-built construction drawings, and engineering drawings related to public and private improvements.
- Provide technical assistance and advice to Boards, Commissions and related agencies of the Village.
- Educate the public about the content and purpose of all relevant codes, ordinances and regulations.

**Engineering Division**

The Engineering Division provides a variety of technical and professional engineering services. These services include: review of civil engineering plans, storm water pollution prevention plans (SWPPP), storm water management reports and construction inspections for public and private improvements; enforcing ordinances, codes and regulations for site construction as well as drainage swales, sump pumps and other various code issues; miscellaneous administrative duties such as development and revision of Village ordinances and codes; and responding to technical inquiries, requests and/or concerns from residents, developers, contractors and design professionals.

**Building Division**

The Building Division is responsible for enforcing ordinances, codes and regulations relating to the construction, expansion, alteration and maintenance of public and private building improvements. Daily inspections are made to ensure compliance with building, zoning, land use, property maintenance, crime free housing and Municipal Code regulations. Enforcement of plumbing, electrical, mechanical and building codes are handled on a daily basis along with responding to technical inquiries, requests, and/or concerns from residents, developers, contractors and design professionals. The Division also performs miscellaneous administrative duties such as development and revision of Village ordinances and codes, redevelopment planning, and review of public hearing petitions.

**Environmental Health Division**

The Environmental Health Division is responsible for inspections and enforcement of codes relating to: food sanitation programs, nuisance abatement, grass and weed abatement, garbage and refuse control, day care and in-home day care establishments, restaurants and other food establishments, hotels/motels, property maintenance and responding to technical

inquiries, requests, and/or concerns from residents, developers, contractors and design professionals.

**Public Works**

The Public Works Department oversees the maintenance and construction of the Village's infrastructure including public streets, snow and ice control; urban forest; traffic signals and signage; streetlights; municipal fleet; water distribution; meter maintenance and customer services; wastewater collection; storm water drainage; and building maintenance for Village facilities. The Department is responsible for the development and implementation of capital improvement projects to the public infrastructure. It is divided into two (2) operation divisions, an engineering division and administration. The authorized department staff includes 61 full-time, 7 part-time, and 17 seasonal employees.

***General Operations Division***

The General Operations Division is involved in several activities within the Public Works Department including maintaining 137 miles of public right of way and its related infrastructure including Village owned trees, roadways, traffic signs, street lights, and managing snow & ice operations.

***Land & Forestry***

Responsibilities include maintaining the urban forest, which has earned the honor of Tree City USA for the last 37 years. The Village's urban forest includes over 15,000 parkway trees in the Village's residential areas, which require trimming/pruning, the removal of dead or hazardous trees and the addition of 500 plus trees planted annually. Additional Residential and Business Park beautification efforts include landscape maintenance for Village facilities, parkway restoration, mowing and landscape maintenance of over 300 sites throughout the Village, and maintaining the live roof at the Charles J. Zetteck Municipal Complex.

***Streets***

Streets manages the Village's annual leaf collection program, large-branch collection twice a year, various aspects of Village special events, maintenance of over 4,600 street signs, street sweeping, street patching and pothole repair, and street and traffic lights maintenance. One of the most important aspects of the Division is overseeing the Village's winter snow and ice control operations to help ensure both members of our community and visitors can safely travel throughout the Village.

***Utilities Division***

The Utilities Division is responsible for the water distribution, wastewater collection, and storm drainage systems providing essential services to utility customers. The Division also operates and maintains Village fountains and the Village splash-pad.

### ***Water Distribution***

A municipal owned public water supply serves the entire community. The distribution system consists of 181 miles of watermain, 2,190 fire hydrants and 1,973 mainline valves. Lake Michigan is the primary source of water of the 1.78 billion gallons of water used on average annually. The City of Chicago treats all the water at the Jardine water treatment plant located next to Navy Pier. The water they treat is entirely withdrawn from Lake Michigan. The City of Chicago distributes the water to the Northwest Suburban Municipal Joint Action Water Agency (NSMJAWA). NSMJAWA may add Chlorine if necessary but otherwise they do not perform any treatment. NSMJAWA serves Elk Grove Village and six other surrounding communities. Elk Grove Village receives the water at four different locations throughout the distribution system. The Village maintains an emergency back-up water supply consisting of six deep wells, and six interconnections with other public water systems. The backup wells have not been included in the distribution system since the Village started receiving Lake Michigan water in 1985. The Backup wells are tested monthly for water quality, meet all the EPA requirements and are available to supply water in the event the Lake Michigan water becomes unavailable for any reason. The Village uses two elevated water tanks and seven water pumping facilities with 9 million gallons of ground storage to meet the daily water demand throughout the water system. The system provides an average of 5 million gallons of water each day to approximately 12,200 customers.

### ***Wastewater Collection***

The municipal owned wastewater collection system serves the entire community and consists of 132 miles of sewer main, 3,415 manholes and fifteen Sanitary sewer pumping stations. The Village does not treat any wastewater. Wastewater is pumped to the Metropolitan Water Reclamation District in the Cook County portion of the Village and to the Village of Bensenville and City of Wood Dale in the DuPage County portions of the Village for wastewater treatment.

### ***Storm Water***

The municipal owned Storm water collection system serves the entire community and consists of 3,378 catch basins & inlets, 2,304 manholes and drainage ditches throughout the business park. The Village also maintains two storm water pumping facilities and the Busse Woods Hydraulic dam.

### ***Building Services***

Building Service manages Village Special events and maintains all municipal buildings including the Charles J. Zettek Municipal Complex, James Paul Petri Public Works Facility, Public Works Biestefield Facility, and three (3) fire stations.

### ***Engineering Division***

Engineering is responsible for the planning, designing and supervising construction of all public improvements to achieve the capital needs of the Village. This Division oversees the implementation of the Capital Improvement Plan through sound engineering practices. In addition to managing the Capital Improvement Plan and Municipal Utility Projects, this Division manages the Village's Roadway Rehabilitation, Residential Rear Yard Drainage, Village-Wide Concrete Rehabilitation, and Infrastructure Inspection Programs. The Division also pursues various federal and state grants to aid in the funding of these projects.

Additionally, the Engineering manages parts of the Business Leaders Forum Budget, which was created for the purpose of overseeing the revitalization and continued growth of the commercial and industrial community that makes up the Village's Business Park. To date, the Village has reinvested over \$75 million in Business Park infrastructure improvements to enhance the transportation network, storm water drainage and municipal utilities.

### **Business Development and Marketing:**

The goal of Business Development & Marketing is the retention and attraction of industry in the Village. The Business Park supplies approximately eighty percent of the Village's tax revenues; therefore, keeping the Business Park occupied and thriving is paramount for the continued growth and success of the Village.

The Economic Development Team is responsible for conducting outreach to the local business community, as well as recruiting new businesses to the Village, thus maintaining and enhancing the Village's diverse and robust business base. In 2021, the Village continued to promote its Beyond Business Friendly and Makers Wanted brand through marketing, networking, public relations, and business retention and attraction events.

In 2021, the Business Park continued to be the destination of choice in the Chicago region for industrial development. The Village's industrial vacancy rate at the end of 2021 was a historic low of 2.36%. A vacancy rate of 5% is considered essentially full when taking into account natural vacancies in the business cycle. As of July 2022, the vacancy rate is at an all-time low of 1.65%.

### **Highlights include:**

- ***Business Friendly Public Relations Campaign:*** Implement a dynamic brand awareness campaign that will positively position the Village as "The Most Business Friendly Community in America."
- ***Business Retention and Expansion:*** The Village enjoys a robust and diverse local economy. The retention and growth of the Village's exciting business community is the cornerstone of a sound economic development policy.

- ***New Business Attraction:*** Attract businesses in emerging and growing industries that will support and benefit from Elk Grove's strategic location, infrastructure, and resources.
- Elk Grove Village was named Municipality of the Year by the Illinois Industrial Real Estate Journal. A panel of judges from the real estate industry evaluated several municipalities based on the size and scope of significant development projects over the last year, key economic development accomplishments, and how the Village supports the business community.
- The Elk Grove Village Business Park was ranked as the number one Business Park in the United States by Business Facilities Magazine (BF). BF's ranking takes into account size, location to markets, growth potential, and recent expansions, as well as distinctive assets like water resources, utilities, residential developments, and amenities.

### **Select Commercial Development Projects:**

#### **Steiner Electric –**

On July 14, 2021 Village officials attended a ground-breaking for the new Steiner Electric expansion. Steiner, a long time tenant of Elk Grove Village, broke ground on an approximately \$10,915,000 development. Steiner owns two buildings in the Village located at 1100 and 1250 Touhy Avenue. They tore down the 1250 Touhy building, constructed a new building in its place and connected it to the 1100 Touhy building for a combined state-of-the-art facility. The new development continues to serve as Steiner Electric's corporate headquarters. Steiner distributes electrical supplies and they are in the top ten for sales tax production in Elk Grove Village.

#### **Elk Grove Technology Park Update –**

In the first quarter of 2021 Microsoft began construction of a \$123 million data center campus at the Elk Grove Technology Park. The 37-acre site in the Elk Grove Technology Park could eventually hold three data center buildings totaling 400,000 square feet, supporting Microsoft's Azure and other cloud services.

The Technology Park in total is almost completely full with high tech, foreign companies ranging from aerospace to magnet manufacturing! These tenants reinforce Elk Grove's standing as a focal point for high tech industrial development.

#### **Prime Data Centers to build 750,000 square foot, 150MW data center campus -**

Prime Data Centers is planning to build a new data center campus in Elk Grove Village. The company said it plans to invest around \$1 billion developing a 750,000 square foot, 150MW campus featuring two three-story facilities. This will be Prime's first data center in the state of Illinois and first development outside of California.

**EGTV**

**Finance**

The Finance Department receives all monies paid to the Village and makes all payments for expenditures incurred. The department oversees a current revised budget of \$225.64 million dollars to provide municipal services throughout the Village.

This Department is also responsible for issuing all business and vehicle licenses. The issuance of a license is conditional upon compliance with all Village ordinances. There are fifteen (15) full-time and one (1) part-time authorized personnel staffing the Finance Department.

Following is a brief guide to taxes that apply to purchases made by residents and businesses in Elk Grove Village. The Village overlaps two counties, Cook and DuPage, resulting in a different sales tax rate for each county.

- Qualifying Food, Drugs, and Medical Appliances:*** Qualifying food, drugs and medical appliances are taxed at a lower rate than general merchandise. This lower tax is applicable on non-prepared foods for consumption off premise. The total tax on qualifying food, drugs and medical appliances in Cook County is 2.25%. In DuPage County, this rate is 1.75%. For more information on the State of Illinois list of qualifying items eligible under this tax rate please visit, [www.revenue.state.il.us](http://www.revenue.state.il.us).
- Prepared Foods & Beverages:*** Restaurants, cafeterias, banquet facilities and bars assess an additional 1.00% tax on prepared food intended for immediate consumption on the premises and alcoholic beverages sold at retail either for consumption on the premises or sold in original packaging for consumption off the premises.
- Telecommunications Taxes:*** Telecommunications taxes apply toward the gross charges on both local and long distance telecommunications made by businesses and residences located within the Village. The term telecommunications includes: telephone, facsimile, paging and wireless service. The Village of Elk Grove Village charges a 6.00% Simplified Municipal Telecommunications Tax on all gross charges. The maximum allowed by state statute is 6.00%. The Village also charges \$.75 per line to help cover the cost for emergency 911 services.
