### 4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – We have sold 379 bricks from the Bowling Alley. Bricks are still available to anyone that would like to have a piece of history from the Village.

On 11/12, I attended a dedication at Morton Park in honor of past Park Commissioner Ralph Souder called Souder Point.

There may be a Diesel Fuel shortage but Public Works has more than enough Diesel fuel for this coming winter. Public Works also has plenty of salt for this winter.

Leaf collection will continue until the week after Thanksgiving unless there is a big snowstorm.

The second coat of asphalt will be placed on Arlington Heights Road next week. The sidewalks may get finished weather permitting.

Our Police Officers are all wearing body cameras, which is 3 years ahead of the state mandate.

There was an opening on the Zoning Board of Appeals and Mayor Johnson asked the Board of Trustees if he can appoint Scott Fowler to fill that position.

Motion to appoint Scott Fowler to the open position on the Zoning Board of Appeals.

Mr. Fowler will be sworn in at the December Village Board Meeting and the Zoning Board of Appeals is now full.

The 25<sup>th</sup> annual Tree Lighting Ceremony is a week from Friday, November 25, and the schedule is 4:30 p.m. New Colony Six will start with a concert, 5:30 p.m. we flip on the lights, and if Santa does not see the lights we have a huge fireworks display. Santa will have a special escort in the Makers Wanted Race Car and Santa will arrive in a Fire Truck.

This past Friday, Veterans Day, we had the chance to dedicate our new Veterans Memorial location at the corner of Biesterfield and Wellington. Thank you to everyone involved to make this a very nice dedication.

On the agenda tonight, we are passing a property tax reduction of 1.6%. The Village is doing very well and we were able to provide everyone with a \$200 gift card which is giving your money back to you. We are also putting a ½ million dollars this year into the Police and Fie Pension Fund. We are also increasing the amount of money for the Police and Fire Pension Funds for next year by a million dollars.

Stern Pinball is relocating their headquarters and consolidating operations here in Elk Grove Village. Stern Pinball is the largest pinball manufacturer in the world. They are relocating to the Prologis building at the corner of Busse and Landmeier. They will give tours and will sell to the public.

On Thursday, I stopped by Creative Works who also moved their headquarters and expanded in Elk Grove Village. They make things like the holiday candy canes that are filled with candy.

Last Wednesday, we had an Open House for the new development at Arlington Heights Road and Higgins. Over 270 residents came by to view the different options. After January 1, we hope to narrow it down to one developer and before we vote on anything, we will have another open house for the public to view again.

Thank you to Stephanie Byrne from Elk Grove High School who coordinates this event and the students gave our Veterans a standing ovation.
