Overnight Parking Restrictions Waived for the Holidays

Recycle Your Batteries at Village Hall



Did you know that lithium battery fires are a major concern in the solid waste and recycling industry? The composition of lithium batteries can cause them to explode if damaged or crushed, which may cause a fire to ignite. Properly disposing of batteries is critical in reducing the risk of fires.

Residents may drop off lithium or non-lithium batteries at the Community Development Department in Village Hall (901 Wellington Ave.) for proper disposal. The Community Development Department is open Monday through Friday, from 8:00 a.m. to 5:00 p.m.

Place your holiday tree on your curbside on your regular collection date.


Please do not put trees in plastic bags and make sure all decorations are removed.

Green Grove: Winter Anti-Icing Program



In 2020, the Public Works Department began using a biodegradable anti-icing liquid derived from refined sugar beet molasses on key roadways before a snow storm begins. Biodegradable means that something can be reabsorbed into the environment without causing pollution. Sugar enhances the performance of the rock salt that is used to prevent snow and ice from accumulating on roads. As a result, less salt is needed to remove snow and ice during winter road maintenance operations.

Excess salt on roadways can have corrosive effects on vehicles and roads over time and is harmful to waterways,

roadside plants, and wildlife. By using this anti-icing liquid on Village roads, the Public Works Department reduces the amount of rock salt needed, thereby protecting our infrastructure and environment.

New Smoke Alarm Regulations in Effect Jan. 1, 2023

Since 1988, smoke alarms have been required in all residential dwellings in Illinois, including single-family homes, multi-family homes, hotels, rental properties, dormitories, etc. In 2017, the Illinois Smoke Detector Act was revised to reflect advances in alarm technology. As part of that revision, effective January 1, 2023, any new smoke alarm being installed in a single or multifamily home must feature a 10-year sealed (non-removable) battery. A sealed battery alarm ensures that the power source cannot be removed from the unit and, if properly maintained, will last the life of the device.

Existing non-hardwired battery-powered smoke alarms must be replaced with a 10-year, sealed battery smoke alarm when it meets any of the following criteria:

- The unit is 10 years older than the date of manufacture (or there is no manufacture date on the device);
- The unit is no longer operational or fails to respond to operability tests; or
- A new device is being installed.

As a reminder, make sure to install smoke alarms on every level of your home, including the basement. There should be an alarm within 15 feet of every sleeping area and preferably inside all bedrooms. Choose installation locations away from the path of steam from bathrooms and cooking vapors from the kitchen, which can result in false or nuisance alarms. Smoke alarms should

be installed away from windows, doors, or ducts, where drafts might interfere with their

operation.

Working smoke alarms double your chance of survival and provide inexpensive protection for you and your family. Since most fatal home fires happen at night when you are asleep and are least able to respond quickly, early warning of a fire is critical. Make sure everyone in your household knows the sound of the smoke alarm and knows what to do if they hear the sound.

Elk Grove Village's Snow and Ice Control

Winter is here and the Village is ready to provide safe and clear streets

To help achieve our goal, please keep in mind the following:

Priority Plowing and Salting



During snow/icing events, Public Works crews focus on major streets first to provide access for emergency vehicles and heavier traffic, then begin working on all other streets. Crews will continue this process for the duration of the storm and come back to clean up side streets after the snowfall has ended.

Your Role in Clearing Snow

Snow removal equipment is designed to push snow onto the right-of-way which may result in snow being pushed onto driveway aprons, mailboxes, sidewalks, and hydrants. Residents and businesses are encouraged to clear:

- Driveway aprons and mailboxes Place the snow onto your property or the adjacent parkway;
- **Sidewalks** Place the snow onto your property as the Village does not provide this service;
- Hydrants Clear the snow and ice three feet around all sides of hydrants to provide access in the case of an emergency.

Keep in mind that shoveling, blowing, or plowing snow into the street creates hazardous driving conditions, negates the effort of our snowplowing operations, and is prohibited by law. Please be careful when moving heavy snow.

Winter Weather Parking Restrictions

Parking on all Village streets is prohibited when 2 or more inches of snow has fallen or is predicted to fall. Parking is also prohibited on both sides of the street for 24 hours after the snowfall stops or until the clearing operation is complete.

Drive Safely and Remember to Yield

Remember to drive cautiously and yield to snow removal equipment and emergency vehicles.

Arlington Heights Road Rehabilitation Update

We are thrilled to share that the Arlington Heights Road Rehabilitation Project has been substantially completed. We are fortunate to have the main stretch of roadway and sidewalks fully re-opened for motorists and pedestrians before the winter season. The project has yielded a widened sidewalk, improved ADA curb ramps, bi-directional turn lanes, and 1.2 miles of newly-paved roadway. The final touches will take place when the weather warms up next year.

Here's the work you can expect to see in the spring of 2023:

- Additional landscaping on the west parkway, including ornamental trees and grasses, shrubs, and perennial flowers will be added. Sod will also be placed in the parkway on the west side of Arlington Heights Road.
- New, dark red decorative stamped thermoplastic will be placed at the Biesterfield Road intersection, as well as the side streets off of Arlington Heights Road, along the project area.
- The medians that are currently asphalted will also be receiving the same dark red decorative stamped thermoplastic upgrades as the crosswalks.
- Sidewalk replacement on the west side of Arlington Heights Road, from Boardwalk Street to Brantwood Avenue will be completed.
- A parapet railing will be installed on the top of the retaining wall located on the southeast corner of the intersection of Arlington Heights Road and John F. Kennedy Boulevard.



The project was substantially completed in November, even while construction across the Chicagoland area faced numerous challenges in the past year. This past summer, several setbacks occurred outside the Village's control, with the biggest impact being the strike by workers at local quarries, which created a shortage of sand, gravel, and crushed stone. Without these raw materials, concrete and asphalt were not being produced from those aggregates for a majority of the summer season. Additionally, a cement shortage in September limited and delayed production on items that directly affected the project's finish date.

Despite these challenges, we are pleased that the project was nearly completed this year, and we look forward to the finishing touches in the spring.

Winter Months are a Prime Time for Warm-Up Thefts

Warm-up theft occurs when thieves steal cars that have been left running to warm up while unlocked and unattended — it is an open invitation for thieves! If you must warm up your car unattended, use a remote starter or lock your vehicle and use a spare key.

It only takes a few seconds for a thief to strike anywhere, including residential areas, private driveways, convenience stores, or gas stations.

Never leave your car running while unlocked and unattended. Make sure you lock up your car and take your keys anytime, anywhere! ■

Fares for a one-way trip are \$1.30 per person, with a discounted fare of \$0.65 for senior citizens (ages 65 or older) and disabled residents.

Home Winterization Tips

Now that winter weather is upon is, it is important to protect the interior and exterior of your property. The following tips can help you prepare your home for the winter season:

Prevent Freezing Pipes:

- Seal or caulk any cracks that might let cold air in, especially places where pipes run from the inside to the outside of your home, such as dryer vents or water pipes.
- Disconnect all garden hoses and check that any outdoor faucets with shutoff valves are drained and closed.

Fireplace Maintenance

- Remove soot, debris, and/or leaves from the chimney and the firebox before igniting.
- Check the flue damper to make sure it opens and closes properly.
- Only burn seasoned firewood or gas logs per manufacturer's regulations.
- Consult with a licensed chimney sweep or fireplace service technician for repair or maintenance.

Furnace Maintenance

- Change the air filter regularly to keep your furnace running efficiently.
- Consult with an HVAC professional annually to test and service your furnace to ensure it is functioning properly.



Door-to-Door Solicitors

All persons seeking to solicit within the Village, other than religious or political organizations that are protected under the First Amendment, are required to apply for a Certificate of Registration within the Village. This does not include people who are exclusively distributing fliers. Although the Village registers solicitors, it does not endorse or support the company or product being solicited.

Village Ordinance requires the individual to apply within the Village Clerk's Office prior to doing any door-to-door business in the Village. The Village reviews the application and conducts a background check for each individual. Upon approval, the applicant is issued a Solicitor Identification Card, which must be visibly displayed at all times while soliciting in the Village. Identification cards include a photo of the solicitor, their name and permit expiration date. Uninvited solicitors or suspicious individuals



who cannot provide proof of solicitor registration should be reported immediately by calling 9-1-1. Current solicitors can be viewed on the Village website.

No solicitor, whether registered with the Village or not, is permitted to engage in soliciting prior to 9:00 a.m. or after 8:00 p.m. Monday through Saturday. Soliciting is not permitted on Sundays or on state or national holidays. ■
