4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> — On behalf of the Village Board and staff at the Village of Elk Grove Village, we wish you a very Merry Christmas, a Happy Holiday and a Happy New Year. A lot has happened in the past few years but we have come through stronger and better.

The Tree Lighting Ceremony on November 25 had a record crowd. People waited an hour and a half to see Santa. Thank you to Public Works for the new Sled and the reindeer. We changed it slightly to make the event flow better with the hot chocolate and hot cider. The racecar led Santa the way to the Tree Lighting. It was a great night and we thank everyone for attending.

The Arlington Heights Road project is done and everything went very well. The sidewalk north of Brantwood Avenue will still be replaced. We do have sidewalks on both sides for the winter.

Kudos to the Public Works Department for a great job with the Leaf pickup program.

The Property Tax Levy is on the Consent Agenda tonight. The Village is cutting our property taxes next year because the Village is doing very well. The Village gave \$9 million back to the Village residents during COVID to help the community with water bill credits and gift cards.

A Dedication for the new Veterans Memorial Park held on Veterans Day went well. The Veterans of Foreign Wars Post 9284 sent a letter to thank the Village Board for the most memorable Veterans Day.

- a. PC Docket 22-9 Consideration of a petition from Elk Grove Village seeking for a Text Amendment to the Elk Grove Zoning Ordinance Section 7E-6 Prohibited Uses In All Industrial Districts by deleting the residential accessory facilities associated with a permitted primary use.

The Plan Commission met to consider the petition of PC Docket 22-9 on November 7. The Village of Elk Grove is the petitioner seeking for a Text Amendment of the Elk Grove Ordinance Section 7E-6 Prohibited Use In All Industrial Districts by deleting the residential accessory facilities associated with a permitted primary use. It was the consensus of the Plan Commission by an 8-0 vote to recommend approval of the Text Amendment to the Zoning Ordinance.

b. PC Docket 22-10 - Consideration of a petition submitted by Elk Grove Village for a Text Amendment to remove and replace Elk Grove Zoning Ordinance Section 5-5- Location of Planned Development, and to remove and replace Elk Grove Zoning Ordinance Section 5-2 Procedure, Subsection E.

On November 7, the Plan Commission met again for PC Docket 22-10 with the Village again acting as the petitioner seeking a Text Amendment of the Zoning Ordinance to remove and replace Section 5-5 Location of Planned Development to allow planned development as an authorized Special Use in all Zoning Districts listed in Chapter 7. To remove and replace Section 5-2 Procedure, Subsection E. It was the consensus of the Plan Commission by a vote of 8-0 to recommend approval of the Text Amendment to the Zoning Ordinances.

Motion to direct the Village Attorney to prepare the necessary documents for the Text Amendment to Section 5-5 and Section 5-2.

c. PC Docket 22-11 - Consideration of a Petition for a one-lot Resubdivision and associated variations for the properties at 2001, 2045, and 2111 Pratt Boulevard. (PH 12-05-22)

On December 5, the Plan Commission met to hear PC Docket 22-11 with the petitioner seeking a Resubdivision of properties at 2001, 2045 and 2111 Pratt Boulevard from two lots to two reconfigured lots in an I-2 Zoning District. The variations are as follows: Section 3-7:D 2 to allow the fuel island canopy to encroach into the required side yard; and Section 7-1 to allow the principal building size to be less than 25% of the overall property area. It was the consensus of the Plan Commission by a 7-0 vote to approve the Subdivision with variations as outlined in the Finding of Fact.

Motion to direct the Village Attorney to prepare the necessary documents for the resubdivision for property at 2001, 2045 and 2111 Pratt Boulevard.
