#### 6. CONSENT AGENDA

1. Consideration to award a professional services contract to The Deigan Group of Lake Bluff, IL for the preparation of soil remediation bid documents and remediation contractor oversight in an amount not to exceed \$27,800 from the Arlington-Higgins TIF.

(The Village recently acquired the former Shell Gas Station property at 1 E. Higgins Road.

(As part of the acquisition, the Village worked with the Deigan Group to facilitate the removal of the two (2) existing fuel storage tanks. During the removal, the Office of the State Fire Marshall identified the presence of petroleum beneath the dispenser piping system requiring the creation of a new Leaking Underground Storage Tank (LUST) Incident.

(As part of this contract, the Deigan Group will formulate bid documents and oversee the remediation to clear the property of the current LUST Incident, as well as previous IEPA requirements for past incidents.

(The Deigan Group has recently overseen the environmental remediation, contractor oversight and documentation of the former Elk Grove Hotel, Motel 6, Phoenix Nightclub, 1550 E. Higgins, and Elk Grove Bowl properties.

(The Village Manager recommends approval.)

In compliance with the Americans with Disabilities Act and other applicable Federal and State laws, the meeting will be accessible to individuals with disabilities. The deigan group (Deigan) is pleased to propose the following scope of work, fees, schedule and terms for conducting post-tank removal follow-up work at the above-referenced property in Elk Grove Village, Illinois. Two Shell Station USTs were removed under IL OSFM supervision on November 29-30, 2022. The OSFM required that a new LUST Incident 22-1059 be created due to the presence of petroleum release beneath the dispenser piping systems. The following scope of follow-up environmental work is proposed to prepare the site for redevelopment consistent with the Master Plan.
