There was a nice turnout at the February 4 Coffee with the Board. We thank everyone that attended.

The Cemetery was mentioned at the last meeting. We are not looking to change the ownership. The owner does a great job with the cemetery. We are actually looking to annex the cemetery into Elk Grove Village. The Journal had a nice article in the paper.

On February 28, we will announce an event for our 5th Anniversary of the Elk Grove Cares Program. The program has continued to operate with the help of grants.

The vacancy rate for the Business Park in 2010 was 12.5% and in 2022 the rate is all the way down to 1.5%. This is an all-time record low vacancy rate for Elk Grove Village.
