4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – Last Tuesday, March 21, we had our Budget Workshop. The Board will be approving approximately a \$187 million dollar budget. The Village is in great shape.

On Thursday, we met with Daryl Pass from Kenneth Young Center to discuss the 5th Anniversary of the Elk Grove Cares Program on June 4. At 3:00 p.m., there will be a Car Show with entertainment by Tony Ocean, at 6:00 p.m. The Grass Roots will be performing and from 4-7:30 p.m., we will have food trucks lined up by the Library entrance. We have a strong partnership with the Kenneth Young Center and the Elk Grove Cares Program.

On Thursday, April 13 at 6:00 p.m., there will be an Open House at the Pavilion for residents to view the updated plans for the Arlington Heights Road and Higgins Development. The first hour will be for viewing and at 7:00 p.m., there will be an open discussion to answer questions. If things change, we will let the public know as soon as possible.

At 11:30 a.m., the same day at the Belvedere, Mayor will be giving the State of the Village Address to the businesses. We hope to have the renderings for that meeting as well on the same day.

You have until noon Monday any questions or comments you have about the Development. The next step, the project will go before the Plan Commission and work can start as early as this Fall.

There is an Ordinance on the agenda, No. 3804, on the prohibition of the sale of Delta 8 and THC products in licensed Tobacco Dealer establishments. We started doing investigations after we have had numerous complaints of underage people purchasing gummies from establishments in the Village and then selling to other students.

Police Officer Mosqueda, School Resource Officer at Elk Grove High School and Deputy Chief Torres spoke about the problem increasing in the Junior High level. We hope that other suburbs will follow suit. The ordinance will be effective 10 days after today, if approved. We will notify tobacco establishments of the new Village Ordinance so they are aware that they cannot sell those products in Elk Grove Village.

<u>Trustee Prochno</u> – The Winter Farmers Market is still going on every other Saturday. There is a Market this coming Saturday, April 1 from 8:00 a.m. to 1:00 p.m. at the Christus Victor Church on Arlington Heights Road.

The committee will provide eight (8) \$1,000 scholarships this year to high school seniors that live in Elk Grove Village. The deadline for the applications is May 5.
