 - (It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.
 - (The Director of Community Development recommends approval.)
- b. Consideration of the following requests from the Little Bulgarian School for a Bulgarian / Cyrillic Alphabet Celebration to be held at Rotary Green on May 21, 2023 from 12:00 p.m. to 6:30 p.m.:
 - A fee waiver for a temporary Class D liquor license (\$2,100);
 - A fee waiver for a parade license (\$50);
 - A fee waiver for a general retail license (\$35); and

(The Little Bulgarian School and Bulldogs LTD will be hosting a cultural event on May

21, 2023.

(The Village is partnering on this event celebrating Bulgarian culture in honor of our official Friendship Agreement with Pernik, Bulgaria.

(The Assistant Village Manager recommends approval.)

c. Consideration of a request from the Elk Grove Park District to waive permit fees for a roof replacement project at 140 Lively Boulevard in the amount of \$4,980.

(It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.

(The Director of Community Development recommends approval.)

d. Consideration to authorize payment for FY 2023-2024 membership dues to the Northwest Municipal Conference (NWMC) in the amount of \$16,734.12.

(The membership dues rate to the Northwest Municipal Conference is based on population and is assessed at a per capita rate of \$0.51.

(This is the same rate from the previous year's dues.)

e. Consideration to renew a contract with Trees "R" Us, Inc. of Wauconda, IL for routine and emergency tree removal services contract in the amount of \$27,160.53 from the General Fund.

(On June 21, 2021, the Public Works Department opened proposals for the routine and emergency tree removal services contract.

(Trees "R" Us, Inc. of Wauconda, IL, submitted the lowest proposal.

(The contract provided for an option of four (4) additional renewals through January 31, 2027.

(Trees "R" Us, Inc. has performed satisfactorily throughout the first year of the contract.

(The contract period is from May 1, 2023 through April 30, 2024.

(The contract amount reflects a 5% increase over the previous year's contract.

(Funds for the contract have been allocated in the General Fund.

(The Director of Public Works recommends approval.)

f. Consideration to award a construction contract to the lowest responsive and responsible bidder Fowler Enterprises LLC of Elgin, IL for demolition and site restoration at 1800 Oakton Street in an amount not to exceed \$48,150.

(On Friday, April 28, 2023, the Village opened sealed bids for the Demolition and Site Restoration Project located at 1800 Oakton Street.

(Nine (9) contractors obtained bid documents and three (3) bids were submitted.

(The lowest responsive and responsible bid was received by Fowler Enterprises LLC of Elgin, IL in the amount of \$48,150.

(Adequate funds are available in the Busse-Elmhurst Redevelopment Fund.

(The Director of Community Development recommends approval.)

g. Consideration to renew a contract with Temple Outdoor Decor of Oswego, IL for the Holiday Lighting and Decoration Services contract in the amount of \$55,574 from the General Fund.

(On August 16, 2022, the Village Board awarded a contract with Temple Outdoor Decor of Oswego, IL, for the Holiday Lighting and Decoration Services.

(The contract provided for an option of four (4) additional renewals through January 31, 2027.

(Temple Outdoor Decor has performed satisfactorily throughout the first year of the contract.

(The contract period is from October 1, 2023 through January 31, 2024.

(The contract amount reflects a 5% increase over the previous year's contract.

(Funds for the contract have been allocated in the General Fund.

(The Director of Public Works recommends approval.)

h. Consideration to renew a contract with Crystal Maintenance Plus, Corporation of Mount Prospect, IL for cleaning and custodial services: Village Hall & Public Safety Building and James Paul Petri Public Works Facility contracts in a total amount of \$115,887 from the General Fund.

(On April 26, 2022, the Village Board awarded a contract with Crystal Maintenance, Corporation of Mount Prospect, IL for the James Paul Petri Public Works Facility contract.

(The awarded contract added to the cleaning and custodial services: Village Hall & Public Safety Building contract awarded on March 22, 2022.

(The 2023 contract includes the addition of the Public Works Biesterfield Facility.

(The contract provides for an option of four (4) additional renewals through April 30, 2027.

(Crystal Maintenance, Corporation has performed satisfactorily throughout the first year of the contract.

(The contract period is from May 1, 2023 through April 30, 2024.

(The contract amount reflects a 5% increase over the previous year's contract.

(Funds for the contract have been allocated in the General Fund.

(The Director of Public Works recommends approval.)

i. Consideration to increase the appropriated funds to the Illinois Department of Transportation (IDOT) for the construction engineering costs and construction match for the Busse Road and Devon Avenue Intersection Improvement project in the amount \$306,227.28 for a total appropriated amount of \$966,852.28 from the Busse-Elmhurst Redevelopment Fund.

(On November 15, 2022, the Village Board approved a Joint Agreement for the Busse Road and Devon Avenue Intersection Improvement project between the Illinois Department of Transportation (IDOT) and the Village of Elk Grove Village.

(As part of the Joint Agreement, a resolution appropriating funds for the full construction engineering and the construction match was adopted by the Village. The total amount of funds appropriated by the Village was \$660,625.

(The lowest and responsive bid was submitted by Plote Construction Inc. in the amount of \$1,255,789.28 which was \$306,277.28 more than the Engineer's estimate.

(In addition to the Village's share of construction cost, \$825,064.28, the Village must appropriate the full cost of construction engineering, \$141,788, bringing the total funds appropriated by the Village to \$966,852.28.

(Funds for the project have been allocated in the Busse-Elmhurst Redevelopment Fund. (The Director of Public Works recommends approval.)

j. Consideration of the following:

- To award a purchase contract through the Suburban Purchasing Cooperative (SPC) Joint Purchasing Contract to Foster Coach Sales of Sterling, IL for one (1) Ford F-550 ambulance with custom Horton Body in the amount of \$364,305 from the Capital Replacement Fund; and
- To increase the Capital Replacement Fund in the amount of \$64,305.

(The Fire Department is replacing one ambulance due to age and excessive engine hours. (The Ford F-550 ambulance is available through the Suburban Purchasing Cooperative Joint Purchasing Contract from the lowest determined bidder, Foster Coach Sales of Sterling, IL.

(The Acting Fire Chief recommends approval.)

k. Consideration to award a professional services contract to HR Green, Inc. of McHenry, IL for engineering review and coordination services related to the new I-490 Tollway corridor and various other engineering services in the amount of \$500,000 from the Busse-Elmhurst Redevelopment Fund.

(The Illinois Tollway is concurrently constructing and designing the new I-490 section of the Tollway system.

(The Village has begun to receive plans, intergovernmental agreements and other contract documents that will require detailed review, quick turn around and significant knowledge of the federal and state requirements.

(The Village solicited a proposal from HR Green, Inc. to provide plan reviews, coordination with other agencies, landscape planning, general engineering services, and project management for the Village related to this Illinois Route 490 corridor project.

(Adequate funds are available in the Busse-Elmhurst Redevelopment Fund.

(The Director of Public Works has recommended approval.)

1. Consideration to award a professional services contract to HR Green, Inc. of McHenry, IL, for engineering design services for the new dual off-street bike paths along each side of Busse Road in the amount of \$839,713 from the Busse-Elmhurst Redevelopment Fund.

(The Village solicited a proposal from HR Green, Inc. of McHenry, IL, to provide design and permitting coordination for the construction of dual multi-use paths on each side of Busse Road, spanning from Oakton Street to Devon Avenue.

(This section of Busse Road is mapped as a proposed off-street bike route in the Village's Bicycle Plan.

(Adequate funds are available in the Busse-Elmhurst Redevelopment Fund.

(The Director of Public Works has recommended approval.)

m. Consideration to commit to the purchase of Bulk Rock Salt through the State of Illinois Joint Purchasing Contract in the amount of 2,500 tons for the FY 2023-2024 winter season.

(Illinois (CMS) is currently preparing bids for the FY 2023-24 Bulk Rock Salt Joint Purchasing Program.

(The Village intends to purchase 2,500 tons of Bulk Road Salt for the 2023 - 2024 winter season.

(The contract allows for the purchase of a minimum of eighty percent (80%) and a

maximum of one hundred and twenty percent (120%) of the awarded amount.

(This purchase option provides flexibility in the event that snowfall totals were below average and provides sufficient quantity to ensure safe roadways during a severe winter.

(Adequate funds have been budgeted for this project in the FY2024 budget.

(The Director of Public Works recommends approval.)

- n. Consideration to adopt Ordinance No. 3811 amending Section 7B-5-2:C(1) of the Elk Grove Village Zoning Ordinance pertaining to Conditional Uses and Section 7B-5-2:D of the Elk Grove Village Zoning Ordinance pertaining to Special Uses.
 - (This item was discussed at the April 25, 2023 Village Board Meeting and currently appears under Unfinished Business.)
- o. Consideration to adopt Ordinance No. 3812 granting a Special Use Permit to the Elk Grove Park District for modifications to property located at 711 Chelmsford Lane, Elk Grove Village, Marshall Park.
 - (This item was discussed at the April 25, 2023 Village Board Meeting and currently appears under Unfinished Business.)
- p. Consideration to adopt Resolution No. 24-23 authorizing the Village of Elk Grove to apply for funding assistance through the Invest In Cook Grant Program administered by Cook County, providing local assurance for the Devon Avenue Sidepath project.
 - (The Village has applied to Cook County for funding assistance through the Invest In Cook Grant Program (IIC) for the Devon Avenue Sidepath Project.
 - (The Village is requesting funding of \$500,000 toward the construction of an eight-foot wide sidepath along Devon from I-290 to Carlisle Avenue, which would complete a large section of the Village's planned bicycle network.
 - (The Director of Public Works has recommended approval.)
- q. Consideration to approve Resolution No. 25-23 accepting the results of the canvass conducted by the Canvassing Board of the Cook County Clerk's Office of the votes of the Consolidated Election and proclaiming the results for Village Officials held on Tuesday, April 4, 2023.
 - (A Consolidated Election was held in Elk Grove Village on Tuesday, April 4, 2023. (The Cook County Clerk canvassed the results of the Election and as required by Statute this Resolution accepts the results of the votes canvassed by the Canvassing Board of the Cook County Clerk's Office.)
- r. Consideration to adopt Resolution No. 26-23 authorizing the continued participation in the Northern Illinois Municipal Electric Cooperative (NIMEC) and authorizing the Village Manager to approve a contract with the lowest cost electricity provider.
 - (The Village has used the Northern Illinois Municipal Electric Cooperative (NIMEC) since 2008 to jointly purchase electricity from a third-party vendor in response to the deregulation of this industry in the State of Illinois.
 - (NIMEC is preparing to seek competitive pricing in June 2023 for electrical purchase for several locations.
 - (Similar to previous years, the Village is required to accept the market-price bid by the end of the business day.

(The Director of Public Works recommends approval.)

AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO THE ELK GROVE PARK DISTRICT FOR MODIFICATIONS TO PROPERTY LOCATED AT 711 CHELMSFORD LANE, ELK GROVE VILLAGE (MARSHALL PARK)

WHEREAS, the Plan Commission of the Village of Elk Grove Village, acting as a Zoning Commission, at a Public Hearing duly called and held according to law, considered the petition of Elk Grove Park District for a special use permit for modifications to a Planned Development for property located at 711 Chelmsford Lane, Elk Grove Village (Marshall Park); and

WHEREAS, the Mayor and Board of Trustees of the Village of Elk Grove Village, after having considered the recommendation and finding of said Plan Commission, find and believe it to be in the best interest of the Village that the special use permit be granted subject to certain conditions recommended by the Plan Commission.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, Illinois as follows:

<u>Section 1</u>: That there be granted a Special Use Permit to Elk Grove Park District for modifications to a Planned Development including altering the existing site plan and a proposed expansion of the public park for property located at 711 Chelmsford Lane, Elk Grove Village (Marshall Park), Elk Grove Village.

Section 2: That the Special Use Permit is subject to the following conditions:

- 1. The proposed fence shall be increased from four feet (4') to six feet (6').
- 2. The Petitioner shall review their plans and make best efforts to move the basketball courts further to the west and, if necessary, to reconfigure the walking path around the basketball court.
- 3. The Petitioner shall provide additional plantings along the southeast border to help diffuse potential noise dispersing from the park.
- 4. The Petitioner shall address and drainage issues caused by the subject property impacting the adjacent residential properties.
- 5. The proposed entryway from the Boardwalk Condominiums parking lot shall be removed.

Section 3: That this Ordinance shall be in full force and effect from and after its passage and approval according to law.

A RESOLUTION AUTHORIZING THE VILLAGE OF ELK GROVE TO APPLY FOR FUNDING ASSISTANCE THROUGH THE INVEST IN COOK GRANT PROGRAM PROVIDING LOCAL ASSURANCE FOR DEVON AVENUE SIDEPATH PROJECT

WHEREAS, the Mayor and Board of Trustees of the Village of Elk Grove Village, Cook County, Illinois desires to improve and enhance the Village's planned bicycle network; and

WHEREAS, the Village has applied to Cook County for funding assistance through the Invest in Cook (IIC) Grant Program for the Devon Avenue Sidepath Project. Invest in Cook prioritizes proposals that support transit and other transportation alternatives, support the region's role as North America's freight capital, promote equal access to opportunities, maintain and modernize what already exists and increase investment in transportation; and

WHEREAS, the Village is requesting funding of \$500,000 toward the construction of an eight-foot wide sidepath along Devon from I-290 to Carlisle Avenue, which would complete a large section of the Village's planned bicycle network; and

WHEREAS, the Devon Avenue Sidepath Project will construct an eight-foot wide concrete sidepath along the north parkway of Devon Avenue, from I-290 to Carlisle Avenue. This project will complete a major section of the Village of Elk Grove's planned bicycling network and provide an east-west connection along the Village's southern limits. The total construction estimate for this project is approximately \$1,300,000. Staff have requested \$500,000 in IIC grant funding in an effort to reduce the Village's share of the construction cost. If the project is selected for IIC grant funding, the project will be required to be constructed by the fall of 2024; and

WHEREAS the staff of Cook County have requested the Village follow up with a resolution of support from the Village Board. The resolution certifies that the Village is able to manage, maintain and operate the project, possesses legal authority to finance and construct the project, and affirms that the project will commence within the timeline as outlined in the grant application.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, State of Illinois authorize the Village staff to apply for the Invest in Cook Grant Program (IIC) to assist in the funding of the above-described project.

BE IT FURTHER RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, Illinois as follows:

Section 1: Certifies that we are willing and able to manage, maintain and operate the project.

<u>Section 2</u>: Affirms that, if selected, the Project will commence within the timeline as outlined in the Grant application.

Section 3: This Resolution shall be in full force and effect immediately from and after its passage and approval according to law.

A RESOLUTION AUTHORIZING THE CONTINUED PARTICIPATION IN THE NORTHERN ILLINOIS MUNICIPAL ELECTRIC COOPERATIVE (NIMEC) AND AUTHORIZING THE VILLAGE MANAGER TO APPROVE A CONTRACT WITH THE LOWEST COST ELECTRICITY PROVIDER

WHEREAS, during fiscal year 2008, the Village of Elk Grove Village joined the Northern Illinois Municipal Electric Cooperative (NIMEC) to jointly purchase electricity from a third-party vendor in response to the deregulation of this industry in the State of Illinois; and

WHEREAS, the Village of Elk Grove Village has selected the Northern Illinois Municipal Electric Cooperative (NIMEC) to serve as the Village's broker relative to the acquisition of electrical energy due to NIMEC'S municipal experience and the fact that NIMEC is a municipal cooperative which will be pooling the energy needs of members of the cooperative in order to secure more competitive pricing based on higher volumes than can be provided individually to a single municipality; and

WHEREAS, NIMEC is preparing to seek competitive pricing in June 2023 for electrical purchase for several municipal facilities and street light systems; and

WHEREAS, due to the bidding procedures required, the Village Manager or in his absence the Director of Public Works will need to have the authority to sign a purchase agreement with the electricity provider, which is deemed most favorable for the Village within hours of the bids being received by NIMEC.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, Illinois:

<u>Section 1</u>: That the Northern Illinois Municipal Electric Cooperative (NIMEC) is hereby appointed as the Village's broker for purposes of obtaining a supply of electricity for the Village's municipal needs, and the Village Manager and Director of Public Works are hereby directed to take all actions necessary to establish said broker relationship.

<u>Section 2</u>: That the Village Manager and/or Director of Public Works is authorized to discuss and negotiate energy rates directly with suppliers in an effort to secure a lower energy cost for the Village of Elk Grove Village.

Section 3: That in light of the time constraints applicable to the acceptance of a competitive bid for a supply of electricity, once the bids are received by NIMEC, the Village Manager and Director of Public Works are hereby authorized to sign the contract with the lowest

bidder, with Village Staff being hereby directed to place said contract on the first available Village Board regular meeting following the execution thereof by the Village Manager, for ratification by the Village Board.

<u>Section 4</u>: That this Resolution shall be in full force and effect from and after its passage and approval according to law.
