#### 4. MAYOR & BOARD OF TRUSTEES' REPORT -

<u>Mayor Johnson</u> – The Elk Grove Business Park ranked the second year in a row as the Best Business Park in America. No other town has had this recognition for two years in a row.

I met with Senator Seth Lewis and Representative Jennifer Sanilitro and things are moving forward. We are looking forward to working with them.

On June 29, ESPN was at Real Time Sports and taped a show about Elk Grove Village with the Racecar.

On July 1 & 2 was the Chicago Nascar race. Great job to Chicago coordinating the race and dealing with the wet pavement on the Nascar streets. Next year we are doing the race again.

The Farmers Market on July 29 will have a booth with Police Officers and the Mayor may stop by.

On July 4, we had KC & the Sunshine Band for the Mid-Summer Classics Concert Series and it was the biggest crowd so far for the concert series. Great job to Police, Fire and Public Works for all their work.

RotaryFest is starting and All American Rejects will be playing on Thursday, July 20. At 3:00 is the countdown to place your chairs out and there should be a very large crowd again.

We had a Parade meeting on July 10. The Parade this year is on September 16.

On July 11, the Spinners Concert had a great crowd.

On July 16, the Play, Picnic, Party in conjunction with the Park District and the Library was a lot of fun. That had the biggest crowd thus far for this event.

There will be another multipurpose Bike Path going in along Oakton Street to connect with another bike path.

The next Coffee with the Board will be on Saturday, August 5, from 9-11 AM in Room E.

Thank you to all of the Village Staff. The storm had winds up to 80 mph and thank you to Colby and the Public Works crew that were out cleaning up after the storm. We will continue to clean up and pick up.

There were three (3) swearing ins for the Fire Department: Firefighter Alexander Espinosa, Firefighter Adam Garrison, and Lieutenant Kristofer Schuldt.

A Citizen's Award was announced tonight for Steven Schiro and Israel Escareno who saw a car on fire on Lively Blvd. and Morse Ave. and the driver was unconscious and strapped in the front seat. The two men were able to retrieve the driver from the burning car before Police & Fire arrived.

The car became completely engulfed with flames when the Police and Fire arrived and these two citizens were heroic for their actions. Since they were unable to attend, the Police and Fire Departments will provide the Citizen Awards in another way.
