4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – The Village has worked with the Kenneth Young Center and placed a Narcan vending machine outside the Police IC to assist residents as needed. There is no cost, and the Police Officers are trained if they need assistance and provides them information about the Elk Grove Cares program. Recently Someone took a Narcan kit for a relative that they were concerned about. A day or two later they applied Narcan to the person that overdosed and saved that person's life.

We thank everyone for contributing. The Parade is on September 16.

RotaryFest took place since the last board meeting. The All American Rejects is one of our concerts that played on Thursday, July 20. There were over 20,000 people on Thursday and the Rotary Club raised more money that day than any of the other days of RotaryFest. We will be doing it again next year. Almost 80% of the money earned goes to Elk Grove Community charities. The summer concerts keep getting better and next year's lineup will be our biggest ever. Senator Laura Murphy gave us a \$200,000 grant toward funding the concerts and for anyone that plays video gaming or stays in our hotels or smokes - Thank you. That's where all

the money comes from to put these shows on.

On July 23, I was invited to attend the grand opening of the new Indian Temple on Martingale Road along with Congressman Raja. We are excited about them opening and we wish them well.

We had a meeting with Microsoft, and they are finishing up with the last building.

We have a new development being built on Arlington Heights Road and Higgins. We are doing a naming contest for naming that whole development. You can submit one idea from each resident and there will be gift cards for each winner. Submit your names and we may take your name in its entirety or parts of a couple of names, and we reserve the right to take none of the names. So, starting tomorrow go to ElkGrove.org and you will find a link that you can submit an idea. The contest will remain open until September 15 at 5:00 p.m. Wingspan has been meeting with all the tenants and things are working out very well.

We also had a meeting with District 59 to discuss the number of Student Resource Officers (SRO) officers they want this school year. We recommend that the parents get involved to have an SRO for each school. Student Resource Officers talk to the kids and get involved with the kids.

The Police Department issued 158 seat belt citations during the recent Independence Day "Click It or Ticket" safety campaign. The campaign took place between June 16 and July 5, 2023. Their enforcement campaign resulted in the following additional citations and arrests: 24 Speeding Violations, 23 Distracted Driving and Cell Phone Citations, 3 Driver's License Offenses, 13 No Insurance Violations, 23 Tinted Window Violations, 53 Other Citations, and 1 Arrest on Warrant.

Mayor read a letter he received complimenting the Police, Fire, and Public Works Department on a nice job they are doing keeping everyone safe at the summer concerts.

Please remember to lock your car doors and don't leave belongings inside. There have been a lot of burglaries lately and two cars were stolen because the keys were inside.

Elk Grove is the place to be with all the summer events. We had the concerts and the Play, Party, Picnic. Everyone had a great season. Mayor thanked all the employees with all the setup and take down for these events.

Isela Cantina was sworn in for the unexpired term on the Library Board.

George VanDusen of SWANCC (also Mayor of Skokie) presented a proclamation to Mayor Johnson for his efforts in reaching out to legislative officials to find another location to put the Solid Waste collections when the Bartlett landfill closed.

There will be a public Information Meeting for the Tonne Road Improvements on August 16, 2023.

<u>Trustee Bush</u> – The August 4 Splash Party went well. Thank you to the Police and all the Lifeguards working late for this event.

Elk Grove High School will be participating in the Parade as needed.

They are also helping with the Prince of Peace pumpkin patch.

EGHS students will be coming to the Village for their government section.

<u>Trustee Miller</u> – Many people are looking to volunteer and one of the organizations is Pads, and the Community Character Coalition (CCC) to learn how to volunteer and give back to the community. The CCC will be celebrating their 20-year Anniversary on Sunday, September 24 from 1-4 PM at the Pavilion. It is about service projects and what service projects you are interested in. More information will be in an upcoming newsletter.

<u>Trustee Schmidt</u> – After the last meeting, I had an opportunity with Sister Cities to meet with several doctors in Sicily. We were also speaking to the students out in Sicily to bring some students here in March 2024.

<u>Trustee Jarosch</u> – Thank you to residents that are willing to step up for PADs Organization. It looks like we will be open this year. We still need help if anyone is interested, you can reach out to myself or Christus Victor.

I also attended a Neighborhood Watch meeting at the end of July and had an awesome demonstration by one of our drone pilots through the Fire Department and learned a lot about what they do. We were able to see the infrared capabilities and how they help our firefighters

with fires, and one of our drones can carry a lifesaving device.

I also attended the Retirement celebration for Officer Maglio.
