4. MAYOR & BOARD OF TRUSTEES' REPORT

<u>Mayor Johnson</u> – On August 16, there was an Open House at Public Works for the upcoming Tonne Road reconstruction. There were 43 people that attended. We are working with Congresswoman Ramirez and Congressman Raja Krishnamoorthi to help with funding for this project. The watermains will begin in 2024 and the rebuild project will begin in 2025.

On August 17, I met with Paul Kelly at Elk Grove High School, and we are looking to expand the Manufacturing Technology Lab space.

On August 18, Rose Garden is now open, and everything looks nice inside.

I was fortunate to meet with the FAA and the County regarding the plane crash. The driver of the plane was the luckiest person on the face of this earth. The plane came down 4' short of the tree on his left and 5' short from a tree on the right. The plane ran out of gas and the pilot literally walked away from the crash. The O'Hare crew was there and I thank the Fire Department, Police Department, and Public Works for providing everything that was needed that night.

The Elementary School District 59 decided that they do want SROs at Grove Junior High. Congratulations Deputy Chief Burke and Deputy Chief Torres last night. They did a great presentation.

The Village will be having a Town Hall meeting on Tuesday, 10/17 in the Council Chambers at 6:30 p.m. It is open for everyone to come and ask questions.

The Elk Grove High School students came to the Village on two days to talk about Government. Trustee Jarosch spoke with one group, and Mayor spoke with the other.

There is a new gaming place that will open in the F45 workout place. They will have race car simulators and will plan to open in November.

We saw Willis Johnson, the owner of Classic Cinemas, when he came in for a liquor license and I asked where the popcorn was? Today, his son Chris yesterday dropped off a huge bag of popcorn for the employees to enjoy. He recently passed away and he will be missed.

This Saturday, 9/16 at 2:00 p.m., the Parade will walk up Elk Grove Boulevard and end at the Oktoberfest.

On August 30, Snap Canna had a Grand Opening at 840 Higgins.

On December 16, at 10:00 a.m. there will be the Wreaths Across America to honor all the veterans and 1st responders in Elk Grove Cemetery. Jane Gregga is present and the board will provide you with any assistance you need that day. We have a very rare cemetery that has 2 Revolutionary War Veterans. This is the 5th year for the ceremony.

The Cook County Health Department is starting to talk about COVID. We are not making masks mandatory and the vaccines are recommended but completely your choice.

A Proclamation was read for the Ignite Dance Company from the Pavilion. There were 960 entries for the competition and the Dance Team won 1st and 2nd place in the national competition.
