FAA Confirms It Will Comply with NEPA and Review Comments from Village for Review of the Fly Quiet Program

In October, the Village filed a lawsuit to compel the Federal Aviation Administration (FAA) to follow its statutory requirements as part of the environmental review of the proposed permanent Fly Quiet Program at O'Hare Airport. In response, the FAA has confirmed it will comply with the National Environmental Policy Act (NEPA) and review the Village's recommendation that Alternative H3 and a heading-sensitivity analysis be considered before making any final decisions related to the Fly Quiet Program.

Among other things, NEPA requires a formal public process so that all stakeholders can review and comment on major federal actions, like the permanent Fly Quiet Program. This will provide the Village, and all communities around the airport, the assurance of a fair process to demonstrate the most equitable alternative for the permanent Fly Quiet Program.

The Village believes that all surrounding communities should share equally in the benefit and the burden of O'Hare airport, including an equal distribution of nighttime noise to give all residents intermittent relief. As the Village has maintained for years, Alternative H3 accompanied by a heading-sensitivity analysis provides the most equitable distribution of nighttime noise for all communities affected by O'Hare.

Following the FAA's assurances, the Village has dismissed its lawsuit, but has reserved the right to pursue additional legal action if necessary. The Village will continue to monitor the review of the Fly Quiet Program closely until a final decision is made and an equitable Fly Quiet Program is established.

Mayor & Board Take Action to Prevent Long-Term Placement of Migrants in Elk Grove Village

In an effort to prevent long-term placement of migrants from staying in Elk Grove Village, the Village Board approved an ordinance that will require hotel and motels to verify that individuals who are not residents of the United States provide certified medical documentation to reserve overnight accommodations. The documentation must state that the individual has not been diagnosed or contracted any contagious diseases in the past 60 days and must be from a board-certified infectious disease specialist.

This requirement does not apply to individuals who have been living in the United States for at least one year.

The ordinance also prevents property owners of warehouses and other vacant spaces from turning their buildings into temporary housing. Per the new ordinance, property owners would need to obtain a Village license required for temporary housing. This means that the property would need to meet health, safety, and zoning requirements such as those imposed on hotels and motels.

The ordinance was approved on November 20, 2023 during a Special Village Board Meeting to ensure the health, safety and welfare of the community.

Overnight Parking Restriction Waived for the Holidays

Overnight parking permission will begin on Saturday, December 16, 2023, at 2:00 a.m. and end on Monday, January 1, 2024 at 5:00 a.m.

Please note that residential street parking is prohibited if there is more than 2 inches of snow on the ground or if the Village is expecting snow. Vehicles must be cleared from the street until snow removal operations are finished.



Elk Grove Village Remains the Most Affordable Community for Residents


A 2023 survey of seven comparable communities shows that Elk Grove Village continues to provide the lowest cost of living for residents. The Village of Elk Grove routinely compares itself to neighboring municipalities and we are proud of our reputation of offering high quality services at affordable prices. Not only has Elk Grove Village maintained its place as the most affordable community since we began this survey over ten years ago, this also marks the 25th year that Elk Grove residents have had the lowest combined property tax rate in the area.

The annual cost-of-living survey is intended to account for the entire range of municipal taxes and fees that impact residents—this includes property tax, sales tax, natural gas tax, cable franchise fees, waste/ recycling services, water/sewer rates, and various other costs. The graph below shows that Elk Grove Village has the lowest annual municipal impact for these taxes and fees, coming in at under \$8,500 per year.

The Village is able to maintain this low cost of living in large part to our robust business community. The Village works hard to cultivate relationships and provide value to our business community to help keep costs low for residents.

The More You Know With Public Works: Elevated Water Storage Tank

The Village is proud to unveil its new 155-foot-tall elevated water storage tank! Located at the intersection of Higgins Road and Busse Road, the new tank will replace the 121-foot-tall tank on Pratt Boulevard that was built in 1964.

This new elevated water storage tank can hold up to 500,000 gallons of water and plays a crucial role in maintaining water system pressure to ensure a steady water supply to homes and businesses.

Construction on the new elevated tank began in 2022 and is scheduled to be brought online to the water distribution system this December.

Home Winterization Tips

Now that winter weather is upon is, it is important to protect the interior and exterior of your property. The following tips can help you prepare your home for the winter season:

Prevent Freezing Pipes:

- Seal or caulk any cracks that might let cold air in, especially places where pipes run from the inside to the outside of your home, such as dryer vents or water pipes.
- Disconnect all garden hoses and check that any outdoor faucets with shutoff valves are drained and closed.

Fireplace Maintenance

- Remove soot, debris, and/or leaves from the chimney and the firebox before igniting.
- Check the flue damper to make sure it opens and closes properly.
- Only burn seasoned firewood or gas logs per manufacturer's regulations.
- Consult with a licensed chimney sweep or fireplace service technician for repair or maintenance.

Furnace Maintenance

- Change the air filter regularly to keep your furnace running efficiently.
- Consult with an HVAC professional annually to test and service your furnace to ensure it is functioning properly.

Avoid Warm-Up Theft this Winter

No one likes to get into an ice-cold car, but leaving your car unattended while it warms up increases your vulnerability to theft! Warm-up theft occurs when thieves steal cars that have been left running to warm up while unlocked and unattended - an open invitation for thieves.

If you must warm up your car and leave it unattended, use a remote starter or lock your vehicle and use a spare key. It only takes a few seconds for a thief to strike and it can happen anywhere, including residential areas, private driveways, retail parking lots, gas stations, etc.

Always remember to lock your car and take your keys with you every time! ■



Pace Dial-A-Ride

Pace provides curb-to-curb Dial-A-Ride bus service within the Village of Elk Grove, excluding the industrial park area, Monday through Friday from 9:00 a.m. to 6:00 p.m.

Fares for a one-way trip are \$1.30 per person, with a discounted fare of \$0.65 for seniors (ages 65 and older), children under 11 accompanied by an adult, persons with disabilities, and students traveling to or from school.

To schedule a ride, please call the Elk Grove Dial-A-Ride reservation line at 847-299-6212 or the regional reservation line at 800-299-0765. Residents are encouraged to call one hour in advance of their desired pickup time beginning at 8:30 a.m.

All Dial-A-Ride riders must register for the Rider ID system prior to scheduling their first ride.

Elk Grove Village's Snow and Ice Control

Winter is here and the Village is ready to provide safe and clear street.
To help achieve our goal, please keep in mind the following:

Priority Plowing and Salting



During snow/icing events, Public Works crews focus on major streets first to provide access for emergency vehicles and heavier traffic, then begin working on all other streets. Crews will continue this process for the duration of the storm and come back to clean up side streets after the snowfall has ended.

Your Role in Clearing Snow

Snow removal equipment is designed to push snow onto the right-of-way which may result in snow being pushed onto driveway aprons, mailboxes, sidewalks, and hydrants. Residents and businesses are encouraged to clear:

- Driveway aprons and mailboxes Place the snow onto your property or the adjacent parkway;
- **Sidewalks** Place the snow onto your property as the Village does not provide this service;
- Hydrants Clear the snow and ice three feet around all sides of hydrants to provide access in the case of an emergency.

Keep in mind that shoveling, blowing, or plowing snow into the street creates hazardous driving conditions, negates the effort of our snowplowing operations, and is prohibited by law. Please be careful when moving heavy snow.

Winter Weather Parking Restrictions

Parking on all Village streets is prohibited when 2 or more inches of snow has fallen or is predicted to fall. Parking is also prohibited on both sides of the street for 24 hours after the snowfall stops or until the clearing operation is complete.

Drive Safely and Remember to Yield

Remember to drive cautiously and yield to snow removal equipment and emergency vehicles.

Early Voting for the Presidential Primary Election will begin on March 4, 2024 and will continue through March 18, 2024.

Early Voting will be open:

Monday - Saturday 9:00 a.m. to 5:00 p.m. Sunday 10:00 a.m. to 4:00 p.m.

Anyone living in Suburban Cook County can vote early at Village Hall (901 Wellington Avenue) during the Early Voting period.

On Election Day (March 19, 2024), all voters must vote at their designated polling place. Please be aware that Village Hall is NOT a designated polling place on Election Day.

If you are not yet registered to vote, you can do so in advance online at <u>ova.elections.il.gov</u>. You can also register to vote in-person at Village Hall, or at your designated polling place on Election Day.

If you are registered to Vote by Mail, please be aware that the Cook County Clerk is mailing out signature cards to voters who have no signature on file or whose signature on file is over 25 years old. Voters are asked to provide a new signature or verify their existing signature on file.

The purpose of these signature cards is to help the Cook County Clerk's Office verify signatures during the Vote by Mail process in upcoming elections.

There has been no change to voter registration status, this process is only for verification and efficiency purposes.
