 - a. Consideration of a request from the Community Consolidated School District 59, located at 1001 Leicester Road, to waive FY 2024/25 vehicle sticker fees in the amount of \$995.
 - (The Community Consolidated School District 59 is seeking a waiver of FY 2024/25 vehicle sticker fees for 1 passenger vehicle (\$25), 17 Class-B trucks (\$850), and 2 school buses (\$120) for a total waiver of \$995.
 - (It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.
 - (The Director of Finance recommends approval.)
 - b. Consideration of a request from the Rotary Club of Elk Grove Village to waive the fee for a temporary Class D liquor license (\$2,100) for the Village's Oktoberfest on September 20 and 21, 2024.
 - (The fee for a Class D Liquor License is \$2,100.
 - (The Rotary Club of Elk Grove Village is coordinating the sale of beer and wine at the Village's 2024 Oktoberfest.

(It has been past practice of the Village Board to grant fee waivers for governmental and non-profit organizations.)

- c. Consideration of a request from the Rotary Club of Elk Grove Village for the following:
 - To authorize a \$22,000 contribution to the 2024 RotaryFest event that takes place from July 18, 2024 through July 20, 2024;
 - To authorize the Rotary Club to host a fireworks display on Saturday, July 20, 2024:
 - To waive the fee for a temporary Class D liquor license (\$2,100), a carnival license (\$500), and a food caterer's license fee (\$100) for a total amount of \$3,500; and
 - To waive the permit fee for the use of a fire hydrant for non-firefighting purposes in the amount of \$75.

(It has been past practice of the Village Board to approve these requests for the annual RotaryFest event.

(Adequate funds have been budgeted and are available for this purpose.)

d. Consideration to award a professional service contract to Lauterbach & Amen, LLP of Naperville, IL to perform the Village's annual audit in an amount not to exceed \$33,420.

(This contract is year two of a five-year contract with Lauterbach & Amen, LLP to audit the Village's financial statements.

(Year two will comprise the audit of financial statements for the fiscal year ending April 30, 2024.

(This second year of the contract represents a 3.1% increase from the previous year.

(Lauterbach & Amen, LLP audits many municipalities with personnel specializing in governmental accounting. They have demonstrated their commitment by providing a high level of quality service with technically competent personnel.

(Their expertise is critical for the adoption of new accounting pronouncements issued by the Governmental Accounting Standards Board (GASB).

(Adequate funds are included in the proposed FY 2024-25 budget.

(The Library will retain the same auditor as the Village under a separate contract.

(The Director of Finance recommends approval.)

e. Consideration to award a services contract to Core & Main of Carol Stream, IL for the annual Sensus Regional Network Interface & Analytics and antenna maintenance agreement at a cost not to exceed \$44,537 from the Water & Sewer Fund.

(On September 10, 2019 the Village Board approved a contract with Siemens Industry, Inc. of Mount Prospect, IL, for the replacement of water meters, advanced metering infrastructure upgrades and other project management services.

(Part of the new meter system upgrade included replacing the sixteen-year-old technology used to capture the water meter readings in the Business Park by replacing the drive-around radio reading system.

(The new system allows for much more efficient collection of water meter readings using radio signals sent to antenna towers.

(The two-antenna system is provided by Sensus. Meter readings are recorded through

radio signals by the two antennas and stored in Senus's Regional Network Interface (RNI) secure cloud-based system before being accessed by the Village for billing purposes.

(The annual services associated with the use and access to Sensus RNI & Analytics and maintenance for the two radio antennas is \$44,537.

(Adequate funds are available in the Water & Sewer Fund.

(The Director of Public Works recommends approval.)

f. Consideration to concur with prior authorization to waive the formal bidding process and award a purchase contract to D'Orazio Ford of Wilmington, IL, for the purchase of five (5) Ford Explorer Interceptors in the amount of \$264,375.15 from the Capital Replacement Fund.

(Funds have been included in the proposed FY2025 Budget to replace police vehicles #230, #233, #235, #236, and #243.

(The order bank for Police Ford Explorer Interceptor Units opened February 12, 2024, and Ford Motor Company requires a signed purchase order within 30 days of order placement, or the order is subject to cancelation.

(Because orders placed in previous years through the SPC contract have been canceled without reason, Public Works identified an alternate sourcing option for these vehicles.

(D'Orazio Ford of Wilmington, IL has made available an order allocation of five (5) Police Ford Explorer Interceptor Units.

(The Police Ford Explorer Interceptors are available at a cost of \$52,875.03 each from D'Orazio Ford with all the options to meet the needs of Elk Grove Village.

(The price per unit from D'Orazio Ford is less than the Suburban Purchasing Cooperative (SPC) Contract cost per unit.

(Adequate funds will be available in the Capital Replacement Fund.

(The Director of Public Works recommends approval.)

g. Consideration to award a professional contract to the lowest responsive and responsible bidder to Keisler Police Supply of Jeffersonville, IN for the Officer Firearm Replacement Project in the amount of \$133,981 from the Federal Asset Seizure Operating Capital Fund.

(On Tuesday, February 13, 2024, the Village opened sealed bids for the Officer Firearm Replacement project.

(The project consists of purchasing one hundred thirty new Glock pistols, magazines, and accessories for sworn officers of the Elk Grove Village Police Department, as well as the trade-in of existing service pistols.

(This purchase would replace the current service weapons which have been in service for the past thirteen years.

(The purchase and pistol trade-in/buy back is anticipated to begin in April 2024, as soon as the manufacturer can supply and deliver the pistols and accessories for the entire Police Department.

(The lowest responsive and responsible bid was received from Kiesler Police Supply Inc. of Jeffersonville, IN in the amount of \$133,981.00. The bid also included \$31,680 for the buyback/trade-in of all current service pistols.

(Funds for the project are budgeted in the Federal Asset Seizure Fund.

(The Director of Police recommends approval.)

h. Consideration to increase a construction contract with RoadSafe Traffic Systems of Woodridge, IL, for the Residential Regulatory Sign Replacement Program project in the amount of \$30,662.30 for a total contract of \$817,049.30 from the Capital Projects Fund.

(On Tuesday, April 25, 2023, the Village awarded a contract for the Residential Regulatory Sign Replacement Program to RoadSafe Traffic Systems of Woodridge, IL, in the amount of \$786,387.70.

(Staff are requesting to increase the contract by \$30,662.30 to add thirteen (13) signs. The added signs are pedestrian crossing signs to be placed at locations where crosswalks are striped adjacent to parks, but do not currently have signage.

(Funds are budgeted and available in the Capital Projects Fund.

(The Director of Public Works recommends approval.)

 Consideration to award a contract to Langton Group of Woodstock, IL for the Residential & Business Park - Turf and Landscape Bed Maintenance contract in the amount of \$339,035 from the Public Works General, Residential Enhancement, BLF, and Busse-Elmhurst TIF Funds.

(On Tuesday, February 13, 2024, the Village opened sealed bids for the Residential & Business Park – Turf and Landscape Bed Maintenance contract.

(Five (5) contractors obtained bid packets, with all five (5) contractors submitting a bid.

(The contract provides for turf mowing, landscape bed maintenance, fertilizing services, irrigation system maintenance and perennial planting at various sites throughout the Village's Residential area and Business Park including landscaped medians, bus shelters, all the Village Fire Stations, James Paul Petri Public Works Facility, Public Works Biesterfield Facility and Charles J. Zettek Municipal Complex.

(The initial term of the contract is from March 1, 2024 through February 28, 2025.

(The contract includes the option for four (4) annual renewals in one (1) year increments through February 28, 2029.

(The lowest responsive and responsible bid was received from Langton Group of Woodstock, IL in the amount \$339,035.

(Funds for the contract have been allocated in the Public Works General, Residential Enhancement, BLF, and Busse-Elmhurst TIF Funds.

(The Director of Public Works recommends approval.)

j. Consideration to award a contract to the lowest responsive and responsible bidder, Builders Paving, LLC of Hillside, IL for the 2024 Business Park Street Rehabilitation project in the amount of \$1,617,815.73 from the Business Leaders Forum Fund, Water & Sewer Fund and Busse-Elmhurst Redevelopment Fund.

(On Thursday, February 15, 2024, the Village opened sealed bids for the 2024 Business Park Street Rehabilitation project.

(Six (6) contractors obtained bid documents and four (4) submitted bids.

(The lowest responsive and responsible bid was received from Builders Paving, LLC of Hillside, IL.

(Adequate funds for the project are included in the proposed FY2025 budget for the Business Leaders Forum Fund, Water & Sewer Fund and Busse-Elmhurst Redevelopment Fund.

(The Director of Public Works recommends approval.)

k. Consideration to adopt Resolution No. 11-24 authorizing the Village of Elk Grove to apply for funding assistance through the Invest In Cook Grant Program administered by Cook County, providing local assurance for the Tonne Road Reconstruction Project.

(The Village has applied to Cook County for funding assistance through the Invest In Cook Grant Program (IIC) for the Tonne Road Reconstruction Project.

(The Village is requesting funding of \$500,000 toward the reconstruction of Tonne Road, from Elk Grove Boulevard/Touhy Avenue to Landmeier Road. The project includes a reconfigured Elk Grove Boulevard/Touhy Avenue intersection, a new multi-use path along the center median, as well as various other improvements.

(The Invest In Cook Grant would reduce the Village's local share of project funding. (The Director of Public Works has recommended approval.)

1. Consideration to adopt Resolution No. 12-24 authorizing the continued participation in the Northern Illinois Municipal Electric Cooperative (NIMEC) and authorizing the Village Manager to approve a contract with the lowest cost electricity provider.

(The Village has used the Northern Illinois Municipal Electric Cooperative (NIMEC) since 2008 to jointly purchase electricity from a third-party vendor in response to the deregulation of this industry in the State of Illinois.

(NIMEC is preparing to seek competitive pricing in March 2024 for electrical purchase for several water & sewer facility locations.

(Similar to previous years, the Village is required to accept the market-price bid by the end of the business day.

(The Director of Public Works recommends approval.)

m. Consideration to adopt Resolution No. 13-24 authorizing the Maintenance of Streets and Highways by a Municipality under the Illinois Highway Code and appropriating \$2,050,000 from the Motor Fuel Tax Funds (MFT) toward the 2024 Roadway Maintenance Program.

(On Wednesday, January 31, 2024, the Capital Improvements Committee met and approved the staff recommendation for the Village's 2024 Roadway Maintenance Program.

(This year's program consists of 9.5 miles of street resurfacing and the rehabilitation of curb, sidewalk and ADA-compliant sidewalk ramps.

(The 2024 Roadway Maintenance Program is broken into four separate projects consisting of the Residential Resurfacing Project, Business Park Resurfacing Project, a new Asphalt Surface Patching Program and Pavement Rejuvenation.

(The Public Works Department recommends that a Resolution be adopted appropriating MFT Funds in the amount of \$2,050,000 to be utilized for the 2024 Residential Resurfacing Project and the purchase of Hot Mix Asphalt material.

(Upon concurrence by the Board, Village staff will prepare bid documents and advertise for bids for all four projects within the 2024 Roadway Maintenance Program.

(The Director of Public Works recommends approval.)

A RESOLUTION AUTHORIZING THE VILLAGE OF ELK GROVE TO APPLY FOR FUNDING ASSISTANCE THROUGH THE INVEST IN COOK GRANT PROGRAM PROVIDING LOCAL ASSURANCE FOR THE TONNE ROAD RECONSTRUCTION PROJECT

WHEREAS, the Mayor and Board of Trustees of the Village of Elk Grove Village, Cook County, Illinois desires to improve and enhance the Village's Tonne Road; and

WHEREAS, the Village is applying to Cook County for funding assistance through the Invest in Cook (IIC) Grant Program for the Tonne Road Reconstruction Project. Invest in Cook prioritizes proposals that support transit and other transportation alternatives, support the region's role as North America's freight capital, promote equal access to opportunities, maintain and modernize what already exists and increase investment in transportation; and

WHEREAS, the Village is requesting funding of \$500,000 toward the construction of Tonne Road, from Elk Grove Boulevard/Touhy Avenue to Landmeier Road. The project includes a reconfigured Elk Grove Boulevard/Touhy Avenue intersection, a new multi-use path along the center median, as well as various other improvements; and

WHEREAS, the Tonne Road Reconstruction Project includes reconstruction of the roadway, improvements to the Tonne Road and Landmeier Road geometrics, a re-design of the intersection of Tonne Road at Elk Grove Boulevard/Touhy Avenue to enhance safety and eliminate frequent collisions and the installation of a multi-use path in the median. The total construction estimate for this project is approximately \$7,840,000. Staff have received over \$5,300,000 in grant funding to-date for the project and are requesting an additional \$500,000 in IIC grant funding in an effort to reduce the Village's share of the construction cost. The project is currently planned for 2025 construction, pending all federal approvals; and

WHEREAS the Resolution is recommended with our application to Cook County to show that the Village Board is in support of this project. The resolution certifies that the Village is able to manage, maintain and operate the project, possesses legal authority to finance and construct the project, and affirms that the project will commence within the timeline as outlined in the grant application.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, State of Illinois authorize the Village staff to apply for the Invest in Cook Grant Program (IIC) to assist in the funding of the above-described project.

BE IT FURTHER RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, Illinois as follows:

Section 1: Certifies that we are willing and able to manage, maintain and operate the project.

<u>Section 2</u>: Affirms that, if selected, the Project will commence within the timeline as outlined in the Grant application.

<u>Section 3</u>: This Resolution shall be in full force and effect immediately from and after its passage and approval according to law.

A RESOLUTION AUTHORIZING THE CONTINUED PARTICIPATION IN THE NORTHERN ILLINOIS MUNICIPAL ELECTRIC COOPERATIVE (NIMEC) AND AUTHORIZING THE VILLAGE MANAGER TO APPROVE A CONTRACT WITH THE LOWEST COST ELECTRICITY PROVIDER

WHEREAS, during fiscal year 2008, the Village of Elk Grove Village joined the Northern Illinois Municipal Electric Cooperative (NIMEC) to jointly purchase electricity from a third-party vendor in response to the deregulation of this industry in the State of Illinois; and

WHEREAS, the Village of Elk Grove Village has selected the Northern Illinois Municipal Electric Cooperative (NIMEC) to serve as the Village's broker relative to the acquisition of electrical energy due to NIMEC'S municipal experience and the fact that NIMEC is a municipal cooperative which will be pooling the energy needs of members of the cooperative in order to secure more competitive pricing based on higher volumes than can be provided individually to a single municipality; and

WHEREAS, NIMEC is preparing to seek competitive pricing in March 2024 for electrical purchase for several water and sewer facility locations; and

WHEREAS, due to the bidding procedures required, the Village Manager or in his absence the Director of Public Works will need to have the authority to sign a purchase agreement with the electricity provider, which is deemed most favorable for the Village within hours of the bids being received by NIMEC.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Elk Grove Village, Counties of Cook and DuPage, Illinois:

<u>Section 1</u>: That the Northern Illinois Municipal Electric Cooperative (NIMEC) is hereby appointed as the Village's broker for purposes of obtaining a supply of electricity for the Village's municipal needs, and the Village Manager and Director of Public Works are hereby directed to take all actions necessary to establish said broker relationship.

<u>Section 2</u>: That the Village Manager and/or Director of Public Works is authorized to discuss and negotiate energy rates directly with suppliers in an effort to secure a lower energy cost for the Village of Elk Grove Village.

Section 3: That in light of the time constraints applicable to the acceptance of a competitive bid for a supply of electricity, once the bids are received by NIMEC, the Village Manager and Director of Public Works are hereby authorized to sign the contract with the lowest

bidder, with Village Staff being hereby directed to place said contract on the first available Village Board regular meeting following the execution thereof by the Village Manager, for ratification by the Village Board.

<u>Section 4</u>: That this Resolution shall be in full force and effect from and after its passage and approval according to law.
