Elk Grove Village Delivers Economic Relief Once Again to Residents in form of \$200 Gift Card

Current Elk Grove Village residents will once again receive \$200 pre-paid gift cards that can be used to offset back-to-school costs and other household expenses like groceries and gasoline thanks to the fourth residential economic relief initiative by the Village in the last few years.

The Village has mailed \$200 gift cards to every household in Elk Grove Village. These gift cards are redeemable at grocery stores, general retailers, and gas stations, among others.

In the same fashion as the previous gift card initiative, residents will receive two envelopes in the mail - a letter from the Village Board explaining the economic relief initiative, and a second envelope containing the pre-paid gift card with instructions to activate it. The Village has also posted information regarding activation and other frequently asked questions to the Village website at elkgrove.org/giftcard.

Where possible, the Village encourages residents to use these funds in a way that can double the impact: "Shop Elk Grove" and spend this money at local businesses so the benefit can also be felt by those who do so much to support the local economy.

This is the fourth time the Village has provided economic relief to Elk Grove

This is the fourth time the Village has provided economic relief to Elk Grove Village residents during these challenging economic times. During the COVID-19 pandemic, the Village provided a \$200 water bill credit to each household in Elk Grove Village two separate times. In 2022, the Village sent home \$200 pre-paid gift cards to all households in the Village to provide relief from inflation and soaring costs for essential household goods.

In the last four years, the Village has delivered \$12 million in economic relief directly back to Elk Grove Village residents, made possible by the economic strength of the Elk Grove Village Business Park.

Back to School Road Safety

As summer ends and school begins, our neighborhoods and school zones see a rise in pedestrian and bicycle activity. To ensure the safety of our children:

- Please avoid speeding and remain vigilant for pedestrians and cyclists.
- Remember to exercise caution around school buses, especially when students are boarding or disembarking.
- Slow down in designated school zones.
- Stop when you see red lights flashing and the stop signal arm extended on school buses. ■

State and County Road Construction Projects

There are several upcoming road construction projects in Elk Grove Village that are managed by other government agencies. Please be aware that the Village of Elk Grove is not conducting these construction projects. Any questions about these construction projects should be directed to the government agency leading the project.

Plum Grove Road Improvements (Summer 2024 - Spring 2025)

Plum Grove Road will be under rehabilitation beginning this summer from Nerge Road to Higgins Road. Work will include pavement patching, curb and gutter removal and replacement, roadway median improvements, sidewalk and ADA ramp improvements, and more.

Lane closures and restrictions are anticipated through the duration of the project. Motorists and pedestrians are advised to use caution when traveling in these areas or seek alternate routes.

Students attending Conant High School can expect more delays than usual when commuting on Plum Grove Road.

The project is being led by Cook County Department of Transportation and Highways, and is anticipated to have ongoing construction until completion in 2025.

York Road Reconstruction (2024 - 2026)

As part of the Illinois Tollway's I-490 project, York Road will be reconstructed from Devon Avenue to Gateway Road in Bensenville. Construction will begin in the late summer of 2024, with roadway reconstruction from Devon Avenue to Supreme Drive, as well as from Foster Avenue to Gateway Road.

Traffic will be reduced to one-lane of traffic in each direction for the duration of the reconstruction work. These segments are anticipated to be completed by the end of 2024. The Tollway anticipates reconstructing York Road from Supreme Drive to Foster Avenue in 2025, and completing the off-street eight foot wide sidepath in 2026.

instruction by LPGA and PGA professionals to help learn and improve in their golf skills. This year, the clinic registration closed at 20 participants and was held at Fox Run Golf Links. ■

The Police Department is extending an invitation to participate in "Remember. Recover. Discover." a community awareness event hosted in collaboration with Elk Grove Village Cares and the Kenneth Young Center.

This free event aims to diminish stigma, enhance understanding, and offer support for recovery related to substance misuse, mental health challenges, trauma, and addictive behaviors.

The event will take place on Saturday, September 28 from 12 p.m. to 4 p.m. at the Kenneth Young Center (1001 Rohlwing Road).

Grant Opportunities Pursued by the Village

The Village of Elk Grove actively pursues grant opportunities, both public and private, to advance the goals of our community and reduce the burden on taxpayers.

Clearmont Pedestrian Bridge Replacement

This summer, the Village celebrated the opening of Clearmont Pedestrian Bridge following the replacement of the existing bridge over Salt Creek with a new structure.

The new bridge is 400-feet long and 14-feet wide and is now open to the public, welcoming pedestrians and cyclists alike to utilized the shared-use structure. The bridge also includes upgrades such as LED

lighting, aesthetic improvements, and the installation of overlooks to view wildlife.

Tonne Road Reconstruction

This construction season, you may have noticed the water main being replaced along Tonne Road between Landmeier Road and Devon Avenue. The water main replacement is the first part of a major reconstruction project for Tonne Road that is anticipated to begin in 2025.

The Tonne Road Improvement project will involve reconstruction of Tonne Road, intersection improvements including a new "Michigan style" U-turns at Elk Grove Boulevard/Touhy Avenue, and bicycle and pedestrian improvements.

While the Village is continuing to pursue additional funding opportunities, at this time the Village has received over \$6 million in funding through the following grants obtained for the Tonne Road Reconstruction project:

- U.S. Department of Transportation (DOT) Surface Transportation Program: \$3,500,000
- Illinois Department of Transportation (IDOT) Highway Safety Improvement Program: \$1,853,184
- U.S. Department of Transportation (DOT) Highway Improvement Program: \$500,000
- Cook County Invest In Cook Grant Program: \$250,000

Elk Grove Village Cares

Last year in June, the Village recognized the 5-year anniversary of the Elk Grove Village Cares program and announced a significant expansion to the program: connections to the road to recovery from addition to opioids, narcotics, and alcohol were made available to adolescents aged 12-17.

This expansion also included making a Narcan vending machine with the overdose-reversing medication available to the public at no cost, located in the Police Department lobby.

Mid-Summer Classics Concert Series

The Village also offers a sincere thank you to State Senator Laura Murphy, who secured \$250,000 in funding from the Illinois Department of Commerce and Economic Opportunity (DCEO) for the Mid-Summer Classics Concert Series to promote tourism.

The Village's efforts have been greatly supported by Federal, State, and Local elected representatives as they have helped secure over \$8 million in funding to address and support local needs including service delivery and infrastructure projects over the past few years. We express deep gratitude to the supporting agencies and representatives for their assistance.

Career and Workforce Development for Students at the Village

Providing students with opportunities to explore their career interests, gain experience, and develop professional skills is critical to ensure a strong and successful future workforce and make career development more accessible for young people.

To promote career and workforce development, the Village has partnered with High School District 214 in their Career Pathways Program, an initiative designed to help students explore and identify their career interests early in their academic journey. The Career Pathways Program is structured around 16 career "clusters" and focuses on practical, real-world experience. As a partner, the Village offers internships to District 214 students interested in government, engineering, information technology, and more.







Summer internships for undergraduate university students are also available in nearly every department in the Village, further expanding opportunities for students to gain real-world experience in their chosen career field. Summer interns are also given the opportunity to tour other departments and learn more about Village operations. This summer, the Village hosted a total of 13 high school and university student interns in different departments.

Recognizing the importance of supporting workforce development, the Village of Elk Grove has supported Elk Grove High School's Culinary Manufacturing Lab by providing a \$750,000 grant to fund a major expansion of the program. The grant will fund the complete modernization of the school's Culinary Manufacturing Lab and make the program accessible to more students. The Village has also supported job training and workforce development through the school's Career and Technical Education Program, providing a \$500,000 grant over five years to fund renovations to the school's advanced manufacturing lab. ■



Fall Large Branch Collection is September 16

The Public Works Department has a Large Branch Collection Program to assist residents in disposing large branches from summer storms and cleanup. This year, Large Branch Collection will begin on Monday, September 16. Public Works will make one pass through the community and will collect branches from pre-registered addresses.

Large Branch Collection Program Rules:

- Large branches 3.5 to 8 inches in diameter from all trees and bushes, except evergreens, are eligible for pick-up.
- Residents MUST call Public Works at (847) 734-8800 to add your address to the pickup route.
 - Public Works is open to accept phone calls Monday through Friday, between 8:00 a.m. and 4:30 p.m.
 - Calls must be received no later than Friday, September 13 at 4:30 p.m.
- Branches must be stacked in the parkway with cut ends pointing towards the curb.
- Branches should NOT be bundled with twine.
- Branches should be placed in the parkway no sooner than Saturday, September 14.

The following items are NOT part of the collection program: logs, lumber, paneling, bushes, stumps, and evergreens as these items damage Village equipment. Please contact Groot at (847) 734-6400 for pickup guidelines regarding these items.

A friendly reminder that the Groot Yard Waste Program includes the removal of bagged yard waste April 1 through December 15.

- Branches must be bundled with biodegradable twine or string.
- Branches up to 3.5 inches in diameter and no more than 4 feet long or over 50 pounds will be collected by Groot free of charge. Please note that using yard waste bags require the purchase of a yard waste sticker. ■

Denim Recycling Event



The event will take place from 9 a.m. to noon at Elk Grove High School (500 W Elk Grove Boulevard).

Any non-denim clothing will not be accepted at this event. ■







Solicitation Safety and Awareness

Always use caution when you have an unexpected visitor at your door! Do not allow anyone in your home or remain on your property unless you know them personally or have a scheduled appointment.

When approached by a solicitor, never leave your front door unlocked or unattended. Remember to always ask for ID; authorized solicitors will have a Village-issued ID badge. If someone cannot provide proof of solicitor identification from the Village, report it by calling 9-1-1.

Elk Grove Village Named 2023 Tree City USA

Elk Grove Village has been named a 2023 Tree City USA community by the Arbor Day Foundation. The Tree City USA program recognizes excellence in urban forestry management and environmental improvement. A city only achieves this designation if they have a tree board or department, establish a community tree ordinance, spend at least \$2 per capita on urban forestry, and celebrate Arbor Day.

The Village has continually gone above and beyond by not only meeting these criteria, but by offering tree evaluations, planting additional trees, and providing outstanding tree care. Since 2017, Elk Grove Village has planted approximately 3,427 trees throughout the community and over the next three

years the Village is planning on planting an additional 1,250 trees.



This is the 39th consecutive year that Elk Grove Village has received the Tree City USA designation. Over the years, the Village has continually demonstrated an exceptional commitment to maintaining a robust urban forest, which has contributed to environmental health as well as the aesthetic pride of the community.





Inspiring Community Investment at Eagles Apartments

In Elk Grove Village, Eagles Apartments recently embarked on a notable journey of revitalization, investing \$1.5 million to upgrade their property over the past 18 months. The new property management company at Eagles Apartment brought a fresh perspective and strong appreciation of the Village's proactive approach to beautification. Contractor Business Licensing: A Guide for Residents

Whether you are planning a home renovation, repair, or improvement project, understanding contractor registration requirements and licensing will help the efficiency of permit issuance.

Most contractors must obtain a valid contractor's business license through the Village. Contractors need to apply for a contractor's business license on the Village's website at elkgrove.org/businesslicense and pay the appropriate fee prior to permit issuance.

Roofers and plumbers are licensed by the State of Illinois and do not require a license from the Village.



Before hiring a plumbing or roofing contractor for these specialized services, it's advisable to verify their state licensure status. Roofing licenses can be verified through the State of Illinois Department of Financial and Professional Regulation, and plumbing contractors' licenses can be verified through the Illinois Department of Public Health.

Fire Sprinkler Save Story

In May, the Fire Department responded to an Activated Fire Alarm at a local business in Fire District 9. Upon arrival, there were no visible signs of fire observed.

Inside, crews found a faint burning smell and heavy smoke in the warehouse. A small fire in an air compressor had activated a sprinkler head, limiting damage to the property.

Early detection of this incident prevented total property loss. Deemed accidental, this incident highlights the importance of sprinkler systems installed in commercial buildings as well as in residences in safeguarding lives and property.

Fire Sprinkler Facts:

- Fire sprinklers are a proven and cost-effective means of protecting lives and property, offering the highest degree of protection from the threat of fire.
- Fire sprinklers can control a fire while it is still a manageable size, saving the lives of occupants and first responders.
- The average response times by crews is 5-12 minutes, depending on the location of the incident in relation to the station. Fire sprinklers help fight the fire while firefighters are on their way.


Topping Off Ceremony: Prime Data Centers

Originally named after the Italian family that started it, Mugaveros Pizza, owner Ernie Cairo found that people were already nicknaming the business "Mugs Pizza" and decided to shorten the name permanently when he and his brother took over the business.
